To win a decathlon requires the extreme best from the participant. It is a very grueling and demanding set of events. The decathlete is usually very good and in fact the best in one or two events and in good standing in the other eight or nine events. The objective is to be the overall best in all ten events. Decathletes like most athletes must complete in head to head events to know if they are able to win the overall decathlon. They must study their competitors in the greatest detail and know their strengths and weakness. They must learn from the other decathletes what allows them to put out that extra 5% that means the difference between winning and just participating. They must also compete in an environment where the performance standard required to win is always becoming higher.

Being a project manager is similar to the decathlete and in the business of projects, the field is very competitive. Similar to a decathlon there are events (nine knowledge areas) in the Project Management Body of Knowledge. The decathletes in project management are the companies that are controlling costs, schedule and quality on a project level. The project-driven companies must find ways to learn "best practices" in a competitive world and apply these lessons to their processes, systems, and tools. This method of continuous improvement through measuring and comparing is referred to as *benchmarking* as described by Dr. Kerzner.

Nortel aspires to win the decathlon prize, but realizes it is not possible without both internal and external benchmarking measurements and continuous improvements. The internal benchmarking is similar to intramural decathlons where learning comes from watching the friendly decathletes. A significant opportunity for learning and continuous improvement occurs when the "best in class" have entered the decathlon.

Nortel has particapted in the Kerzner five-step Project Management Maturity Model survey for the last year and a half. The five steps measure the desired direction of Nortel in reaching the point of external benchmarking and continuous improvement. Over 400 Nortel Project Managers globally have participated in step one. Step one determines if a common language is being used. Nortel is using this initial assessment as a baseline for improvements. In the fall of 2000 Nortel will confirm the improvements in step one and move to measure step 2, "common process," and step 3 "common methodology."

Dr. Kerzner has provided the measuring devices for the project management decathlon in the Maturity Model. By placing the sense of urgency around the improvement programs and remeasuring against the initial baseline, Nortel has a tangible measure of improvement and is encouraged to go on and participate in the external benchmarking order to become the best in Project Management.

Dr. Kerzner's Project Management Maturity Model is on the internal web in Nortel and the results are automatically calculated to provide the participant with an immediate score. The aggregate scores of each business unit are published monthly as a visible proof that Nortel is focused on the ideals of the five-step model (common language, process, methodology, benchmarking and continuous improvement). The model leads to a strong foundation for a world-class, projectdriven company to mature and evolve.

If has often been said "that to improve, one must be prepared to measure the improvement" and "one must inspect what one expects." The Kerzner Project Management Maturity Model has provided this tangible measure of maturity. The rest is up to the company to set the expectations and to inspect the results.

# Preface\_

Excellence in project management cannot occur, at least not within a reasonable time frame, without some form of strategic planning for project management. Although the principles of strategic planning have been known for several decades, an understanding of their applicability to project management is relatively new. Today, as more companies recognize the benefits that project management can provide to their "bottom line," the need for strategic planning for project management has been identified as a high priority.

This book is broken down into two major parts. The first part, Chapters 1 to 3, discusses the principles of strategic planning and how it relates to project management. The second part, Chapters 4 to 10, details the project management maturity model (PMMM), which will provide organizations with general guidance on how to perform strategic planning for project management. The various levels, or stages of development, for achieving project management maturity, and the accompanying assessment instruments, can be used to validate how far along the maturity curve the organization has progressed. The PMMM has been industry validated. One large company requires that, each month, managers and executives take the assessment instrument exams and then verify that progress toward maturity is taking place from reporting period to reporting period.

# INTRODUCTION

For more than 40 years, American companies have been using the principles of project management to get work accomplished. Yet, for more than 30 of these years, very few attempts were made to recognize project management as a core competency for the company. There were three reasons for this resistance to project management. First, project management was viewed as simply a scheduling tool for the workers. Second, since this scheduling tool was thought to belong at the worker level, executives saw no reason to look more closely at project management, and thus failed to recognize the true benefits it could bring. Third, executives were fearful that project management, if viewed as a core competency, would require them to decentralize authority, to delegate decision-making to the project managers, and thus to diminish the executives' power and authority base.

# **MISCONCEPTIONS**

As the 1990s approached, project management began to mature in virtually all types of organizations, including those firms that were project-driven, those that were non-project-driven, and hybrids. Knowledge concerning the benefits project management offered now permeated all levels of management. Project management came to be recognized as a process that would increase shareholder value.

This new knowledge on the benefits of project management allowed us to

dispel the illusions and misconceptions that we had believed in for over 30 years. These misconceptions or past views are detailed below, together with current views.

#### Cost of Project Management

- Misconception: Project management will require more people and increase our overhead costs.
- Present view: Project management allows us to lower our cost of operations by accomplishing more work in less time and with fewer resources without any sacrifice in quality.

#### Profitability

- Misconception: Profitability may decrease.
- Present view: Profitability will increase.

#### Scope Changes

- Misconception: Project management will increase the number of scope changes on projects, perhaps due to the project manager's desire for creativity.
- Present view: Project management provides us with better control of scope changes. Good project managers try to avoid scope changes.

#### Organizational Performance

- Misconception: Because of multiple-boss reporting, project management will create organizational instability and increase the potential for conflicts.
- Present view: Project management makes the organization more efficient and effective through better organizational behavior principles.

#### Customer Contact

- Misconception: Project management is really "eyewash" for the customer's benefit.
- Present view: Project management allows us to develop a closer working relationship with our customers.

#### Problems

- Misconception: Project management will end up creating more problems than usual.
- Present view: Project management provides us with a structured process for effectively solving problems.

#### Applicability

• Misconception: Project management is applicable only to large, long-term projects such as in aerospace, defense, and construction.

• Present view: Virtually all projects in all industries can benefit from the principles of project management.

# Quality

- Misconception: Project management will increase the potential for quality problems.
- Present view: Project management will increase the quality of our products and services.

# Power/Authority

- Misconception: Multiple-boss reporting will increase power and authority problems.
- Present view: Project management will reduce the majority of the power/authority problems.

# Focus

- Misconception: Project management focuses on suboptimization by looking at the project only.
- Present view: Project management allows us to make better decisions for the best interest of the company.

# End Result

- Misconception: Project management delivers products to a customer.
- Present view: Project management delivers solutions to a customer.

# Competitiveness

- Misconception: The cost of project management may make us noncompetitive.
- Present view: Project management will increase our business (and even enhance our reputation).

# WALL STREET BENEFITS




FIGURE 1–1. Impact on stock price as a result of better project management.

The benefits recognized by the present views of project management are now seen to be strategic initiatives designed to enhance shareholder value. Perhaps one of the best examples showing this is the effect on stock price illustrated in Figure 1-1. An executive who wishes to remain anonymous believes that the difference between the target selling price of his company's stock and the actual selling price can be attributed to the quality of the comapny's project management system and management's ability to execute projects within time, cost, and quality constraints and to the customer's satisfaction. If the actual selling price was below the target selling price, it might indicate that the company, especially if it were pro-

ject-driven, was having fundamental problems with project execution, which would affect competitiveness and profitability.

It may take years for a company just beginning to adopt project management to reap the benefits shown in Figure 1-1. Some of the organizations that believe they are achieving the benefits of Figure 1-1 are in these fields:

- Automotive subcontractors, some of whom are now treated as "partners" by their customers due to the quality of their project management systems.
- Financial institutions, especially those that are aggressively acquiring and assimilating other organizations and rapidly integrating both cultures into one without any appreciable negative effect on earnings.
- High technology companies who have beaten their competitors to the marketplace with new products.

Not all companies have the ability to reap the benefits of project management. Some do not yet recognize the benefits of or need for strategic planning for project management. Others recognize its importance but simply lack expertise in how to do it. In either event, strategic planning for project management is a necessity.

# STAKEHOLDERS

Given the fact that project management is no longer seen as just a quantitative tool for the employees, but is recognized as a source of benefits to the whole corporation, project management must satisfy the needs of its stakeholders. Stakeholders are individuals or groups that either directly or indirectly are affected by the performance of the organization. These individuals are not only affected by the organization's performance, but may even have a claim on its performance. As an example, unions can have a strong influence on how a project management methodology is executed. The general public and government agencies may be affected through health, safety, and ethical issues in the way projects are executed.

Although there are several ways to classify stakeholders, the most common method is as follows:

#### Financial Stakeholders

- Stockholders
- Financial institutions (suppliers of capital)
- Creditors

#### The Product/Market Stakeholders

- Primary customers
- Primary suppliers
- Competitors
- Unions
- Government agencies
- Local government committees

#### Organizational Stakeholders

- Executive officers
- Board of Directors
- Employees in general
- Managers

Any strategic planning efforts must focus on the best interests of all of an organization's stakeholders, not merely a few.

# GAP ANALYSIS .

There are two primary reasons for wanting to perform strategic planning for project management. First and foremost is the desire to secure a competitive advantage. The second reason is to minimize the competition's competitive advantage or to strengthen your own competitive advantage.




FIGURE 1–2. Gap analysis.

The key to reducing any disadvantage that may exist between you and your competitors is the process known as gap analysis. Figure 1–2 illustrates the basic concept behind gap analysis. You can compare your firm either to the industry average or to another company. Both comparisons are shown in Figure 1–2.

Just for an example, using Figure 1–2, we can compare the gaps in total sales. According to Figure 1–2, the gap between your firm and your major competitor

is significant and appears to be increasing. The gap between your organization and the industry average is also increasing, but not as greatly as the gap between you and your major competitor.

For a company aspiring to perform strategic planning for project management, there are three critical gaps to analyze:

- Speed to market
- Competitiveness on cost
- Competitiveness on quality




FIGURE 1–3. Gap analysis (time).

Figure 1–3 shows the gap on speed to market or new product development times. If the gap is large between you and either the industry average or your major competitor, then to win the battle you must develop a project management methodology that allows for the overlapping of life cycle phases combined with appreciable risk-taking. The larger the gap, the greater the risks to be taken. If the gap cannot be closed, then your organization must decide if its future should rest on the shoulders of a "first-to-market" approach or if a less critical "me-too" product approach is best. Another unfavorable result would be the firm's inability to compete on full product lines. The latter could impact the firm's revenue stream.

Another critical aspect of the schedule gap analysis shown in Figure 1–3 is customer's future expectations. Consider, for example, the auto manufacturers and their tier one suppliers. Today, these organizations operate on a three-year life cycle from concept to first production run. If you were a tier one supplier, however, and you found out that your primary customers were experimenting with a 24-month car, then you would need to perform strategic planning, not only to be competitive but also to be able to react quickly should your customers mandate schedule compression.




FIGURE 1–4. Gap analysis (cost).

A gap on cost is an even more serious situation. Figure 1–4 illustrates the cost or pricing gap. Strategic planning for project management can include for provisions in the methodology for better estimating techniques, the creation of lessons learned files on previous costing, and possibly the purchasing of historical databases for cost estimating.

Good project management methodologies allow work to be accomplished in less time, at lower cost, with fewer resources, and without any sacrifice in quality. But if a cost/pricing gap still persists despite good project management, then the organization may either have to be more selective about which projects it accepts or choose to compete on quality rather than on cost. The latter assumes that your customers would be willing to pay a higher price for added quality or added value features.





FIGURE 1–5. Gap analysis (quality).

Gaps on time and cost may not necessarily limit the markets in which you compete. However, gaps on quality, as shown in Figure 1–5, can severely hinder

your firm's ability to compete. The critical gap in Figure 1–5 is the difference between the customer's expectations of quality and what you can deliver. Good project management methodologies can include policies, procedures, and guidelines for improving quality. However, the gap on quality takes a lot longer to compress than the gaps on time and cost.

### CONCLUDING REMARKS \_

Strategic planning for project management, combined with a good project management methodology, can compress the gaps on time, cost, and quality. However, there are still critical decisions that must be made. Marketing must decide what products to offer and which markets to serve. The information systems people must assist in the design, development, and/or selection of support systems. And senior management must provide sufficient and qualified resources.

Strategic planning for excellence in project management needs to consider all aspects of the company: from the working relationships among employees and managers and between staff and management, to the roles of the various players (especially the role of executive project sponsors), to the company's corporate structure and culture. Other aspects of project management must also be planned. Strategic planning is vital for every company's health. Effective strategic planning can mean the difference between long-term success and failure. Even career planning for individual project managers ultimately plays a part in a company's excellence, or its mediocrity, in project management. All of these subjects are discussed in the following chapters.

# INTRODUCTION

Economic conditions can be favorable or unfavorable. Yet in either case, an astute company can convert someone else's misfortune into its own good fortune. Every place we look we find windows of opportunity. But to take full and prompt advantage of these windows of opportunity, to be truly successful, management must have a repeatable process predicated upon speed and quality of execution. The problem with most companies is that setting strategic targets can occur quickly, but developing implementation plans and executing them are much slower processes. Why did it take us so long to truly recognize the benefits of project management?

# HISTORICAL BASIS

During favorable economic times, changes in management style and corporate culture occur very slowly. Executives are reluctant to "rock the boat." But favorable economic conditions don't last forever. The period between recognizing the need for change and garnering the ability to manage change is usually measured in years. As economic conditions deteriorate, change occurs more and more quickly in business organizations, but still not fast enough to keep up with the economy. To make matters worse, windows of opportunity are missed because no project management methodology is in place.

Before the recession of 1989–1993, U.S. companies were willing to accept the implementation of project management at a tedious pace. The implementation, if it happened at all, simply consisted of using or adopting new planning and scheduling tools for the benefit of the employee, not the company. Corporate managers in general believed that their guidance was sufficient to keep their companies healthy, and outside consultants were brought in primarily to train production workers in the principles of project management. Executive training sessions, even very short ones, were rarely offered.

During the recession, senior managers came to realize that their knowledge of project management was not as comprehensive as they had once believed. Table 2–1 shows how the recession affected the development of project management systems.




FIGURE 2–1. Basic strategic planning.

By the end of the recession, in 1993, many companies had finally recognized the importance of both strategic planning and project management, as well as the relationship between them. The relationship between project management and strategic planning can best be seen from Figure 2–1. Historically, a great deal of emphasis had been placed on strategic formulation with little emphasis on strategic implementation. Now companies were recognizing that the principles of project management could be used for the implementation of strategic plans, as well as operational plans. Now, project management had the attention of senior management.





FIGURE 2-2. Hierarchy of strategic plans. Source: Unknown.

Another factor promoting project management was the acceptances of strategic business units (SBUs). There was usually less resistance to the use of project management in the SBU than in the parent company, along with greater recognition for the need to obtain horizontal as well as vertical work flow. This is shown in Figure 2–2. Project management was now recognized as a vehicle for the implementation of just about any type of plan for any type of project. Organizational charts showed project teams working horizontally across the corporation rather than vertically.

To address the far-reaching changes in the economic environment, senior managers began to ask a fundamental question: How do we plan for excellence in

project management? In answering this question, it would be futile to expect managers to implement immediately all of the changes needed to set up modern project management in their companies. What senior managers needed was a plan expressed in terms of three broad, critical success factors: qualitative factors, organizational factors, and quantitative factors. To take advantage of the economic outlook, whatever it happened to be at a given time, senior managers needed a plan like the one shown in Table 2–2.



# **GENERAL STRATEGIC PLANNING**

*Strategic planning* is the process of formulating and implementing decisions about an organization's future direction. This has been shown in Figure 2–1. This process is vital to every organization's survival because it is the process by which the organization adapts to its ever-changing environment, and the process is applicable to all management levels and all types of organizations.

Let's look at the first step in strategic planning: the formulation process is the process of deciding where you want to go, what decisions must be made, and when they must be made in order to get there. It is the process of defining and understanding the business you are in and how to remain competitive within that business. The outcome of successful formulation results in the organization doing the right thing in the right way (i.e., it results in project management) by producing goods or services for which there is a demand or need in the external or internal environment. When this occurs, we say the organization has been effective as measured by market response, such as sales and market shares or internal customer acceptance. A good project management methodology can provide better customer satisfaction and a greater likelihood of repeat business. All organizations must be effective and responsive to their environments to survive in the long run.

The formulation process is performed at the top levels of the organization. Here, top management values provide the ultimate decision template for directing the course of the firm. Formulation:

- Scans the external environment and industry environment for changing conditions.
- Interprets the changing environment in terms of opportunities or threats.
- Analyzes the firm's resource base for asset strengths and weaknesses.
- Defines the mission of the business by matching environmental opportunities and threats with resource strengths and weaknesses.
- Sets goals for pursuing the mission based on top management values and sense of responsibility.

The second step in strategic planning, implementation, translates the formulated plan into policies and procedures for achieving the grand decision. Implementation involves all levels of management in moving the organization toward its mission. The process seeks to create a fit between the organization's formulated goal and its ongoing activities. Because implentation involves all levels of the organization, it results in the integration of all aspects of the firm's functioning. Integration management is a vital core competency of project management. Middle- and lower-level managers spend most of their time on implementation activities. Effective implementation results in stated objectives, action plans, timetables, policies and procedures, and results in the organization moving efficiently toward fulfillment of its mission.

#### WHAT IS STRATEGIC PLANNING FOR PROJECT MANAGEMENT?

Strategic planning for project management is the *development of a standard methodology for project management*, a methodology that can be used over and over again, and that will produce a high likelihood of achieving the project's objectives. Although strategic planning for the methodology and execution of the methodology does not guarantee profits or success, it does improve the chances of success.

One primary advantage of developing an implementation methodology is that it provides the organization with a consistency of action. As the number of interrelated functional units in organizations has increased, so have the benefits from the integrating direction afforded by the project management implementation process.




FIGURE 3–1. Methodology structuring.

Methodologies need not be complex. Figure 3–1 shows the "skeleton" for the development of a simple project management methodology. The methodology begins with a project definition process, which is broken down into a technical baseline, a functional or management baseline, and a financial baseline. The technical baseline includes, at a minimum:

- Statement of work (SOW)
- Specifications

- Work breakdown structure (WBS)
- Timing (i.e., schedules)
- Spending curve (S curve)

The functional or management baseline indicates how you will manage the technical baseline. This includes:

- Resumés of the key players
- Project policies and procedures
- The organization for the project
- Responsibility assignment matrices (RAMs)

The financial baseline identifies how costs will be collected and analyzed, how variances will be explained, and how reports will be prepared. Altogether, this is a simple process that can be applied to each and every project.

Without this repetitive process, subunits tend to drift off in their own direction without regard to their role as a subsystem in a larger system of goals and objectives. The objective-setting and the integration of the implementation process using the methodology assure that all of the parts of an organization are moving toward the same common objective. The methodology gives direction to diverse activities, as well as providing a common process for managing multinational projects.

Another advantage of strategic project planning is that it provides a vehicle for the communication of overall goals to all levels of management in the organization. It affords the potential of a vertical feedback loop from top to bottom, bottom to top, and functional unit to functional unit. The process of communication and its resultant understanding helps reduce resistance to change. It is extremely difficult to achieve commitment to change when employees do not understand its purpose. The strategic project planning process gives all levels an opportunity to participate, thus reducing the fear of the unknown and possibly eliminating resistance.




FIGURE 3-2. Project selection process.

The final and perhaps the most important advantage is the thinking process required. Planning is a rational, logically ordered function. This is what a structured methodology provides. Many managers caught up in the day-to-day action of operations will appreciate the order afforded by a logical thinking process. Methodologies can be based upon sound, logical decisions. Figure 3–2 shows the logical decision-making process that could be part of the project selection process for an organization. Checklists can be developed for each section of Figure 3–2 to simplify the process.

The first box in Figure 3–2 is the project definition process. At this point, the project definition process simply involves a clear understanding of the objectives, which should be defined in both business and technical terms.

The second box is an analysis of the environmental situation. This includes a market feasibility analysis to determine:

- The potential size of the market for the product
- The potential risks on product liability
- The capital requirements for the product
- The market position on price
- The expected competitive response
- The regulatory climate, if applicable
- The degree of social acceptance
- Human factors (e.g., unionization)

The third box in Figure 3–2 is an analysis of the competitive situation and includes:

- The overall competitive advantage of the product
- Opportunities for technical superiority:
  - Product performance
  - Patent protection
  - Exceptional price-quality-value relationship
- Business attractiveness:
  - Type and nature of competitors
  - Structure of the competition/industry
  - Differences among competitors (price, quality, etc.)
  - Threat of substitute products
- Competitive positioning:
  - Market share
  - Rate of change in market share
  - Perceived differentiation among competitors and across various market segments
  - Positioning of the product within the product line
- Opportunities for market positioning:
  - Franchises
  - Reputation/image
  - Superior service
- Supply chain management:
  - Ownership of raw material sources
  - Vertical integration
- Physical plant opportunities:
  - Locations
  - Superior logistics support
- Financial capabilities:
  - Available capital
  - Credit rating impact
  - Wall Street support
- Efficient operations management:
  - Inventory management
  - Production
  - Distribution
  - Logistics support

The next box in Figure 3-2 is resources and capabilities. Analysis of resources and capabilities, combined with the analysis of competitive positioning just discussed, allows us to determine our strengths and weaknesses. Identifying opportunities and threats lets us identify what we *want* to do. However, it is knowing our strengths and weaknesses that lets us identify what we *can* do. Therefore,

the design of any type of project management methodology must be based heavily upon what the organization can do.

Internal strengths and weaknesses can be defined for each major functional area. The design of a project management methodology can exploit the strengths in each functional area and minimize its weaknesses. Not all functional areas will possess the same strengths and weaknesses.

The following illustrates typical strengths or weaknesses for various functional organizations:

- Research and development:
  - Ability to conduct basic/applied research
  - Ability to maintain state-of-the-art knowledge
  - Technical forecasting ability
  - Well-equipped laboratories
  - Proprietary technical knowledge
  - An innovative and creative environment
  - Offensive R&D capability
  - Defensive R&D capability
  - Ability to optimize cost with performance
- Manufacturing:
  - Efficiency factors
  - Raw material availability and cost
  - Vertical integration abilities
  - Quality assurance system
  - Relationship with unions
  - Learning curve applications
  - Subsystems integration
- Finance and accounting:
  - Cash flow (present and future projections)
  - Forward pricing rates
  - Working capital requirements
  - Human resource management:
    - Turnover rate of key personnel
    - Recruitment opportunities
    - Promotion opportunities
    - Having a project management career path
    - Quality of management at all levels
    - Public relations policies
    - Social consciousness
- Marketing:
  - Price-value analysis
  - Sales forecasting ability
  - Market share
  - Life cycle phases of each product
  - Brand loyalty

- Patent protection
- Turnover of key personnel

Having analyzed what we can do, we must now look at past performance to see if there are any applicable lessons learned files that could impact the current project or selection of projects. Analysis of past performance, as shown in Figure 3-2, is usually the best guide for the specifications of the present project.

The final box in Figure 3–2 is the decision on whether or not to undertake the project. This type of decision-making process is critical if we are to improve our chances of success. Historically, less than 10 percent of R&D projects ever make it through full commercialization where all costs are recovered. Part of that problem has been the lack of a structured approach for decision-making, project approval, and project execution. All this can be satisfied with a sound project management methodology.

In the absence of an explicit project management methodology, decisions are made incrementally. A response to the crisis of the moment may result in a choice that is unrelated to, and perhaps inconsistent with, the choice made in the previous moment of crisis. Discontinuous choices serve to keep the organization from moving forward. Contradictory choices are a disservice to the organization and may well be the cause of its demise. Such discontinuous and contradictory choices occur when decisions are made independently to achieve different objectives, even though everyone is supposedly working on the same project. When the implementation process is made explicit, however, objectives, missions, and policies become visible guidelines that produce logically consistent decisions.

Small companies usually have an easier time in performing strategic planning for project management excellence. Large companies with highly diversified product lines and multiple management styles find that institutionalizing changes in the way projects are managed can be very complex. Innovation and creativity in project management can be a daunting, but not impossible, task.




FIGURE 3–3. Integration opportunities between process strategies.




FIGURE 3-4. Qualitative process improvement opportunities.

Effective strategic planning for project management is a never-ending effort, requiring continuous support. The two most common continuous supporting strategies are the integration opportunities strategy, outlined in Figure 3–3, and the performance improvement strategy, shown in Figure 3–4.

Figure 3–3 outlines the opportunities that exist to integrate or combine an existing methodology with other types of management approaches that may be currently in use within the company. Such other methodologies available for integration include concurrent engineering, total quality management (TQM), scope change management, and risk management. Integrated strategies provide a synergistic effect. Typical synergies include:

#### Project Management Process

• Tighter cost control: This results from a uniform cost reporting system in which variance reporting can be tightened and lessons learned files are maintained and updated.

- Corporate resource models: Companies are now able to develop total company resource models and capacity planning models to determine how efficiently the existing resources are being utilized and how much new business can be undertaken.
- Efficiency/effectiveness: A good methodology allows for the capturing and comparison of metrics to show that the organization is performing

more work in less time and with fewer resources. Such data verifies the existence of economies of scale.

## Concurrent Engineering Process

- Parts scheduling: Improvement can be made in the way that parts are ordered and tracked. As an organization overlaps activities to compress the schedule, timely delivery of materials is crucial.
- Risk identification: Overlapping activities increase the risks on a project. Better risk management practices are essential.
- Resource constraint analysis: Overlapping activities during concurrent engineering require that sufficient resources be available. Models are available to define the resource constraints and recommend ways to deal with limited availability of resources.
- Supplier involvement: Overlapping activities not only increase your risks but can also increase the risks for your supplier. A good methodology allows for better customer interfacing.

## Total Quality Management (TQM)

- Lower cost of quality: Many of the basic principles of project management are also the basic principles of TQM. A good project management methodology will allow for the maximization of benefits for both.
- Customer involvement: A good methodology allows you to get closer to your customers. This could easily result in customer involvement in ways to improve quality for both products and services.
- Supplier involvement: A good methodology allows you to get closer to your supplier base. Suppliers will often come up with ideas to improve quality, thus solidifying your relationship with them. They also may have information from other companies they supply, possibly even your competitors, and may be willing to release this information.

#### Scope Change Management


- Impact analysis: A good methodology allows for checklists and forms for accurately determining the time, cost, and quality impact resulting from scope changes. It also puts in place a regimented process for scope change management.
- Customer management: Customers want to believe that all changes are no-cost changes (to the customer), and that the changes can be made at any time and in any life cycle phase. A good methodology that completely outlines the change management process allows for better customer management.
- Enhancement projects: A good project management methodology allows for a clear distinction as to whether the change should be made now or possibly later as an enhancement project. It addresses the question of how imperative the change actually is.

#### Risk Management

• WBS analysis: A good methodology provides guidelines on how deep into the WBS risk analysis should be performed.

- Technical risk analysis: Risk analysis is reasonably well defined for schedule and cost risks. Very little is known about technical risk management. A good methodology may provide templates on how to perform technical risk management.
- Customer involvement: Your firm's perception of risks, specifically which risks are worth taking and which are not, may be significantly different than your customer's perceptions. Customer involvement in risk analysis is essential.

The qualitative process improvement strategy shown in Figure 3–4 is designed to improve the efficiency of the existing methodology and to find new applications for it. The integrated process strategies of Figure 3–3 are one part of these process improvement strategies, as shown. Process improvement is discussed further in Chapter 9.

The goal of most organizations is to be more profitable than their competitors. Project management methodologies contribute to profitability through more efficient execution of the project and implementation of the methodology. This is another valid reason mandating continuous strategic planning.

A good project management methodology will be responsive to all environmental factors and will serve all of its stakeholders. Stakeholders are people who have a vested interest in the company's performance and who have claims on its performance. Figure 3–5 shows, as part of the immediate environment, six commonly used categories of stakeholder: suppliers, customers, employees, creditors, shareholders, and even competitors. Some organizations would also identify government officials and society at large as being among their multiple stakeholders. One part of strategic planning for project management may include prioritizing the order in which stakeholders will be satisfied if and when a problem exists. A good project management methodology may also include a "standard practices" section, which will discuss moral and ethical considerations involved in dealing with stakeholders.

# EXECUTIVE INVOLVEMENT .

Senior management's involvement in strategic planning is essential if the process is to move ahead quickly and if full employee commitment and acceptance is to be achieved. The need for involvement is essential:

- A visible general endorsement is mandatory.
- An executive champion (not sponsor) must be assigned.
- The executive champion must initiate the process.
- The executive champion must make sure that the ideas/aspirations of senior management are included throughout the methodology.
- The executive champion must verify the validity of the corporate assumptions, including:
  - Forward pricing rate data
  - Targeted customers/industries
  - Reporting requirement for senior management
  - Strategic trends
  - Customer interfacing requirements

If senior management's support is not visible right from the onset, then:

- The workers may believe that senior management is not committed to the process.
- Functional managers may hesitate to provide valuable support, believing that the process is unreal.
- The entire process may lack realism and waste time.

Another critical function of senior management is determining "strategic timing." A strategic plan is a timed sequence of conditional moves that involve the deployment of resources. The executive champion must either develop or approve the strategic timing activities, which include:

- Establishing the timetable for major moves
- Establishing resource requirements and assuring availability
- Providing funding release time for critical assets and hardware/software purchases to support the project management systems

# THE GENERAL ENVIRONMENT .

The first step in any strategic planning process is an understanding of the general environment in which the strategy must be target and executed (refer again to Figure 3–5). Historically, the general environment includes:

- The demographic segment
- The economic segment
- The political/legal segment
- The sociocultural segment
- The technological segment

In general strategic planning, these segments are heavily oriented toward the external environment. For project management, the focus is more internal than external.

## The Demographic Segment

For general strategic planning, we focus on such factors as population size, age structure, geographic structure, ethnic mix, and income distribution. For project management, the focus is more internal. The factors we look at will include:

- Corporate size: How many functional units will use the methodology? Will there be pockets of use or corporate-wide acceptance?
- Age structure: What will be the average age of the users of the methodology? Age structure can affect both risk-taking and willingness/ability to work overtime.
- Geographic dispersion: If the firm is multinational, how do we get everyone to support the methodology? Will there exist language/communication complexities?
- Types of projects: Will the methodology be general enough for all types of projects, or will we need multiple methodologies?

# The Economic Segment

For general strategic planning, the economic environment is the external economic environment and how it affects the operations of the firm. Included in this segment would be inflation rates, interest rates, trade budget/surpluses, personal saving rates, business saving ratesr and gross domestic product. For project management strategies, the economic environment will include:

- Cost of capital: How much will it cost us to borrow money for new product development or on an interim basis to account for cash flow deficits?
- Forward pricing rates: Based upon current knowledge, what will our costs look like over the next several years?
- Quality of cost estimates: How accurate are our cost estimates, and are there lessons learned?

## The Political/Legal Segment

For general strategic planning, the political/legal segment includes laws on antitrust, taxation, and labor training, and philosophies on deregulation and education. For project management strategic planning, the list could include the above items for multinational efforts, but generally includes:

- Customer-interfacing: This includes the development of a standard practice manual on morality and ethics in dealing with customers. It could also include a corporate "credo" that specifies that the best interests of the customer come first.
- Product liability/truth of disclosure: Do we have supporting data for information presented to the customers or consumers?
- Changing laws: Does our methodology allow for changes if new laws are enacted?

## The Sociocultural Segment

The sociocultural segment generally includes topics such as women/minorities in the workforce, quality of work life, environmental concerns, and career preferences. For strategic planning for project management, the list would include:

- Customer requirements: Do our customers mandate the hiring of women/minorities on our projects? Do the customers require that our subcontracts go to union shop organizations only?
- Health/safety issues: Does our methodology specify that we do not expect the employees to violate health and safety regulations?
- Overtime: How much overtime are employees expected to perform? This includes both exempt and nonexempt employees.
- Career path: Is project management regarded as a career path position?

#### The Technological Segment

The technological segment is basically the same for general strategic planning and strategic planning for project management. Included in this segment we have:

- Offensive technology: Do we have the skill to develop new products and, if so, does the methodology account for technical risk taking in this regard?
- Defensive technology: How quickly and effectively can we defend our existing products through enhancements? Does our methodology allow for short cuts for enhancement projects?
- Purchasing of technology: Does our company allow us to purchase technology (hardware, software, etc.) to improve our management processes?
- Technology gap: Does a technology gap exist between us and our competitors? Does the methodology allow for risk-taking to close the gap?
- The freedom to innovate: Is the methodology rigidly structured or does it allow some degree of freedom for creativity?

## CRITICAL SUCCESS FACTORS FOR STRATEGIC PLANNING

Critical success factors for strategic planning for project management include those activities that must be performed if the organization is to achieve its longterm objectives. Most businesses have only a handful of critical success factors. However, if even one of them is not executed successfully, the business's competitive position may be threatened.

The critical success factors in achieving project management excellence apply equally to all types of organizations, even those that have not fully implemented their project management systems. Though most organizations are sincere in their efforts to fully implement their systems, stumbling blocks are inevitable and must be overcome. Here's a list of common complaints from project teams:

- There's scope creep in every project and no way to avoid it.
- Completion dates are set before project scope and requirements have been agreed upon.
- Detailed project plans identifying all of the project's activities, tasks, and subtasks are not available.
- Projects emphasize deadlines. We should emphasize milestones and quality and not time.
- Senior managers don't always allow us to use pure project management techniques. Too many of them are still date driven instead of requirements driven. Original target dates should be used only for broad planning.
- Project management techniques from the 1960s are still being used on most projects. We need to learn how to manage from a plan and how to use shared resources.

- Sometimes we are pressured to cut estimates low to win a contract, but then we have to worry about how we'll accomplish the project's objectives.
- There are times when line personnel not involved in a project change the project budget to maintain their own chargeability. Management does the same.
- Hidden agendas come into play. Instead of concentrating on the project, some people are out to set precedents or score political points.
- We can't run a laboratory without equipment, and equipment maintenance is a problem because there's no funding to pay for the materials and labor.
- Budgets and schedules are not coordinated. Sometimes we have spent money according to the schedule but are left with only a small percentage of the project activities complete.
- Juggling schedules on multiple projects is sometimes almost impossible.
- Sometimes we filter information from reports to management because we fear sending them negative messages.
- There's a lot of caving in on budgets and schedules. Trying to be a good guy all the time is a trap.

With these comments in mind, let's look at the three critical success factors in achieving project management excellence: qualitative, organizational, and quantitative factors.

# QUALITATIVE FACTORS

If excellence in project management means a continuous stream of successfully completed projects, then our first step should be to define *success*. As discussed in Chapter 1, success in projects has traditionally been defined as achieving the project's objectives within the following constraints:

- Allocated time
- Budget cost
- Desired performance at technical or specification level
- Quality standards as defined by customers or users

In experienced organizations, the four preceding parameters have been extended to include the following:

- With minimal or mutually agreed upon scope changes
- Without disturbing the organization's corporate culture or values
- Without disturbing the organization's usual work flow

These last three parameters deserve further comment.

Organizations that eventually achieve excellence are committed to quality and up-front planning so that minimal scope changes are required as the project progresses. Those scope changes that are needed must be approved jointly by both the customer and the contractor. A well-thought-out process for handling scope changes is in place in such organizations. Even in large profit-making, project-driven industries, such as aerospace, defense, and large construction, tremendous customer pressure can be expected to curtail any "profitable" scope changes introduced by the contractor.

Most organizations have well-established corporate cultures that have taken years to build. On the other hand, project managers may need to develop their own subcultures for their projects, particularly when the projects will require years to finish. Such temporary project cultures must be developed within the limitations of the larger corporate culture. The project manager should not expect senior officers of the company to allow the project manager free rein.

The same limitations affect organizational work flow. Most project managers working in organizations that are only partially project-driven realize that line managers in their organizations are committed to providing continuous support to the company's regular functional work. Satisfying the needs of time-limited projects may only be secondary. Project managers are expected to keep the welfare of their whole companies in mind when they make project decisions.

For companies to reach excellence in project management, executives must learn to define project success in terms of both what is good for the project and what is good for the organization.

Executives can support project managers by reminding them of this two-part responsibility by:

- Encouraging project managers to take on nonproject responsibilities, such as administrative activities
- Providing project managers with information on the company's operations and not just information pertaining to their assigned projects
- Supporting meaningful dialogue among project managers
- Asking whether decisions made by project managers are in the best interest of the company as a whole

### **ORGANIZATIONAL FACTORS** .

Coordination of organizational behavior in project management is a delicate balancing act, something like sitting on a bar stool. Bar stools usually come with three legs to keep them standing. So does project management: one is the project manager, one is the line manager, and one is the project sponsor. If one of the legs is lost or unusable, the stool will be very difficult to balance.

Although line managers are the key to successful project management, they will have a lot of trouble performing their functions without effective interplay with the project's manager and corporate sponsor. In unsuccessful projects, the project manager has often been vested with power (authority) over the line managers involved. In successful projects, project and line managers are more likely to have shared authority. The project manager will have negotiated the line managers' commitment to the project and worked through them, not around them. The project manager probably provided recommendations regarding employee performance. And leadership was centered around the whole project team, not just the project manager.

In successful project management systems, the following equation always holds true:

When project and line managers view each other as equals, they share equally in the management of the project, and thus they share equally the authority, responsibility, and accountability for the project's success. Obviously the sharing of authority makes shared decision-making easier. The project management methodology must account for shared accountability. A few suggestions for executive project sponsors follow:

- Do not increase the authority of the project manager at the expense of the line managers.
- Allow line managers to provide technical direction to their people, if at all possible.
- Encourage line managers to provide realistic time and resource estimates, and then work with the line managers to make sure they keep their promises.
- Above all, keep the line managers fully informed.

In organizations that have created effective project management systems, the role of the executive manager has changed along with project management. Early in the implementation of project management, executives were actively involved in the everyday project management process. But as project management has come into its own and as general economic conditions have changed, executive involvement has become more passive, and project sponsors now usually concentrate on long-term and strategic planning. They have learned to trust project managers to make the day-to-day decisions and they have come to view project management as a central factor in their company's success.

Project sponsors provide visible, ongoing support. Their role is to act as a bodyguard for the project and the project manager. Unlike other executives on the

senior management team, individual project sponsors may play a more active role in projects, depending on how far along the project is. Early in the project's functioning, for example, the project sponsor might help the project manager define the project's requirements. Once that is done, the sponsor resumes a less active role and receives project information only as needed.

In successful project management systems that carry a high volume of ongoing project work, an executive sponsor may not be assigned to low-dollar-value or low-priority projects. Middle managers may fill the sponsorship role in some cases. But no matter what the size or value of the project, project sponsors today are responsible for the welfare of all members of their project teams, not just that of the project manager.

The existence of a project sponsor implies visible, ongoing executive support for project management. And executive support motivates project personnel to excel. Executive project sponsorship also supports the development of an organizational culture that fosters confidence in the organization's project management systems.

*Conclusion:* Executive project sponsorship must exist and be visible so that the project–line manager interface is in balance.

Recommendations for obtaining maturity include:

- Educate the executives as to the benefits of project management.
- Convince the executives of the necessity for ongoing, visible support in the capacity of a project sponsor.
- Convince executives that they need not know all the details. Provide them with the least information that tells the most.

### QUANTITATIVE FACTORS

The third factor in achieving excellence in project management is the implementation and acceptance of project management tools to support the methodology. (See the discussion of project management tools in Chapter 4.) Some companies are quick to implement PERT/CPM tools, but many are reluctant to accept other mainframe or personal computer network software for project planning, project cost estimating, project cost control, resource scheduling, project tracking, project audits, or project management information systems.

Mainframe project management tools have been resurrected in the past few years. These new mainframe products are being used mainly for total company project control. However, executives have been slow to accept these sophisticated tools. The reasons for this are:

- Upper management may not like the reality of the output.
- Upper management uses their own techniques rather than the system for the planning, budgeting, and decision-making process.
- Day-to-day planners may not use the packages for their own projects.
- Upper management may not demonstrate support and commitment to training.
- Use of sophisticated mainframe packages requires strong internal communication lines for support .
- Clear, concise reports are lacking even though report generators exist.
- Mainframe packages do not always provide for immediate turnaround of information.
- The business entity may not have any project management standards in place prior to implementation.
- Implementation may highlight middle management's inexperience in project planning and organizational skills.
- Sufficient/extensive resources required (staff, equipment, etc.) may not be in place.
- Business environment and organizational structure may not be appropriate to meet project management/planning needs.
- Software utilization training without project management training is insufficient.
- Software may be used inappropriately as a substitute for the extensive interpersonal and negotiation skills required by project management.
- The business entity may not have predetermined the extent and appropriate use of the software within the organization.

*Conclusions:* Project management education must precede software education. Also, executives must provide the same encouragement and support for the use of the software as they do for project management.

The following recommendations can help accelerate the maturity process:

- Educating people in the use of sophisticated software and having them accept its use is easier if the organization is already committed to project management.
- Executives must provide standards and consistency for the information they wish to see in the output.
- Executive knowledge (overview) in project management principles is necessary to provide meaningful support.
- Not everyone needs to become an expert in the use of the system. One or two individuals can act as support resources for multiple projects.

## IDENTIFYING STRATEGIC RESOURCES

All businesses have corporate competencies and resources that distinguish them from their competitors. These competencies and resources are usually identified in terms of a company's strengths and weaknesses. Deciding upon what a company *should* do can only be achieved after assessing the strengths and weaknesses to determine what the company *can* do. Strengths support windows of opportunities, whereas weaknesses create limitations. What a company can do is based upon the quality of its resources.

Strengths and weaknesses can be identified at all levels of management. Senior management may have a clearer picture of the overall company's position in relation to the external environment, whereas middle management may have a better grasp of the internal strengths and weaknesses. Unfortunately, most managers do not think in terms of strengths and weaknesses and, as a result, they worry more about what they *should* do than about what they *can* do.


Although all organizations have strengths and weaknesses, no organization is equally strong in all areas. Procter & Gamble, Budweiser, Coke, and Pepsi are all known for their advertising and marketing. Computer firms are known for technical strengths, whereas General Electric has long been regarded as the training ground for manufacturing executives. Large firms have vast resources with strong technical competency, but they often react slowly when change is needed. Small firms can react quickly but have limited strengths. Any organization's strengths and weaknesses can change over time and must, therefore, be closely monitored.

Strengths and weaknesses are internal measurements of what a company can do and assessment of them must be based upon the quality of the company's resources. Consider the situation shown in Figure 3–6. Even a company with a world-class methodology in project management will not be able to close the performance gap in Figure 3–6 until the proper internal or subcontracted resources are available. Methodologies, no matter how good, are executed by use of resources. Project management methodologies do not guarantee success. They simply increase the chances for success provided that (1) the project objective is realistic and (2) the proper resources are available along with the skills needed to achieve the objective.

#### **Tangible Resources**

In basic project management courses, the strengths and weaknesses of a firm are usually described in the terms of its tangible resources. The most common classification for tangible resources is:

- Equipment
- Facilities
- Manpower
- Materials
- Money
- Information/technology




FIGURE 3-7. Project resources.

Another representation of resources is shown in Figure 3–7. Unfortunately, these crude types of classification do not readily lend themselves to an accurate determination of internal strengths and weaknesses for project management. A more useful classification would be human resources, nonhuman resources, organizational resources, and financial resources.

#### Human Resources

Human resources are the knowledge, skills, capabilities, and talent of the firm's employees. This includes the board of directors, managers at all levels, and employees as a whole. The board of directors provides the company with considerable experience, political astuteness, and connections, and possibly sources of borrowing power. The board of directors is primarily responsible for selecting the CEO and representing the best interest of the diverse stakeholders as a whole.

Top management is responsible for developing the strategic mission and making sure that the strategic mission satisfies the shareholders. All too often, CEOs have singular strengths in only one area of business, such as marketing, finance, technology, or production.

The biggest asset of senior management is its decision-making ability, especially during project planning. Unfortunately, all too often senior management will delegate planning (and the accompanying decision-making process) to staff personnel. This may result in no effective project planning process within the organization and may lead to continuous replanning efforts.

Another important role of senior management is to define clearly its own managerial values and the firm's social responsibility (see Figure 2–1). A change in senior management could result in an overnight change in the organization's managerial values and its definition of its social responsibility. This could require an immediate update of the firm's project management methodology.

Lower and middle management are responsible for developing and maintaining the "core" technical competencies of the firm. Every organization maintains a distinct collection of human resources. Middle management must develop some type of cohesive organization such that synergistic effects will follow. It is the synergistic effect that produces the core competencies that lead to sustained competitive advantages and a high probability of successful project execution.

#### Nonhuman Resources

Nonhuman resources are physical resources that distinguish one organization from another. Boeing and IBM both have sustained competitive advantages but have different physical resources. Physical resources include plant and equipment, distribution networks, proximity of supplies, availability of a raw material, land, and labor.

Companies with superior nonhuman resources may not have a sustained competitive advantage without also having superior human resources. Likewise, a company with strong human resources may not be able to take advantage of windows of opportunity unless it also has strong physical resources. An Ohiobased company had a 30-year history of sustained competitive advantage on R&D projects that were won through competitive bidding. As times changed however, senior management saw that the potential for megaprofits now lay in production. Unfortunately, in order to acquire the resources needed for physical production, the organization diluted some of its technical resources. The firm learned a hard lesson in that the management of human resources is not the same as the management of nonhuman resources. The firm also had to reformulate its project management methodology to account for manufacturing operations.

Firms that endeavor to develop superior manufacturing are faced with two critical issues. First, how reliable are the suppliers? Do the suppliers maintain quality standards? Are the suppliers cost effective? The second concern, and perhaps the more serious of the two, is the ability to cut costs quickly and efficiently to remain competitive. This usually leads to some form of vertical integration.

#### **Organizational Resources**

Organizational resources are the glue that holds all of the other resources together. Organizational resources include the organizational structure, the project office, the formal (and sometimes informal) reporting structure, the planning system, the scheduling system, the control system, and the supporting policies and procedures. Decentralization can create havoc in large firms where each strategic business unit (SBU), functional unit, and operating division can have its own policies, procedures, rules, and guidelines. Multiple project management methodologies can cause serious problems if resources are shared between SBUs.

#### Financial Resources

Financial resources are the firm's borrowing capability, credit lines, credit rating, ability to generate cash, and relationship with investment bankers. Companies with quality credit ratings can borrow money at a lower rate than companies with nonquality ratings. Companies must maintain a proper balance between equity and credit markets when raising funds. A firm with strong, continuous cash flow may be able to fund growth projects out of cash flow rather than through borrowing. This is the usual financial-growth strategy for a small firm.

#### Intangible Resources

Human, physical, organizational, and financial resources are regarded as tangible resources. There are also intangible resources that include the organizational culture, reputation, brand name, patents, trademarks, know-how, and relationships with customers and suppliers. Intangible resources do not have the visibility that tangible resources possess, but they can lead to a sustained competitive advantage. When companies develop a "brand name," it is nurtured through advertising and marketing and is often accompanied by a slogan. Project management methodologies can include paragraphs on how to protect the corporate image or brand name.


#### Social Responsibility

Social responsibility is also an intangible asset, although some consider it both intangible and tangible. Social responsibility is the expectation that the public perceives that a firm will make decisions that are in the best interest of the public as a whole. Social responsibility can include a broad range of topics from environmental protection to consumer safeguards to consumer honesty and employing the disadvantaged. An image of social responsibility can convert a potential disaster into an advantage. Johnson & Johnson, for example, earned high marks for social responsibility in the way it handled the two Tylenol tragedies in the 1980s. Nestlé, on the other hand, earned low marks for its role in the infant-formula controversy.

## WHY DOES STRATEGIC PLANNING FOR PROJECT MANAGEMENT SOMETIMES FAIL?

We have developed a strong case earlier for the benefits of strategic planning for project management. Knowledge about this process is growing, and new information is being disseminated rapidly. Why, then, does this process often fail? Following are some of the problems that can occur during the strategic planning process. Each of these pitfalls must be considered carefully if the process is to be effective.

- Lack of CEO endorsement: Any type of strategic planning process must originate with senior management. They must start the process and signal their own aspirations. A failure by senior management to endorse strategic planning may signal line management that the process is unreal.
- Failure to reexamine: Strategic planning for project management is not a one-shot process. It is a dynamic, continuous process of reexamination, feedback, and updating.
- Being blinded by success: Simply because a few projects are completed successfully does not mean that the methodology is correct, nor does it imply that improvements are not possible. A belief that "you can do no wrong" usually leads to failure.
- Overresponsiveness to information: Too many changes in too short a time frame may leave employees with the impression that the methodology is flawed or that its use may not be worth the effort. The issue to be decided here is whether changes should be made continuously or at structured time frames.
- Failure to educate: People cannot implement successfully and repetitively a methodology they do not understand. Training and education on the use of the methodology is essential.
- Failure of organizational acceptance: Company-wide acceptance of the methodology is essential. This may take time to achieve in large organi-





FIGURE 3–8. Differences in strategic importance.

zations. Strong, visible executive support may be essential for rapid acceptance.

- Failure to keep the methodology simple: Simple methodologies based upon guidelines are ideal. Unfortunately, as more and more improvements are made, there is a tendency to go from informality using guidelines to formality using policies and procedures.
- Blaming failures on the methodology: Project failures are not always the result of poor methodology; the problem may be poor implementation. Unrealistic objectives or poorly defined executive expectations are two common causes of poor implementation. Good methodologies do not guarantee success, but they do imply that the project will be managed correctly.

- Failure to prioritize: Serious differences can exist in the importance different functional areas, such as marketing and manufacturing, assign to strategic project objectives. Figure 3–8 shows three projects and how they are viewed differently by marketing and manufacturing. A common, across-company prioritization system may be necessary.
- Rapid acquisitions: Sometimes an organization will purchase another company as part of its long-term strategy for vertical integration. Backward integration occurs when a firm purchases suppliers of components or raw materials in order to reduce its dependency on outside sources. Forward integration occurs when an organization purchases the forward channels of distribution for its products. In either case, the company's projects will now require more work, and this must be accounted for in the methodology. Changes may occur quickly.

Only by watching out for these potential problems can a firm hope to avoid them (or at least to minimize their negative effects). This is the path to success in strategic planning for project management.



## INTRODUCTION

All companies desire to achieve maturity and excellence in project management. Unfortunately, not all companies recognize that the timeframe can be shortened by performing strategic planning for project management. The simple use of project management, even for an extended period of time, does *not* necessarily lead to excellence. Instead, it can result in repetitive mistakes and, what's worse, learning from your own mistakes rather than from the mistakes of others.

Companies such as Motorola, Nortel, Ericsson, and Compaq perform strategic planning for project management, and the results are self-explanatory. What Nortel and Ericsson have accomplished from 1992 to 1998, other companies have not achieved in 20 years of using project management.

Strategic planning for project management is unlike other forms of strategic planning in that it is most often performed at the middle-management, rather than executive-management. Executive level management is still involved, mostly in a supporting role, and provides funding together with employee release time for the effort. Executive involvement will be necessary to make sure that whatever is recommended by middle management will not result in unwanted changes to the corporate culture.

Organizations tend to perform strategic planning for new products and services by laying out a well-thought-out plan and then executing the plan with the precision of a surgeon. Unfortunately, strategic planning for project management, if performed at all, is done on a trial-by-fire basis. However, there are models that can be used to assist corporations in performing strategic planning for project management and achieving maturity and excellence in a reasonable period of time.

## THE FOUNDATION FOR EXCELLENCE




FIGURE 4-1. The five levels of project management maturity.

The foundation for achieving excellence in project management can best be described as the project management maturity model (PMMM), which is comprised of five levels, as shown in Figure 4–1. Each of the five levels represents a different degree of maturity in project management. Each level is discussed in detail in the remaining chapters. The levels are:

- Level 1—Common language: In this level, the organization recognizes the importance of project management and the need for a good understanding of the basic knowledge on project management and the accompanying language/terminology.
- Level 2—Common processes: In this level, the organization recognizes that common processes need to be defined and developed such that successes on one project can be repeated on other projects. Also included in this level is the recognition of the application and support of the project management principles to other methodologies employed by the company.

- Level 3—Singular methodology: In this level, the organization recognizes the synergistic effect of combining all corporate methodologies into a singular methodology, the center of which is project management. The synergistic effects also make process control easier with a single methodology than with multiple methodologies.
- Level 4—Benchmarking: This level contains the recognition that process improvement is necessary to maintain a competitive advantage. Benchmarking must be performed on a continuous basis. The company must decide whom to benchmark and what to benchmark.
- Level 5—Continuous improvement: In this level, the organization evaluates the information obtained through benchmarking and must then decide whether or not this information will enhance the singular methodology.

When we talk about levels of maturity (and even life cycle phases), there exists a common misbelief that all work must be accomplished sequentially (i.e., in series). This is not necessarily true. Certain levels can and do overlap. The magnitude of the overlap is based upon the amount of risk the organization is willing to tolerate. For example, a company can begin the development of project management checklists to support the methodology while it is still providing project management training for the workforce. A company can create a center of excellence (COE) in project management before benchmarking is undertaken.

# OVERLAP OF LEVELS




FIGURE 4–2. Overlapping levels.

Although overlapping does occur, the order in which the phases are completed cannot change. For example, even though Level 1 and Level 2 can overlap, Level 1 *must* still be completed before Level 2 can be completed. Overlapping of several of the levels can take place, as shown in Figure 4–2.

- Overlap of Level 1 and Level 2: This overlap will occur because the organization can begin the development of project management processes either while refinements are being made to the common language or during training.
- Overlap of Level 3 and Level 4: This overlap occurs because, while the organization is developing a singular methodology, plans are being made as to the process for improving the methodology.




FIGURE 4-3. Feedback among the five levels of project management maturity.

- Overlap of Level 4 and Level 5: As the organization becomes more and more committed to benchmarking and continuous improvement, the speed by which the organization wants changes to be made can cause these two levels to have significant overlap. The feedback from Level 5 back to Level 4 and Level 3, as shown in Figure 4–3, implies that these three levels form a continuous improvement cycle, and it may even be possible for all three of these levels to overlap.

Level 2 and Level 3 generally do not overlap. It may be possible to begin some of the Level 3 work before Level 2 is completed, but this is highly unlikely. Once a company is committed to a singular methodology, work on other methodologies generally terminates.

Also, if a company is truly astute in project management, it may be possible to begin benchmarking efforts even as early as Level 1. This way the company may learn from the mistakes of others rather than from its own mistakes. It is possible for Level 4 to overlap all of the first three levels.

## RISKS .

Risks can be assigned to each level of the PMMM. For simplicity's sake, the risks can be labeled as low, medium, and high. The level of risk is most frequently associated with the impact of having to change the corporate culture. The following definitions can be assigned to these three risks:

- Low risk: There will be virtually no impact on the corporate culture, or the corporate culture is dynamic and readily accepts change.
- Medium risk: The organization recognizes that change is necessary but may be unaware of the impact of the change. Instituting multiple-boss reporting would be an example of a change carrying medium risk.
- High risk: High risks occur when the organization recognizes that the changes resulting from the implementation of project management will cause a change in the corporate culture. Examples include the creation of project management methodologies, policies, and procedures, as well as decentralization of authority and decision-making.

Level 3 has the highest risks and degree of difficulty for the organization. This is shown in Figure 4–4. Once an organization is committed to Level 3, the time and effort needed to achieve the higher levels of maturity have a low degree of difficulty. Achieving Level 3, however, may require a major shift in the corporate culture.

The following chapters have detailed descriptions of each of the five levels of the PMMM. For each of the five levels of maturity, we discuss:


- The characteristics of the level
- What roadblocks exist that prevent us from reaching the next level
- What must be done to reach the next level

Also included in each of the next five chapters is an assessment instrument to help you determine your organization's degree of maturity at each level. No two companies implement project management the same way. Since maturity will

be different from company to company, the questions in these assessments can be modified to satisfy the needs of individual companies. Simply stated, using the principles contained in each chapter, you can customize the assessment instruments for each level.



# INTRODUCTION


Level 1 is the level in which the organization first recognizes the importance of project management. The organization may have a cursory knowledge of project management or simply no knowledge at all. There are certain characteristics of Level 1, as shown in Figure 5–1:

- If the organization is using project management at all, the use is sporadic. Both senior management and middle-level management provide meaningless or "lip service" support to the use of project management. Executive-level support is nonexistent.
- There may exist small "pockets" of interest in project management, with most of the interest existing in the project-driven areas of the firm.
- No attempt is made to recognize the benefits of project management. Managers are worried more about their own empires, power, and authority, and appear threatened by any new approach to management.
- Decision-making is based upon what is in the best interest of the decision-maker, rather than the firm as a whole.
- There exists no investment or support for project management training and education for fear that this new knowledge may alter the status quo.

In Level 1, project management is recognized, as in all companies but *not* fully supported. There is resistance to change and some companies never get beyond this level.

# **Common Language**

- Lip Service to Project Management
- Virtually No Executive-Level Support
- Small "Pockets" of Interest
- No Attempt to Recognize the Benefits of Project Management
- Self-Interest Comes Before Company's Best Interest
- No Investment in Project Management Training and Education



The starting point to overcome the characteristics of Level 1 is a sound, basic knowledge of the principles of project management. Education is the "name of the game" to complete Level 1. Educational programs on project management cover the principles of project management, advantages (and disadvantages) of project management methodologies, and the basic language of project management.

Project management certification training courses are ideal to fulfill the organizational needs to reach Level 1 of the project management maturity model (PMMM). Project management and total quality management (TQM) are alike in that both require an all-employee training program that begins at the senior levels of management. However, the magnitude of the training program and the material covered can vary, based upon the type of employees, skills needed, and the size and nature of the projects within the organization. Executives may require only an overview course of three to six hours, whereas employees who are more actively involved in the day-to-day activities of projects may require week-long training programs.

## ROADBLOCKS .




FIGURE 5–2. Roadblocks to completion of Level 1.

Training programs alone cannot overcome the fears and apprehensions that exist in the management ranks concerning the implementation of project management. Figure 5–2 illustrates the most common roadblocks that prevent an organization from completing Level 1.

Resistance to change is the result of management's belief that the implementation of project management will cause "culture shock," where functional managers will have to surrender some or all of their authority to the project managers. As a result, numerous excuses will appear as to why project management is not needed or will not work. Typical comments include: "We don't need it." "It doesn't apply to our business." "Let's leave well enough alone."

The implementation of project management does *not* have to be accompanied by shifts in the power and authority spectrum. However, there may be a shift in the reporting structure, inasmuch as project management is almost always accompanied by multiple-boss reporting. All training programs on project management emphasize multiple-boss reporting.

## ADVANCEMENT CRITERIA

There are five key actions required before the organization can advance to Level 2. They are:

- Arrange for initial training and education in project management.
- Encourage the training (or hiring) of certified project management professionals (PMPs).
- Encourage employees to begin communicating in common project management language.

- Recognize available project management tools.
- Develop an understanding of the principles of project management: the project management body of knowledge (PMBOK).

The last item may prove the most difficult in non-project-driven organizations where project management is not regarded as a profession.

The successful completion of Level 1 usually occurs with a medium degree of difficulty. The time period to complete Level 1 could be measured in months or years, based upon such factors as:

- Type of company (project-driven versus non-project-driven)
- Size and nature of the projects
- Amount of executive support
- Visibility of executive support
- Strength of the existing corporate culture
- Previous experience, if any, with project management
- Corporate profitability
- Economic conditions (inflation, recession, etc.)
- The speed by which training can be accomplished

## RISK \_

Level 1 carries a medium degree of risk. The organization might very well be resistant to change. Management may be fearful of a shift in the balance of power and authority.

Another major problem at Level 1 is when the organization first recognizes the complexities of multiple-boss reporting, which is a necessity for project management. Multiple-boss reporting can affect the wage and salary administration program and how employees are evaluated.

Typical factors that cause Level 1 to present a medium level of risk include:

- Fear of organizational restructuring
- Fear of changes in roles and responsibilities
- Fear of changes in priorities

#### ASSESSMENT INSTRUMENT FOR LEVEL 1

Completion of Level 1 is based upon gaining a knowledge of the fundamental principles of project management and its associated terminology. The requirements for completing Level 1 can be fulfilled through a good understanding of the guide to the PMBOK<sup>TM</sup> prepared by the Project Management Institute (PMI).

Testing on the PMBOK is a good indicator of where you stand in relation to Level 1. The testing can be accomplished on an individual basis or by taking the average score from a group of individuals.

## EXPLANATION OF POINTS FOR LEVEL 1


If you received a score of 60 or more points in each of the eight categories, then you have a reasonable knowledge of the basic principles of project management.

If you received a score of 60 or more in all but one or two of the categories, it's possible that you and your organization still possess all the knowledge you need of basic principles but that one or two of the categories do not apply directly to your circumstances. For example, if most of your projects are internal to your organization, procurement management may not be applicable. Also, for internal projects, companies often do not need the rigorous cost control systems that would be found in project-driven organizations. Eventually, however, specialized training in these deficient areas will be needed.

If your score is less than 60 in any category, a deficiency exists. For scores less than 30 in any category, rigorous training programs on basic principles appear necessary. The organization appears highly immature in project management.

A total score on all categories of 600 or more would indicate that the organization appears well positioned to begin work on Level 2 of the PMMM. If your organization as a whole scores less than 600 points, there may exist pockets of project management. Each pocket may be at a different level of knowledge. Project-driven pockets generally possess more project management knowledge than non-project-driven pockets.

This assessment instrument can be used to measure either an individual's knowledge or an organization's knowledge. To assess organizational knowledge accurately, however, care must be taken in determining the proper cross-section of participants to be tested.



### INTRODUCTION


Learning the basics of project management, and even having several employees certified as Project Management Professionals (PMPs), does not guarantee that project management is being used in your organization. Even if it is being used, it may not be used effectively. Level 2 is the stage where an organization makes a concerted effort to use project management and to develop processes and methodologies to support its effective use.

In Level 2, the organization realizes that common methodologies and processes are needed such that managerial success on one project can be repeated on other projects. Also apparent in this level is the fact that certain behavioral expectations of organizational personnel are necessary for the repetitive execution of the methodology. These are the characteristics of Level 2, as shown in Figure 6–1:

- Tangible benefits of using project management must become apparent. The most common benefits include lower cost, shortened schedules, no sacrifice of scope or quality, and the potential for a higher degree of customer satisfaction.
- Project management must be supported throughout all levels of the organization, including the senior levels. It is possible that changes to the corporate culture may be necessary, thus mandating executive support.
- A continuous stream of successfully managed projects requires methodologies and processes that can be used over and over again. This requires an organizational commitment.

# **Common Processes**

- Recognition of Benefits of Project Management
- Organizational Support at All Levels
- Recognition of Need for Processes/Methodologies
- Recognition of the Need for Cost Control
- Development of a Project Management Training Curriculum



- Managing projects within scope and time is only part of the effort. The projects must also be completed within cost, and this may mandate changes to the cost accounting system.
- The final characteristic of Level 2 is the development of a project management curriculum rather than just a project management course. This is often seen as proof of the organization's firm commitment to project management.

# LIFE CYCLES FOR LEVEL 2 .




FIGURE 6-2. Life cycle phases for Level 2 of project management maturity.

Common processes require a good process definition effort accompanied by the necessary organizational behavior needed for the execution of the processes. Level 2, common processes, can be broken down into five life cycle phases, as shown in Figure 6–2. The first life cycle phase of Level 2 is the embryonic phase, which is where the organization recognizes that project management can benefit the organization. The embryonic phase includes:

- Recognizing the need for project management
- Recognizing the potential benefits of project management
- Recognizing the applications of project management to the various parts of the business
- Recognizing some of the changes necessary to implement project management

Companies do not generally promote the acceptance of project management unless they understand a sound basis for wanting project management. The six most common driving forces for project management are as follows:

- Capital projects: High-dollar-value capital projects require effective planning and scheduling. Without project management, ineffective use of manufacturing resources may occur.
- Customer expectations: Customers have the right to expect the contractor to manage the customer's work requirements efficiently and effectively.
- Internal competitiveness: Executives want employees to focus on external competition rather than internal competition, power struggles, and gamesmanship.
- Executive understanding: Although it's uncommon, executives can drive the acceptance of project management from the top of the organization down to the bottom.
- New product development: Executives want a methodology in place that provides a high likelihood that R&D projects will be completed successfully, in a timely manner, and within reasonable cost.
- Efficiency and effectiveness: Executives want the organization to be highly competitive.




FIGURE 6–3. The components of survival.

In theory, most companies have one and only one driving force. While we've just discussed six different driving forces, in practice, in reality, they combine to give us one, and only one—survival. This is shown in Figure 6–3. Once execu-

tives recognize that project management is needed for survival, changes occur quickly.

What is unfortunate about the embryonic phase is that the recognition of benefits and applications may be seen first by lower and middle levels of management. Senior management must then be "sold" on the concept of project management. This leads us to the second life cycle phase, executive management acceptance. Included in the executive management acceptance phase are the following:

- Visible executive support
- Executive understanding of project management
- Project sponsorship
- Willingness to change the way the company does business

The third life cycle phase of Level 2 is line management acceptance. This includes:

- Visible line management support
- Line management commitment to project management
- Line management education
- Release of functional employees for project management training programs

It is highly unlikely that line managers will provide support for project management unless they also see "visible" executive support.

The fourth life cycle phase of Level 2 is the growth phase. This is the critical phase. Although some of the effort in this phase can be accomplished in parallel with the first three life cycle phases of Level 2, the completion of this phase

is predicated upon the completion of the first three life cycle phases. The growth phase is the beginning of the creation of the project management process. Included in this phase are:

- Development of company project management life cycles
- Development of a project management methodology
- A commitment to effective planning
- Minimization of scope changes (i.e., of creeping scope)
- Selection of project management software to support the methodology

Unfortunately, companies often develop several types of methodologies for each type of project within the organization. This becomes an inefficient use of resources, although it can function as a good learning experience for the company.

The fifth life cycle phase of Level 2 is the so-called "initial maturity phase" of Level 2. Included in this phase are:


- The development of a management cost/schedule control system
- Integration of schedule and cost control
- Development of an ongoing educational curriculum to support project management and enhance individual skills

Many companies never fully complete this life cycle phase because the organization is resistant to project cost control, otherwise known as horizontal accounting. Line managers dislike horizontal accounting because it clearly identifies which line managers provide good estimates for projects and which do not. Executives resist horizontal accounting because the executives want to establish a budget and schedule long before a project plan is created.

# ROADBLOCKS \_

Figure 6–4 illustrates the most common roadblocks that prevent an organization from completing Level 2. Based upon the strength and longevity of the corporate culture, there could be strong resistance to change. The argument is always, "What we already have works well." The resistance to change stems from the fear that support for a new methodology will result in a shift in the established power and authority relationships.

Another area of resistance is due to the misbelief that a new methodology *must* be accompanied by rigid policies and procedures, thus once again causing potential changes to the power and authority structure. The final roadblock comes from the fear that "horizontal accounting" will bring to the surface problems that people would prefer to keep hidden, such as poor estimating ability.

# ADVANCEMENT CRITERIA

There are four key actions required to complete Level 2 and advance to Level 3. These actions are as follows:

- Develop a culture that supports both the behavioral and quantitative sides of project management.
- Recognize both the driving forces/need for project management and the benefits that can be achieved in both the short term and the long term.
- Develop a project management process/methodology such that the desired benefits can be achieved on a repetitive basis.
- Develop an ongoing, all-employee project management curriculum such that the project management benefits can be sustained and improved upon for the long term.

## RISK .

The successful completion of Level 2 usually occurs with a medium degree of difficulty. The time period to complete Level 2 is usually six months to two years, based upon such factors as:

- Type of company (project-driven versus non-project-driven)
- Visibility of executive support
- Strength of the corporate culture

- Resistance to change
- Speed with which a good, workable methodology can be developed
- Existence of an executive-level champion to drive the development of the project management methodology
- Speed with which the project management benefits can be realized

The risk in this level can be overcome through strong, visible executive support.

### OVERLAPPING LEVELS

Level 2 can and does overlap Level 1. There is no reason why we must wait for a multitude of people to be trained in project management before we begin the development of processes and methodologies. Also, the earlier the company begins developing processes and methodologies, the earlier those processes and methodologies can be included as part of the training. One HMO conducted a three-day course on the principles of project management. A fourth day was spent covering the company's processes and methodologies for project management. Thus the employees could see clearly how the processes/methodologies utilized the basic concepts of project management.

Level 2, common processes, is the process definition level. Level 2 can be fulfilled by recognizing the different life cycle phases of Level 2.






## INTRODUCTION

Level 3 is the level in which the organization recognizes that synergism and process control can best be achieved through the development of a singular methodology rather than by using multiple methodologies. In this level, the organization is totally committed to the concept of project management. The characteristics of Level 3, as shown in Figure 7–1, are as follows:

- Integrated processes: This is where the organization recognizes that multiple processes can be streamlined into one, integrated process encompassing all other processes. (However, not all companies have the luxury of using a single methodology.)
- Cultural support: Integrated processes create a singular methodology. It is through this singular methodology that exceptional benefits are achieved. The execution of the methodology is through the corporate culture, which now wholeheartedly supports the project management approach. The culture becomes a cooperative culture.
- Management support: In this level, project management support permeates the organization throughout all layers of management. The support is visible. Each layer or level of management understands its role and the support needed to make the singular methodology work.
- Informal project management: With management support and a cooperative culture, the singular methodology is based upon guidelines and checklists, rather than based on the expensive development of rigid policies and procedures. Paperwork is minimized.

- Training and education: With strong cultural support, the organization realizes financial benefits from project management training. The benefits can be described quantitatively and qualitatively.
- Behavioral excellence: The organization recognizes the behavioral differences between project management and line management. Behavioral training programs are developed to enhance project management skills.




FIGURE 7–2. The hexagon of excellence.

These six characteristics formulate the "hexagon of excellence," as shown in Figure 7–2. These six areas differentiate those companies excellent in project management from those with average skills in project management. Each of the six areas is discussed below.

### INTEGRATED PROCESSES





FIGURE 7–3. Totally uncoupled processes.

Companies that are relatively immature in project management have multiple processes in place. Figure 7–3 shows the three most common of these separate processes. Why, however, would a company want its processes, its facilities, its resources in general, to be totally uncoupled? The first two processes to be integrated, once an organization understands the advantages, are usually project management and total quality management (TQM). After all, employees trained in the principles of TQM will realize the similarities between the two processes. All of the winners of the prestigious Malcolm Baldrige Award have excellent project management systems in place.

When organizations begin to realize the importance of a singular methodology, project management becomes integrated with TQM and concurrent engi-




FIGURE 7–5. Integrated processes for the twenty-first century.

neering to formulate a singular methodology. This integration is shown in Figure 7–4. As companies begin to climb the ladder toward excellence in project management, the initial singular methodology is further enhanced to include risk management and change management, as shown in Figure 7–5. Risks generally require scope changes, which, in turn, create additional risks. Creating a singular,

integrated methodology that encompasses all other methodologies leads to organizational efficiency and effectiveness.

# CULTURE .

Project management methodologies must not simply be pieces of paper. The pieces of paper must be converted into a world-class methodology by the way in which the corporate culture executes the methodology. Companies excellent in project management have cooperative cultures where the entire organization supports the singular methodology. Organizational resistance is at a minimum, and everyone pitches in during times of trouble.

# MANAGEMENT SUPPORT .

Cooperative cultures require effective management support at all levels. During the execution of the project management methodology, the interface between project management and line management is critical. Effective relationships with line management are based upon these factors:

- Project managers and line managers share accountability for the successful completion of a project. Line managers must keep their promises to the project managers.
- Project managers negotiate with line managers for the accomplishment of deliverables rather than for specific talent. Project managers can request specific talent, but the final decision for staffing belongs to the line manager.
- Line managers trust their employees enough to empower those employees to make decisions related to their specific functional area without continuously having to run back to their line manager.
- If a line manager is unable to keep a promise he or she made to a project, then the project manager must do everything possible to help the line manager develop alternative plans.

The relationship between project management and senior management is equally important. A good relationship with executive management, specifically the executive sponsor, includes these factors:

- The project manager is empowered to make project-related decisions. This is done through decentralization of authority and decision-making.
- The sponsor is briefed periodically while maintaining a hands-off, but available, position.

- The project manager (and other project personnel) are encouraged to present recommendations and alternatives rather than just problems.
- Exactly what needs to be included in a meaningful executive status report has been formulated.
- A policy is in place calling for periodic, but excessively frequent, briefings.

#### INFORMAL PROJECT MANAGEMENT

With informal project management, the organization recognizes the high cost of paperwork. Informal project management does not *eliminate* paperwork. Instead, paperwork requirements are *reduced* to the minimum acceptable levels. For this to work effectively, the organization must experience effective communications, cooperation, trust, and teamwork. These four elements are critical components of a cooperative culture.

As trust develops, project sponsorship may be pushed down from the executive levels to middle management. The project managers no longer wears multiple hats (i.e., being a project manager and line manager at the same time), but functions as a dedicated project manager.

The development of project management methodologies at Level 2 are based upon rigid policies and procedures. But in Level 3, with a singular methodology based more upon informal project management, methodologies are written in the format of general guidelines and checklists. This drastically lowers methodology execution cost and execution time.

The advent of colored printers has allowed companies to provide additional information without words. As an example, one company uses a "traffic light" beside each work breakdown structure (WBS) work package in the status report. The traffic light is either red, yellow, or green, based upon the following definitions:

- Red: A problem exists that may affect time, cost, scope, or quality. Sponsor involvement is necessary.
- Yellow: This is a caution. A potential problem may exist. The sponsor is informed, but no action by the sponsor is necessary right now.
- Green: Work is progressing as planned. Sponsor involvement is not necessary.

#### TRAINING AND EDUCATION .

In Level 3, there is a recognition that there exists a return on investment for training dollars. The benefits, or return on investment, can be measured quantitatively and qualitatively. Quantitative results include:

- Shorter product development time
- Faster, higher quality decisions
- Lower costs
- Higher profit margins
- Fewer people needed
- Reduction in paperwork
- Improved quality and reliability
- Lower turnover of personnel
- Quicker "best practices" implementation

Qualitative results include:

- Better visibility and focus on results
- Better coordination
- Higher morale
- Accelerated development of managers
- Better control
- Better customer relations
- Better support from the functional areas
- Fewer conflicts requiring senior management involvement




FIGURE 7-6. Project management costs versus benefits.

Project management training and education is an investment and, as such, senior management wishes to know when the added profits will materialize. This can best be explained from Figure 7–6. Initially, there may be a substantial cost incurred during Level 2 and the beginning of Level 3. But as the culture develops

and informal project management matures, the cost of project management diminishes to a pegged level while the additional profits grow. The "question mark" in Figure 7–6 generally occurs during Level 3, which is usually about two to five years after the organization has made a firm commitment to project management.

A question normally asked by executives is, "How do we know if we are in Level 3 of the project management maturity model (the PMMM)?" The answer is by the number of conflicts coming up to the senior levels of management for resolution.

By Level 3, executives have realized that the speed by which the benefits can be achieved can be accelerated through proper training and education. Therefore the training and education in Level 3 does not consist merely of a few random courses. Instead, as discussed in the advancement criteria for completing Level 2 and moving up to Level 3, the company develops a project management curriculum. This will encompass a "core competency model" for the basic and advanced skills that a project manager should possess. Training is conducted to support the core competency skills.

#### BEHAVIORAL EXCELLENCE \_

Behavioral excellence occurs when the organization recognizes the differences between project management and line management, and the fact that a completely different set of training courses is required to support sustained project management growth. Emphasis is placed on:

- Motivation in project management
- Creation of outstanding project leaders
- Characteristics of productive teams
- Characteristics of productive organizations
- Sound and effective project management

People are often under the misapprehension that achieving Level 3 in the PMMM will deliver 100 percent successful projects. This is not true. Successful implementation of project management does *not* guarantee that your projects will be successful. Instead, it does guarantee that your projects will be managed effectively, thus improving your chances of success. From Figure 7–7 we see that, during Level 3 of the PMMM, the number of project successes increases. However, even though the number of successes increases, and comes to dramatically exceeds the number of failures, failure still exists. Project management does not circumvent the problem of unrealistic objectives or targets, unforeseen acts of God, and economic upheaval. Any company that has a 100 percent project success rate is not working on enough projects. No risk is being taken. Also, any executive sponsor or project manager who always makes the right decision is not making enough decisions.





Figure 7–8 shows the key roadblocks that prevent an organization from completing Level 3. They include:

- Don't fix it if it isn't broken. We should continue to use the processes now in place.
- There will always exist initial resistance to a singular methodology for fear that it will be accompanied by shifts in the balance of power.
- Line managers may resist accepting accountability for the promises made to the projects. Shared accountability is often viewed as a high risk for the line managers.
- Organizations with strong, fragmented corporate cultures often resist being converted over to a single, cooperative culture.
- Some organizations thrive on the belief that what is not on paper has not been said. Overemphasis on documentation is a bad habit that is hard to break.

# ADVANCEMENT CRITERIA

There are certain key actions needed to advance from Level 3 to Level 4. These key actions are as follows:



- Don't Fix It If It Isn't Broken
- Resistance to a Singular Integrated Methodology (i.e., Repeatable Process)
- Resistance to Shared Accountability
- Fragmented Corporate Culture
- Overemphasis on Documentation

- Integrate all related processes into a single methodology with demonstrated successful execution.
- Encourage the corporate-wide acceptance of a culture that supports informal project management and multiple-boss reporting.
- Develop support for shared accountability.

### RISK .

The successful completion of Level 3 is accompanied by a high degree of difficulty. Culture shock may result. The time period to complete Level 3 is measured in years, based upon such factors as:

- The speed at which the culture will change
- The acceptance of informal project management
- The acceptance of a singular methodology

The greatest degree of risk in project management is attributed to the corporate culture. Poorly designed methodologies can convert a good, cooperative culture into a combative culture.

If an organization develops a singular methodology, then the organization should strive for a corporate-wide acceptance of that methodology. If the methodology is accepted and used only in "pockets of interest," then a fragmented culture will occur. Fragmented cultures generally do not allow the organization to maximize the benefits of project management.

# OVERLAPPING LEVELS ,

Generally speaking, Levels 2 and 3 do not overlap. Once a company recognizes the true benefits of project management and the need for a singular methodology, the organization stops developing individual processes and focuses on what's best for the whole.

Allowing individual processes to continue without any integration into a singular methodology gives employees a viable excuse to resist change. Employees must be encouraged to make decisions that are in the best interest of the company as a whole rather than in the best interest of their own department.



#### INTRODUCTION

Project management benchmarking is the process of continuously comparing the project management practices of your organization with the practices of leaders anywhere in the world; its goal is to to gain information to help you improve your own performance. The information obtained through benchmarking might be used to help you improve your processes and the way in which those processes are executed, or the information might be used to help your company become more competitive in the marketplace.

Benchmarking is a continuous effort of analysis and evaluation. Care must be taken in deciding what to benchmark. It is impossible and impractical to evaluate every aspect of project management. It is best to decide on those few critical success factors that must go right for your business to flourish. For project management benchmarking, the critical success factors are usually the key business processes and how they are integrated. If these key success factors do not exist, then the organization's efforts may be hindered.

Deciding what information to benchmark against is usually easier than obtaining that information. Locating some information will require a critical search. Some information may be hard to find. Some information you would find helpful might not be available for release because the organization that has it views it as proprietary. Identifying the target companies against which you should benchmark may not be as easy as you believe.

Benchmarking has become common since it was first popularized by Xerox during the 1980s. Benchmarking is an essential ingredient for those companies

that have won the prestigious Malcolm Baldrige Award. Most of these award winners readily share their project management experiences. Unfortunately, there are some truly excellent companies in project management that have not competed for these awards because they do not want their excellence displayed.

Benchmarking for project management can be accomplished through surveys, questionnaires, attending local chapter meetings of the Project Management Institute (PMI), and attending conferences and symposiums. Personal contacts often provide the most valued sources of information.

There is a so-called "Code of Conduct" for benchmarking:

- Keep the benchmarking process legal.
- Do not violate rules of confidentiality.
- Sharing information is a two-way street.
- Be willing to sign a nondisclosure form.
- Do not share *any* information received with a third party without written permission.
- Emphasize guidelines and checklists but avoid asking for forms that may be highly sensitive.

Benchmarking should not be performed unless your organization is willing to make changes. The changes must be part of a structured process that includes evaluation, applicability, and risk management. Benchmarking is part of the strategic planning process for project management that results in an action plan ready for implementation.


#### CHARACTERISTICS .

Level 4 is the level where the organization realizes that its existing methodology can be improved upon. The complexity rests in figuring out how to achieve that improvement. For project-driven companies, continuous improvement is a means to maintain or improve upon a competitive advantage. Continuous improvement is best accomplished through continuous benchmarking. The company must decide whom to benchmark and what to benchmark.

There are certain characteristics of Level 4, as show in Figure 8-1:

- The organization must establish a project office (PO) or a center of excellence (COE) for project management. This is the focal position in the company for project management knowledge.
- The PO or COE must be dedicated to the project management improvement process. This is usually accomplished with full-time, dedicated personnel.
- Benchmarking must be made against both similar and nonsimilar industries. In today's world, a company with five years of experience in pro-

ject management could easily surpass the capabilities of a company that has used project management for 20 years or more.

• The company should perform both quantitative and qualitative benchmarking. Quantitative benchmarking analyzes processes and methodologies, whereas qualitative benchmarking looks at project management applications.

# THE PROJECT OFFICE/ CENTER OF EXCELLENCE

When companies reach Level 4, they are committed to project management across the entire organization. Project management knowledge is now considered as essential for the survival of the firm. To centralize the knowledge on project management, organizations have created a project office (PO) or a center of excellence (COE) for project management.

Responsibilities for a PO/COE include:

- A strategic planning focal point of project management
- An organization dedicated to benchmarking for project management
- An organization dedicated to continuous improvement
- An organization that provides mentorship for inexperienced project managers
- A centralized data bank on lessons learned

- An organization for sharing project management ideas and experiences
- A "hot line" for problem-solving that does not automatically inform senior management
- An organization for creating project management standards
- A focal point for centralized planning and scheduling activities
- A focal point for centralized cost control and reporting
- An organization to assist Human Resources in the creation of a project management career path
- An organization to assist Human Resources in developing a project management curriculum

Most companies view the PO and the COE as being two names for the same thing. There are, however, fundamental differences, as shown in Table 8–1. Despite the responsibilities, companies are struggling with the organizational reporting location of the PO/COE. There appears to be agreement that the location should be at the senior levels of management. Figure 8–2 shows a simplified organizational chart for a PO.



FIGURE 8–2. Simplified PO organizational chart.


# **BENCHMARKING OPPORTUNITIES**

Historically, benchmarking is accomplished by two approaches: competitive benchmarking and process benchmarking. Competitive benchmarking concentrates on deliverables and quantitative critical success factors. Process benchmarking focuses on process performance and functionality. Process benchmarking is most closely aligned to project management. For simplicity's sake, we will consider only process improvement benchmarking. We can break it down into quantitative (i.e., integration) process improvement opportunities and qualitative process improvement opportunities.

Figure 8–3 shows the quantitative process improvement opportunities, which center around enhancements due to integration opportunities. The five major areas identified in Figure 8–3 are the five integrated processes described in Level 3 of the project management maturity model (PMMM).




FIGURE 8-4. Qualitative process improvement opportunities (generic performance improvement strategies).

Figure 8–4 shows the qualitative process improvement opportunities, which center around applications and further changes to the corporate culture. Included in the qualitative process improvement activities are:

- Corporate acceptance: This includes getting the entire organization to accept a singular methodology for managing projects. Pockets of project management support tend to hinder rapid acceptance of project management by the rest of the organization. To obtain corporate acceptance, we must:
  - Increase the usage and support of existing users

- Attract new internal users, those who have been providing resistance to project management
- Discourage the development of parallel methodologies, which can create further pockets of project management. This is done by showing the added costs of parallelization.
- Emphasize the present and future benefits to the corporation that will result from using a singular methodology.
- Integrated processes: This is a recognition that the singular methodology can be enhanced further by integrating other existing processes into the singular methodology. Typically, this includes business processes such as capital budgeting, feasibility studies, cost-benefit analyses, and return-on-investment analyses. New processes that could be integrated include supply chain management.
- Enhanced benchmarking: Everyone tends to benchmark against the best within their own industry, but benchmarking against nonsimilar industries can be just as fruitful. An aerospace company spent over ten years benchmarking only against other aerospace companies. During the mid-1990s, the firm began benchmarking against nonaerospace firms, and found that these firms had developed outstanding methodologies with capabilities exceeding those of the aerospace firm.
- Software enhancements: Although off-the-shelf software packages exist, most firms still need some type of customization. This can be done through internal upgrades for customization or by new purchases, with the software vendor developing the customization.


There also exist roadblocks to completing Level 4 and reaching Level 5, as seen in Figure 8–5. The singular methodology created in Level 3 was developed internally within the company. Benchmarking may indicate that improvements can be made. The original architects of the singular methodology may resist change with arguments such as: "It wasn't invented here," or "It does not apply to us." Another form of resistance is the argument that we have benchmarked against the wrong industry.

People are inherently fearful of change, and benchmarking opens the door for unexpected results to surface. Sooner or later everyone realizes that benchmarking is a necessity for company survival. It is at this junction where a serious commitment to benchmarking occurs.

# ADVANCEMENT CRITERIA,

There are four key actions required by the organization to advance to Level 5, the final level. These actions are as follows:

- Create an organization dedicated to benchmarking.
- Develop a project management benchmarking process.
- Decide what to benchmark and against whom to benchmark.
- Recognize the benefits of benchmarking.


# **EXPLANATION OF POINTS FOR LEVEL 4**,

This exercise measures two items: Is your organization performing benchmarking and, if so, are you emphasizing quantitative or qualitative benchmarking?

Quantitative benchmarking investigates improvements to the methodology and processes. Scores greater than 25 are excellent and imply that your organization is committed to quantitative benchmarking. Scores less than 10 indicate a lack of commitment or that the organization does not understand how to benchmark or against whom to benchmark. Scores between 11 and 24 indicate that some benchmarking may be taking place, but a PO or COE is not in place as yet.

Qualitative benchmarking looks more at applications benchmarking and how the culture executes the methodology. Scores greater than 12 are excellent. Scores less than 5 indicate that not enough emphasis is placed upon the "soft side" of benchmarking. Scores between 6 and 11 are marginally acceptable.

Combined scores (i.e., quantitative and qualitative) of 37 or more imply that your organization is performing benchmarking well. The right information is being considered and the right companies are being targeted. The balance between quantitative and qualitative benchmarking is good. The company probably has a COE or PO in place.



# CHARACTERISTICS


In the previous level, the organization began benchmarking against other companies. In Level 5, the organization evaluates the information learned during benchmarking and *implements* the changes necessary to improve the project management process. It is in this level that the company comes to the realization that excellence in project management is a never-ending journey.

There are four characteristics of Level 5, as shown in Figure 9–1.

- The organization must create lessons learned files from the debriefing sessions at the end of each project. Case studies on each project, discussing mistakes made and knowledge learned, are critical so that mistakes are not repeated.
- The knowledge learned on each project must be transferred to other projects and teams. This can be accomplished through quarterly or semiannual lessons learned forums or from lessons learned case studies discussed in training programs.
- The company must recognize that a mentorship program should be put in place to groom future project managers. Knowledge transfer and lessons learned information can be transmitted through the mentorship program as well. The mentorship program is best administered through a Project Office (PO) or a Center of Excellence (COE).
- The final characteristic of Level 5 is a corporate-wide understanding that strategic planning for project management is a continuous, ongoing process.

Documenting project results in lessons learned files and the preparation of case studies can be difficult to implement. People learn from both successes and failures. One executive commented that the only true project failures are the ones from which we learned nothing. Another executive commented that project debriefings are a waste of time unless we learn something from them.

Documenting successes is easy. Documenting mistakes is more troublesome because people do not want their names attached to mistakes for fear of retribution. Company employees still know which individuals worked on which projects, even when the case study is disguised. A strong corporate culture is needed to make documenting mistakes work effectively.

#### CONTINUOUS IMPROVEMENT AREAS

Project management methodologies must undergo continuous improvement. This may be strategically important to stay ahead of the competition. Continuous improvements to a methodology can be internally driven by factors such as better software availability, a more cooperative corporate culture, or simply training and education in the use of the methodology. Externally driven factors include relationships with customers and suppliers, legal factors, social factors, technological factors, and even political factors.




FIGURE 9–2. Factors to consider for continuous improvement.

Five areas for continuous improvement to the project management methodology are shown in Figure 9–2 and in the following:

#### Existing Process Improvements

- Frequency of use: Has prolonged use of the methodology made it apparent that changes can be made?
- Access to customers: Can we improve the methodology to get closer to our customers?
- Substitute products: Are there new products (i.e., software) in the marketplace that can replace and improve part of our methodology?
- Better working conditions: Can changes in the working conditions cause us to eliminate parts of the methodology (i.e., paperwork requirements)?
- Better use of software: Will new or better use of the software allow us to eliminate some of our documentation and reports?

# Integrated Process Improvements

- Speed of integration: Are there ways to change the methodology to increase the speed of integrating activities?
- Training requirements: Have changes in our training requirements mandated changes in our methodology?
- Corporate-wide acceptance: Should the methodology change in order to obtain corporate-wide acceptance?

# Behavioral Issues

- Changes in organizational behavior: Have changes in behavior mandated methodology changes?
- Cultural changes: Has our culture changed (i.e., to a cooperative culture) such that the methodology can be enhanced?

- Management support: Has management support improved to a point where fewer gate reviews are required?
- Impact on informal project management: Is there enough of a cooperative culture such that informal project management can be used to execute the methodology?
- Shifts in power and authority: Do authority and power changes mandate a looser or a more rigid methodology?
- Safety considerations: Have safety or environmental changes occurred that will impact the methodology?
- Overtime requirements: Do new overtime requirements mandate an updating of forms, policies, or procedures?

#### Benchmarking

- Creation of a project management COE: Do we now have a "core" group responsible for benchmarking?
- Cultural benchmarking: Do other organizations have better cultures than we do in project management execution?
- Process benchmarking: What new processes are other companies integrating into their methodology?

#### Managerial Issues

- Customer communications: Have there been changes in the way we communicate with our customers?
- Resource capability versus needs: If our needs have changed, what has happened to the capabilities of our resources?
- Restructuring requirements: Has restructuring caused us to change our sign-off requirements?
- Growing pains: Does the methodology have to be updated to include our present growth in business (i.e., tighter or looser controls)?

The five factors considered above provide a company with a good framework for continuous improvement. The benefits of continuous improvement include:

- Better competitive positioning
- Corporate unity
- Improved cost analysis
- Customer value added
- Better management of customer expectations
- Ease of implementation

# THE NEVER-ENDING CYCLE \_\_\_\_

Given the fact that maturity in project management is a never-ending journey, we can define excellence in project management as a never-ending cycle of bench-




FIGURE 9–3. The five levels of maturity.

marking–continuous improvement–singular methodology enhancement, as shown in Figure 9–3. This implies that Levels 3, 4, and 5 of the PMMM are repeated over and over again. This also justifies our statement of the need for overlapping levels.

# EXAMPLES OF CONTINUOUS

As more and more industries accept project management as a way of life, the continuous improvement opportunities in project management practices have arisen at an astounding rate. What is even more important is the fact that companies are sharing their accomplishments with other companies during benchmarking activities.

Ten recent interest areas are included in this chapter:

- Developing effective procedural documentation
- Project management methodologies
- Continuous improvement
- Capacity planning
- Competency models
- Managing multiple projects
- End-of-phase review meetings
- Strategic selection of projects

- Portfolio selection of projects
- Horizontal accounting

These ten topics appear to be the quickest to change as we enter the twentyfirst century.

#### DEVELOPING EFFECTIVE PROCEDURAL DOCUMENTATION

Previously, we showed the necessity to develop processes and ultimately a singular methodology for project management. Project management methodologies require a project management information system (PMIS), which is based upon procedural documentation. The procedural documentation can be in the form of policies, procedures, guidelines, forms, and checklists, or even a combination of these. Good procedural documentation will accelerate the project management maturity process, foster support at all levels of management, and greatly improve project communications. The type of procedural documentation selected can change over the years and is heavily biased on whether we wish to manage more formally or informally. In any event, procedural documentation supports effective communications, which in turn, provides for better interpersonal skills.

An important facet of any project management methodology is to provide the people in the organization with procedural documentation on how to conduct project-oriented activities and how to communicate in such a multidimensional environment. The project management policies, procedures, forms, and guidelines can provide some of these tools for delineating the process, as well as a format for collecting, processing, and communicating project-related data in an orderly, standardized format. Project planning and tracking, however, involve more than just the generation of paperwork. They require the participation of the entire project team, including support departments, subcontractors, and top management. This involvement of the entire team fosters a unifying team environment. This unity, in turn, helps the team focus on the project goals and, ultimately, fosters each team member's personal commitment to accomplishing the various tasks within time and budget constraints. The specific benefits of procedural documents, including forms and checklists, are that they help to:

- Provide guidelines and uniformity
- Encourage useful, but minimum, documentation
- Communicate clearly and effectively
- Standardize data formats
- Unify project teams
- Provide a basis for analysis
- Document agreements for future reference
- Refuel commitments

- Minimize paperwork
- Minimize conflict and confusion
- Delineate work packages
- Bring new team members onboard
- Build an experience track and method for future projects

Done properly, the process of project planning must involve both the performing and the customer organizations. This involvement creates a new insight into the intricacies of a project and its management methods. It also leads to visibility of the project at various organizational levels, management involvement, and support. It is this involvement at all organizational levels that stimulates interest in the project and the desire for success, and fosters a pervasive reach for excellence that unifies the project team. It leads to commitment toward establishing and reaching the desired project objectives and to a self-forcing management system where people want to work toward these established objectives.

#### The Challenges

Despite all these benefits, management is often reluctant to implement or fully support a formal project management system. Management concerns often center around four issues: overhead burden, start-up delays, stifled creativity, and reduced self-forcing control. First, the introduction of more organizational formality via policies, procedures, and forms might cost some money, plus additional funding will be needed to support and maintain the system. Second, the system is seen, especially by action-oriented managers, as causing undesirable start-up delays by requiring the putting of certain stakes into the ground, in terms of project definition, feasibility, and organization, before the detailed implementation can start. Third and fourth, the system is often perceived as stifling creativity and shifting project control from the responsible individual to an impersonal process that enforces the execution of a predefined number of procedural steps and forms without paying attention to the complexities and dynamics of the individual project and its possibly changing objectives.

The comment of one project manager may be typical for many situations: "My support personnel feels that we spend too much time planning a project up front; it creates a very rigid environment that stifles innovation. The only purpose seems to be establishing a basis for controls against outdated measures and for punishment rather than help in case of a contingency." This comment is echoed by many project managers. It's not a groundless attitude either, for it also illustrates a potential misuse of formal project management systems, establishment of unrealistic controls and penalties for deviations from the program plan rather than help in finding solutions. Whether these fears are real or imaginary within a particular organization does not change the situation. It is the perceived coercion that leads to the rejection of the project management system. An additional concern is the lack of management involvement and funding to implement the project management system. Often the customer or sponsor organization must also be involved and agree with the process for planning and controlling the project.

#### How to Make It Work

Few companies have introduced project management procedures with ease. Most have experienced problems ranging from skepticism to sabotage of the procedural system. Realistically, however, program managers do not have much of a choice, especially for larger, more complex programs. Every project manager who believes in project management has his or her own success story. It is interesting to note, however, that many have had to use incremental approaches to develop and implement their project management methodology.

Developing and implementing such a methodology incrementally is a multifaceted challenge to management. The problem is seldom one of understanding the techniques involved, such as budgeting and scheduling, but rather one of involving the project team in the process, getting their input, support, and commitment, and establishing a supportive environment. Furthermore, project personnel must have the feeling that the policies and procedures of the project management system facilitate communication, are flexible and adaptive to the changing environment, and provide an early warning system through which project personnel can obtain assistance rather than punishment in case of a contingency.

The procedural guidelines and forms of an established project management methodology can be especially useful during the project planning/definition phase. Not only do they help to delineate and communicate the four major sets of variables for organizing and managing the project—(1) tasks, (2) timing, (3) resources, and (4) responsibilities—they also help to define measurable milestones, as well as report and review requirements. This in turn makes it possible to measure project status and performance and supplies the crucial inputs for controlling the project toward the desired results.

Developing an effective project management methodology takes more than just a set of policies and procedures. It requires the integration of these guidelines and standards into the culture and value system of the organization. Management must lead the overall efforts and foster an environment conducive to teamwork. The greater the team spirit, trust, commitment and quality of information exchange among team members, the more likely it is that the team will develop effective decision-making processes, make individual and group commitments, focus on problem-solving, and operate in a self-forcing, self-correcting control mode. These are the characteristics that will support and pervade the formal project management system and make it work for you. When understood and accepted by the team members, such a system provides the formal standards, guidelines, and measures needed to direct a project toward specific results within the given time and resource constraints.

#### **Established Practices**

Although project managers may have the right to establish their own policies and procedures, many companies have taken the route of designing project control forms that can be used uniformly on all projects to assist in the communications process. Project control forms serve two vital purposes by establishing a common framework from which:

- The project manager will communicate with executives, functional managers, functional employees, and clients
- Executives and the project manager can make meaningful decisions concerning the allocation of resources.

Success or failure of a project depends upon the ability of key personnel to have sufficient data for decision-making. Project management is often considered to be both an art and a science. It is an art because of the strong need for interpersonal skills, and the project planning and control forms attempt to convert part of the "art" into a science.

Many companies tend not to realize until too late the necessity of good planning and control forms. Today, some of the larger companies with mature project management structures maintain a separate functional unit for forms control. This is quite common in aerospace and defense, but is also becoming common practice in other industries. Yet, some executives still believe that forms are needed only when the company grows to a point where a continuous stream of unique projects necessitates some sort of uniform control mechanism.

In some small or non-project-driven organizations, each project can have its own forms. But for most other organizations, uniformity is a must. Quite often, the actual design and selection of the forms is made by individuals other than the users. This can easily lead to disaster.

Large companies with a multitude of different projects do not have the luxury of controlling projects with three or four forms. There are different forms for planning, scheduling, controlling, authorizing work, and so on. It is not uncommon for companies to have 20 to 30 different forms, each dependent upon the type of project, length of project, dollar value, type of customer reporting, and other such factors.

In project management, the project manager is often afforded the luxury of being able to set up his or her own administration for the project, a fact that could lead to irrevocable long-term damage if each project manager were permitted to design his or her own forms for project control. Many times this problem remains unchecked, and the number of forms grows exponentially with each project.

Executives can overcome this problem either by limiting the number of forms necessary for planning, scheduling, and controlling projects, or by establishing a separate department to develop the needed forms. Neither of these approaches is really practical or cost-effective. The best method appears to be the task force concept, where both managers and doers will have the opportunity to interact and provide input. In the short run, this may appear to be ineffective and a waste of time and money. However, in the long run there should be large benefits.

To be effective, the following ground rules can be used:

- Task forces should include managers as well as doers.
- Task force members must be willing to accept criticism from other peers, superiors, and especially subordinates who must "live" with these forms.

- Upper level management should maintain a rather passive (or monitoring) involvement.
- A minimum of signature approvals should be required for each form.
- Forms should be designed so that they can be updated periodically.
- Functional managers and project managers must be dedicated and committed to the use of the forms.

#### **Categorizing the Broad Spectrum of Documents**





FIGURE 9–4. Interrelationship of project activities with various functional/organizational levels and project management levels. *Source:* Reprinted from H. Kerzner and H. J. Thamhain, *Project Management Operating Guidelines*. New York: Van Nostrand Reinhold, 1985.

The dynamic nature of project management and its multifunctional involvement create a need for a multitude of procedural documents to guide a project through the various phases and stages of integration. Especially for larger organizations, the challenge is not only to provide management guidelines for each project activity, but also to provide a coherent procedural framework within which project leaders from all disciplines can work and communicate with each other. Specifically, each policy or procedure must be consistent with and accommodating to the various other functions that interface with the project over its life cycle. This complexity of intricate relations is illustrated in Figure 9–4.

One simple and effective way of categorizing the broad spectrum of procedural documents is by utilizing the work breakdown concept, as shown in Figure 9–5. This concept organizes the principal procedural categories along the lines of the principal project life cycle phases. Each category is then subdivided into (1) general management guidelines, (2) policies, (3) procedures, (4) forms, and (5) checklists. If necessary, the concept can be extended an additional step to develop policies, procedures, forms, and checklists for the various project and functional sublevels of operation. Although this level of formality might be needed for very large programs, an effort should be made to minimize "layering" of policies and procedures as the additional bureaucracy can cause new interface problems and additional overhead costs. For most projects, a single document covers all levels of project operations.

#### As We Mature . . .

As companies become more mature in executing the project management methodology, project management policies and procedures are discarded and replaced with guidelines, forms, and checklists. More flexibility is thus provided the project manager. Unfortunately, reaching this stage takes time, because executives need to develop confidence in the ability of the project management methodology to work without the rigid controls provided by policies and procedures. All companies seem to go through the evolutionary stage of relying on policies and procedures before they advance to guidelines, forms, and checklists.

#### PROJECT MANAGEMENT METHODOLOGIES

The ultimate purpose of any project management system is to drastically increase the likelihood that your organization will have a continuous stream of successfully managed projects. The best way to achieve this goal is with the development of a project management methodology. Good project management methodologies are based upon guidelines and forms rather than policies and procedures. Methodologies must have enough flexibility such that they can be adapted easily to each and every project. There are consulting companies out there who have created their own methodologies and who will try to convince you that the solution to most of your project management problems can be resolved with the purchase of their (often expensive) methodology. The primary goal of these consulting companies is turning problems into gold: *your problems into their gold*!

One major hurdle that any company must overcome when developing or purchasing a project management methodology is the fact that a methodology is nothing more than a sheet of paper with instructions. To convert this sheet of paper into a successful methodology, the company must accept, support, and execute the methodology. If this is going to happen, the methodology should be designed to support the corporate culture, not vice versa. It is a fatal mistake to purchase a canned methodology package that mandates that you change your corporate culture to support it. If the methodology does not support the culture, the result will be a lack of acceptance of the methodology, sporadic use at best, inconsistent application of the methodology, poor morale, and perhaps even diminishing support for project management. What converts any methodology into a world-class methodology is its adaptability to the corporate culture.

There is no reason why organizations cannot develop their own methodologies. Companies such as Compaq Services, Ericsson, Nortel Networks, Johnson Controls, and Motorola are regarded as having world-class methodologies for project management and, in each case, the methodology was developed internally. The amount of time and effort needed to develop a methodology will vary from company to company, based upon such factors as the size and nature of the projects, the number of functional boundaries to be crossed, whether the organization is project-driven or non-project-driven, and competitive pressures.

#### CONTINUOUS IMPROVEMENT

All too often complacency directs the decision-making process. This is particularly true of organizations that have reached some degree of excellence in project management and become self-satisfied. They often realize only too late that they have lost their competitive advantage. This occurs when organizations fail to recognize the importance of continuous improvement.




FIGURE 9–6. The need for continuous improvement.

Figure 9-6 illustrates the need for continuous improvement. As companies

begin to mature in project management and reach some degree of excellence, they achieve a sustained competitive advantage. Achieving this edge might very well be the single most important strategic objective of the firm. Once the firm has this sustained competitive advantage, it will then begin to exploit it.




FIGURE 9–7. The need for continuous improvement.

Unfortunately, the competition will not be sitting by idly watching you exploit your sustained competitive advantage; they will begin to counterattack. When they do, you may lose a large portion, if not all, of your sustained competitive advantage. To remain effective and competitive, your organization must recognize the need for continuous improvement, as shown in Figure 9–7. Continuous improvement allows a firm to maintain its competitive advantage even when its competitors counterattack.

#### CAPACITY PLANNING

As companies become excellent in project management, the benefits of performing more work in less time and with fewer resources become readily apparent. The question, of course, is how much more work can the organization take on? Companies are now struggling to develop capacity planning models to see how much new work can be undertaken within the existing human and nonhuman constraints.




FIGURE 9-8. Capacity planning.

Figure 9–8 illustrates the classical way that companies perform capacity planning. The approach shown holds true for both project- and non–project-driven organizations. The "planning horizon" line indicates the point in time for capacity planning. The "proposals" line indicates the manpower needed for approved internal projects or a percentage (perhaps as much as 100 percent) for all work expected through competitive bidding. The combination of this line and the "manpower requirements" line, when compared against the current staffing, provides an indication of capacity. This planning technique can be effective if performed early enough such that training time is allowed for future manpower shortages.




FIGURE 9–9. Capacity planning.

There is an important limitation to the above process for capacity planning, however: only human resources are considered. A more realistic method would be to use the strategy shown in Figure 9–9, which can also be applied to both project-driven and non–project-driven organizations. Using the approach shown in Figure 9–9, projects are selected based upon such factors as strategic fit, profitability, consideration of who the customer is, and corporate benefits. The objectives for the projects selected are then defined in both business and technical terms, because there can be both business and technical capacity constraints.

The next step points up one critical difference between average companies and excellent companies. An excellent company will identify capacity constraints from the summation of the schedules and plans. Project managers will meet with project sponsors to determine the objective of the plan, which is different than the objective of the project. Is the objective of the plan to achieve the project's objective with the least cost, least time, or least risk? Typically, only one of these applies, whereas immature organizations believe that all three can be achieved on every project. This, of course, is unrealistic.

The final box in Figure 9–9 is now the determination of the capacity limitations. Previously, we considered only human resource capacity constraints. Now we realize that the critical path of a project can be constrained not only by available manpower but also by time, facilities, cash flow, and even technology. It is possible to have multiple critical paths on a project other than those identified by classical capacity planning. Each of these critical paths provides a different dimension to the capacity planning models, and each of these constraints can lead us to a different capacity limitation. As an example, manpower might limit us to taking on only four additional projects. Based upon available facilities, however, we might only be able to undertake two more projects, and based upon available technology, we might be able to undertake only one new project.

# COMPETENCY MODELS .

In the twenty-first century, companies will replace job descriptions with competency models. Job descriptions for project management tend to emphasize the deliverables and expectations from the project manager, whereas competency models emphasize the specific skills needed to achieve the deliverables.




FIGURE 9–10. Competency model for Eli Lilly.

Figure 9–10 shows the competency model for Eli Lilly. Project managers are expected to have competencies in three broad areas:\*


- Scientific/technical skills
- Leadership skills
- Process skills

For each of the three broad areas, there are subdivisions or grade levels. A primary advantage of a competency model is that it allows the training department to develop customized project management training programs to satisfy the skill requirements. Without competency models, most training programs are generic rather than customized. Also, competency models make it easier for organizations to develop a complete training curriculum, rather than a single course.

Competency models focus on specialized skills in order to assist project managers in making more efficient utilization of their time. Figure 9–11, although theoretical, shows how, with specialized competency training, project managers might be able to increase their time effectiveness by reducing time robbers and rework. Unfortunately, time robbers and rework cannot always be eliminated, but they can be reduced.




FIGURE 9–12. Competency models and training.

As stated above, competency models make it easier for companies to develop project management curricula, rather than simply single courses. This is shown in Figure 9–12. As companies mature in project management and develop a company-wide core competency model, an internal, custom-designed curriculum will be developed. Companies, especially large ones, will find it necessary to maintain a course architecture specialist on their staff.

# MANAGING MULTIPLE PROJECTS

As organizations begin to mature in project management, there is a tendency toward wanting to manage multiple projects. This might entail either the company's sponsoring the various projects, or each project manager's managing multiple projects. There are several factors supporting the managing of multiple projects.

First, the cost of maintaining a full-time project manager on all projects may be prohibitive. The magnitude and risks of the project dictate whether a full-time or part-time assignment is necessary. Assigning a project manager full-time on an activity that does not require it is an overmanagement cost. Overmanagement of projects was considered an acceptable practice in the early days of project management because we had little knowledge on how to handle risk management. Today, methods for risk management exist.

Second, line managers are now sharing accountability with project managers for the successful completion of projects. Project managers are now managing at the template levels of the work breakdown structure (WBS), with the line managers accepting accountability for the work packages at the detailed WBS levels. Project managers now spend more of their time integrating work rather than planning and scheduling functional activities. With the line manager accepting more accountability, time may be available for the project manager to manage multiple projects.

Third, senior management has come to the realization that they must provide high quality training for their project managers if they are to reap the benefits of managing multiple projects. Senior managers must also change the way that they function as sponsors. There are six major areas where the corporation as a whole may have to change in order for the managing of multiple projects to succeed:

- Prioritization: If a project prioritization system is in effect, it must be used correctly such that employee credibility in the system is realized. There are downside risks to a prioritization system. The project manager, having multiple projects to manage, may favor those projects having the highest priorities. It is possible that no prioritization system at all may be the best solution. Also, not every project needs to be prioritized. Prioritization can be a time-consuming effort.
- Scope changes: Managing multiple projects is almost impossible if the sponsors/customers are allowed to make continuous scope changes. When managing multiple projects, the project manager must understand that the majority of the scope changes desired may have to be performed through enhancement projects rather than through a continuous scope change effort on the original projects. A major scope change on one project could limit the project manager's available time to service other projects. Also, continuous scope changes will almost always be accompanied by reprioritization of projects, a further detriment to the management of multiple projects.
- Capacity planning: Organizations that support the management of multiple projects generally have a tight control on resource scheduling. As a precondition, these organizations must have knowledge of capacity planning, theory of constraints, resource leveling, and resource limited planning.
- Project methodology: Methodologies for project management range from rigid policies and procedures to more informal guidelines and

checklists. When managing multiple projects, the project manager must be granted some degree of freedom. This necessitates guidelines, checklists, and forms. Formal project management practices create excessive paperwork requirements, thus minimizing the opportunities to manage multiple projects. The project size is also critical.

- Project initiation: Managing multiple projects has been going on for almost 40 years. One thing that we have learned is that it can work well as long as the projects are in relatively different life cycle phases. The demands on the project manager's time are different from each life cycle phase. Therefore, for the project manager to effectively balance his/her time among multiple projects, it would be best for the sponsor not to have the projects begin at exactly the same time.
- Organizational structures: If the project manager is to manage multiple projects, then it is highly unlikely that the project manager will be a technical expert in all areas of all projects. Assuming that the accountability is shared with the line managers, the organization will most likely adopt a weak matrix structure.

# END-OF-PHASE REVIEW MEETINGS

For more than 20 years, end-of-phase review meetings were simply an opportunity for executives to "rubber-stamp" the project to continue on. The meetings were used to give the executives some degree of comfort concerning project status. Only good news was presented by the project team.

Executives, from a selfish point of view, very rarely cancelled projects. The executive was better off allowing the new product to be developed, even though the executive knew full well that the product would have no buyers or would be overpriced. Once the product was developed, the executive sponsor was "off the hook." The onus now rested on the shoulders of the marketing group to find potential customers. If customers could not be found, obviously the problem was with marketing.

Today, end-of-phase review meetings take on a different dimension. First and foremost, executives are no longer afraid to cancel projects, especially if the objectives have changed, the objectives are unreachable, or if the resources could be used on other activities that have a greater likelihood of success. Executives now spend more time assessing the risks in the future rather than focusing on accomplishments in the past.

Since project managers are now becoming more business-oriented, rather than technically oriented, they are expected to present information on business risks, reassessment of the benefit-to-cost ratio, and any business decisions that could affect the ultimate objectives. Simply stated, the end-of-phase review meetings now focus more on business decisions than on technical decisions.

#### STRATEGIC SELECTION OF PROJECTS

What a company wants to do is not always what it can do. The critical constraint is normally the availability and quality of the critical resources. Companies usually have an abundance of projects they would like to work on but, because of resource limitations, they have to develop a prioritization system for the selection of projects.




FIGURE 9–13. Portfolio classification matrix.




FIGURE 9–14. Potential benefits of a project.

One commonly used selection process is the portfolio classification matrix shown in Figure 9–13. Each potential project undergoes a situational assessment for strengths, weaknesses, opportunities, and threats. The project is then ranked on the nine-square grid, based upon its potential benefits and the quality of resources needed to achieve those benefits. The characteristics of the benefits appear in Figure 9–14, and the characteristics of the resources needed are shown in Figure 9–15.

This classification technique allows for proper selection of projects, as well as providing the organization with the foundation for a capacity planning model to see how much work the organization can take on. Companies usually have little trouble figuring out where to assign the highly talented people. The model, however, provides guidance on how to make the most effective utilization of the average and below average individuals as well.




FIGURE 9–16. Strategic importance of projects.

The boxes in the nine-square grid of Figure 9–13 can then be prioritized according to strategic importance, as shown in Figure 9–16. If resources are limited but funding is adequate, the boxes identified as "high priority" will be addressed first.




FIGURE 9–17. Strategic guide to allocating project resources.

The nine-square grid in Figure 9–16 can also be used to identify the quality of the project management skills needed, in addition to the quality of functional employees. This is shown in Figure 9–17. As an example, the project managers with the best overall skills will be assigned to those projects that are needed to protect the firm's current position. Each of the nine cells in Figure 9–17 can be described as follows:

- Protect position (high benefits and high quality of resources): These projects may be regarded as the survival of the firm. These projects mandate professional project management, possibly certified project managers, and the organization considers project management as a career path posi-
  - Knowledge of Business
  - Manpower
  - Facilities, Equipment, Machinery
  - Proprietary Knowledge
  - Special Expertise
  - Reputation
  - Relationship with Key Stakeholders
  - Project Management Skills
  - Money



FIGURE 9–15. Characteristics of the resources needed to achieve a project's benefits.

tion. Continuous improvement in project management is essential to make sure that the methodology is the best it can be.

• Protect position (high benefits and medium quality of resources): Projects in this category may require a full-time project manager, but not necessarily a certified one. An enhanced project management methodol-

ogy is needed with emphasis on reinforcing vulnerable areas of project management.

- Protect position (medium benefits and high quality of resources): Emphasis in these projects is on training project managers, with special attention to their leadership skills. The types of projects here are usually efforts to add customer value rather than to develop new products.
- Line management project management (high benefits and low quality of resources): These projects are usually process improvement efforts to support repetitive production. Minimum integration across functional lines is necessary, which allows line managers to function as project managers. These projects are characterized by short time frames.
- Build selectively (medium benefits and medium quality of resources): These projects are specialized, perhaps repetitive, and focus on a specific area of the business. Limited project management strengths are needed. Risk management may be needed, especially technical risk management.
- Team leaders (low benefits but high quality of resources): These are normally small, short-term R&D projects that require strong technical skills. Since minimal integration is required, scientists and technical experts will function as team leaders. Minimal knowledge of project management is needed.
- Part-time project management (medium benefits and low quality of resources): These are small capital projects that require only an introductory knowledge of project management. One project manager could end up managing multiple small projects.
- Part-time project management (low benefits and medium quality of resources): These are internal projects or very small capital projects. These projects have small budgets and perhaps a low to moderate risk.
- Part-time project management (low benefits and low quality of resources): These projects are usually planned by line managers but executed by project coordinators or project expediters.

# PORTFOLIO SELECTION OF PROJECTS \_

Companies that are project-driven organizations must be careful about the type and quantity of projects they work on because of the constraints on available resources. Because timing is often critical, it is not always possible to hire new employees and have them trained quickly enough, or to hire subcontractors, whose skills may well be questionable anyway.




FIGURE 9-18. Basic portfolio.

Figure 9-18 shows a typical project portfolio.\* Each circle represents a pro-

ject. The location of each circle represents the quality of resources needed and the life cycle phase that the project is in. The size of the circle represents the magnitude of the achievable benefits, relative to those of other projects, and the "pie wedge" represents the percentage of the project completed thus far.

In Figure 9–18, Project A has relatively low benefits and uses medium quality of resources. Project A is in the definition phase. However, when Project A moves into the design phase, the quality of resources may change to low or high quality. Therefore, this type of chart has to be updated frequently.

Figures 9–19, 9–20, and 9–21 show three different types of portfolios. Figure 9–19 represents a high-risk project portfolio where high-quality resources are required on each project. This may be representative of a project-driven organization that has been awarded several highly profitable, large projects. This could also be a company that competes in the computer field, an industry that has short product life cycles and where product obsolescence occurs only six months downstream.

Figure 9–20 represents a conservative, profit-oriented project portfolio, say that of an organization that works mainly on low risk projects that require low-quality resources. This could be representation of project portfolio selection in a service organization, or even a manufacturing firm that has projects designed mostly for product enhancement.




FIGURE 9–19. Typical high-risk project portfolio.




FIGURE 9–20. Typical conservative, profit-oriented project portfolio.





FIGURE 9-21. Typical balanced project portfolio.

Figure 9–21 shows a balanced portfolio with projects in each life cycle phase and where all quality of resources is being utilized, usually quite effectively. A very delicate juggling act is required to maintain this balance.

## HORIZONTAL ACCOUNTING

In the early days of project management, project management was synonymous with scheduling. Project planning meant simply laying out a schedule with very little regard for costs. After all, we know that costs will change (i.e., most likely increase) over the life of the project and that the final cost will never resemble the original budget. Therefore, why worry about cost control?

Recessions and poor economic times have put pressure on the average company to achieve better cost control. Historically, costs were measured on a vertical basis only. This created a problem in that project managers had no knowledge of how many hours were actually being expended in the functional areas to perform the assigned project activities. Standards were very rarely updated and, if they were, it was usually without the project manager's knowledge.

Today, methodologies for project management mandate horizontal accounting using earned value measurement techniques. This is extremely important, especially if the project manager has the responsibility for profit and loss. Projects are now controlled through a series of charge numbers or cost account codes assigned to all of the work packages in the WBS.

Strategic planning for cost control on projects is a three-phase effort, as shown in Figures 9-22 through 9-24. The three phases are:

- Phase I—Budget-based planning (Figure 9–22): This is the development of a project's baseline budget and cash flow based upon reasonably accurate historical data. The historical databases are updated at the end of each project.





FIGURE 9–23. The evolution of integrated cost-schedule management. Phase II—Cost/performance determination.

- Phase II—Cost/performance determination (Figure 9–23): This is where the costs are determined for each work package and where the actual costs are compared against the actual performance in order to determine the true project status.
- Phase III—Updating and reporting (Figure 9–24): This is the preparation of the necessary reports for the project team members, line managers, sponsors, and customer. At a minimum, these reports should address the questions of:
  - Where are we today (time and cost)?
  - Where will we end up (time and cost)?
  - What problems do we have now and will we have in the future, and what mitigation strategies have we come up with?

Good methodologies provide the framework for gathering the information to answer these questions.

# **ORGANIZATIONAL RESTRUCTURING**,

Effective project management cultures are based on trust, communication, cooperation, and teamwork. When the basis of project management is strong, organizational structure becomes almost irrelevant. Restructuring an organization only to add project management is unnecessary and perhaps even dangerous. Companies may need to be restructured for other reasons, such as making the customer more important. But successful project management can live within any structure, no matter how awful the structure looks on paper, just as long as the culture of the company promotes teamwork, cooperation, trust, and effective communication.

The organizations of companies excellent in project management can take almost any form. Today, small- to medium-size companies sometimes restructure to pool management resources. Large companies tend to focus on the strategic business unit as the foundation of their structures. Many companies still follow matrix management. Any structure can work with project management as long as it has the following traits:

- The company is organized around nondedicated project teams.
- It has a flat organizational hierarchy.
- It practices informal project management.
- It does not consider the reporting level of project managers to be important.

The first point listed above may be somewhat controversial. Dedicated project teams have been a fact of life since the late 1980s. Although there have been many positive results from dedicated teams, there has also been a tremendous waste of manpower coupled with duplication of equipment, facilities, and technologies. Today, most experienced organizations believe that they are scheduling resources effectively so that multiple projects can make use of scarce resources at the same time. And, they believe, nondedicated project teams can be just as creative as dedicated teams, and perhaps at a lower cost.

Although tall organizational structures with multiple layers of management were the rule when project management came on the scene in the early 1960s, today's organizations tend to be lean and mean, with fewer layers of management than ever. The span of control has been widened, and the results of that change have been mass confusion in some companies but complete success in others. The simple fact is that flat organizations work better. They are characterized by better internal communication, greater cooperation among employees and managers, and atmospheres of trust.

In addition, today's project management organizations, with only a few exceptions (purely project-driven companies), prefer to use informal project management. With formal project management systems, the authority and power of project managers must be documented in writing. Formal project management policies and procedures are required. And documentation is required on the simplest tasks. By contrast, in informal systems, paperwork is minimized. In the future, I believe that even totally project-driven organizations will develop more informal systems.

The reporting level for project managers has fluctuated between top-level and lower-level managers. As a result, some line managers have felt alienated over authority and power disagreements with project managers. In the most successful organizations, the reporting level has stabilized, and project managers and line managers today report at about the same level. Project management simply works better when the managers involved view each other as peers. In large projects, however, project managers may report higher up, sometimes to the executive level. For such projects, a project office is usually set up for project team members at the same level as the line managers with whom they interact daily.

To sum it all up, effective cross-functional communication, cooperation, and trust are bound to generate organizational stability. Let's hope that organizational restructuring on the scale we've seen in recent years will no longer be necessary.

#### CAREER PLANNING \_\_\_\_\_

In organizations that successfully manage their projects, project managers are considered professionals and have distinct job descriptions. Employees traditionally are allowed to climb one of two career ladders: the management ladder or the technical ladder. (They cannot, however, jump back and forth between the two.) This presents a problem to project managers, whose responsibilities bridge the two ladders. To solve this problem, some organizations have created a third ladder, one that fills the gap between technology and management. It is a project management ladder, with the same opportunities for advancement as the other two.


# EXPLANATION OF POINTS FOR LEVEL 5

Scores 20 or more are indicative of an organization committed to benchmarking and continuous improvement. These companies are probably leaders in their field. These companies will always possess more project management knowledge than both their customers and their competitors.

Scores between 10–19 are indicative that some forms of continuous improvement are taking place, but the changes may be occurring slowly. There may be resistance to some of the changes, most likely because of shifts in the power and authority spectrum.

Scores less than 9 imply a strong resistance to change or simply a lack of senior management support for continuous improvement. This most likely occurs in low technology, non–project-driven organizations where projects do not necessarily have a well-defined profit-loss statement. These organizations will eventually change only after pressure by their customers or an erosion of their business base.

## INTRODUCTION

To spend time and money developing a project management methodology because you believe it is the right thing to do is a wasted effort. The better approach is to develop a methodology with the intent of converting it into a sustainable competitive advantage. A sustainable competitive advantage not only placates your customers, it also puts pressure on your competitors to spend money to compete with you.





FIGURE 10–1. R&D Efforts for a sustained competitive advantage. *Source:* Reprinted from P. Rea and H. Kerzner, *Strategic Planning.* New York: Wiley, 1997, p. 105.

Sustainable competitive advantages can be determined for individual functional areas rather than for the entire company. As an example, consider Figure 10–1, which illustrates the efforts needed to achieve a sustained competitive advantage in research and development (R&D). As a company advances through the various stages of innovation, the technical risks will increase. The organization must have developed a good approach to the problem of assessing technical risks and must be willing to admit when a project should be cancelled because the resources could be allocated more effectively on other projects. Maintaining a competitive advantage requires a continuous stream of new and/or enhanced products or services. Risk management is an essential ingredient in the evaluation process.

As technical risks increase, so does the amount of money expended, as well as the requirement for superior technical ability. The technical skills required increase as we go from basic to applied research and on through development. Although some people may argue about the need for this increase in skill levels, the fact remains that a product that can be developed on a small laboratory bench may never be able to be mass-produced or, even if it can be mass-produced, the

quality may have to be degraded. Also, it is in development where one finally obtains the hard numbers as to whether the product can be manufactured at a competitive price.

# STRATEGIC THRUSTS ,

As shown in Figure 10–2, there are four "strategic thrusts" that must be considered before your project management methodology can be turned into a sustained competitive advantage. These strategic thrusts must be identified while the methodology is being designed and developed, not later on. Developing a methodology and then having to make major changes to it because the strategic thrusts were not considered can waste time and money, as well as lowering morale. Poor morale can cause the workers to lose faith in the methodology.



The first strategic thrust is the core values/purpose. The core values/purpose thrust describes the heart of the company, as well as the basic reason for its existence.

- Core values: There are usually three to five core values for a company, the timeless, passionately held guiding principles of the organization. At Procter & Gamble, for example, the core values are delivering consumer value, developing breakthrough innovation, and building strong brands. The core values for the Walt Disney Company might be imagination and wholesomeness, while at Nordstrom they could be service to the customer, trust, and products with style. Core values come from within the organization; they represent what the organization is at its very essence, as opposed to what it does from day to day.
- The core purpose: An organization's core purpose should last for at least 100 years; it is the organization's reason for being that goes beyond current products and services. For 3M, the core purpose is "to solve unsolved problems innovatively." For Hewlett-Packard, it is "to make technical contributions for the advancement and welfare of humanity." For McKinsey & Company, it is "to help leading corporations and govern-

ments to be more successful." For Merck it is "to preserve and improve human life." And for the Walt Disney Company it is "to make people happy." One approach to finding a core purpose is to ask five whys. Start with a description of the business and ask, "Why is that important?" five times; after a few whys you get to the very essence of the business.\*

Generally speaking, all projects undertaken using the project management methodology must support the company's core values/purpose, which could very well be regarded as the most important strategic thrust.

The second strategic thrust in Figure 10–2 is the strategic focus. The strategic focus identifies the product/market element in which the organization competes. There are three primary questions that must be addressed in the strategic focus:

- Where will the organization compete? (What products are offered, which markets are served, by segment or geographically?)
- Against whom will the organization compete? (Who is the competition?)
- How will the organization compete? (By product, by proper positioning, by functional strategy as channels of distribution, etc.?)

The answers to these three questions provide guidance on the quality and competencies of the resources and assets needed. Project management methodologies *must* be designed around the competencies of the resources.

The third strategic thrust is the competitive focus. Although this thrust has some similarities to the strategic focus thrust, there are other overriding factors. The competitive focus emphasizes the differences between your organization and your major competitors. The differences can exist in such areas as:

- Product features
- Product design
- Product performance
- Product quality
- Products offered
- Value-added opportunities
- Brand name and image
- Cost reduction opportunities (i.e., experience curves, labor rates)
- Strategic alliances and partnerships

These strategic competitive differences can give your methodology one step up on the competition.




FIGURE 10-3. Risks associated with maintaining a sustainable competitive advantage.

The final strategic thrust in Figure 10–2 is synergy. Synergy reflects the organization's ability to perform more work in less time and with fewer resources. Organizational synergy is a measure of how well the employees cooperate with one another. Does the organization have a cooperative or noncooperative culture? Cooperative cultures allow for the design of a flexible methodology that will take advantage of continuous improvement opportunities.

Because market conditions and the environment can change, continuous improvement is necessary to maintain the sustained competitive advantage. Change generates risk that, if not properly analyzed and mitigated, can cause a firm to lose its competitive advantage. The key here is for the competitive advantage to become a sustainable competitive advantage. Typical risks associated with maintaining a sustainable advantage are shown in Figure 10–3.

### THE NEED FOR CONTINUOUS IMPROVEMENT

Sustained competitive advantages require continuous improvement for a firm to maintain its strength in the marketplace. Although new products/services are one way, strengthening one's internal position can also effective if it results in the in-

troduction of new and/or more sophisticated tools that allow a firm to make faster and better decisions. Tools for the future can be classified as follows:

#### Resource Analysis Tools

- Resource limited planning
- Resource leveling
- Capacity planning
- Multiproject resource analysis

### Cost Analysis Tools

- Earned value forecasting
- Variance analysis
- Trend analysis
- Crashing costs

### Risk Analysis Tools

- Risk analysis
- Risk quantification
- Lessons learned databases

#### Forecasting Analysis Tools

- Technology forecasting
- Forward pricing rates
- Escalation factors
- Market analysis

## PROJECT MANAGEMENT COMPETITIVENESS




FIGURE 10-4. Project management competitiveness.

Figure 10–4 shows the process of developing project management competitiveness. These steps are somewhat similar to the steps in the project management maturity model (PMMM). In the first step in Figure 10–4, the organization undergoes project management training, which leads to the development of project management skills. But even with a reasonable skill base, the organization can still be reasonably immature. The project management skill base must be regarded as a company-wide project management competency designed to benefit the entire company.

This is more than simply obtaining the knowledge. It also includes developing a corporate culture that is based upon effective organizational behavior and creating a well-developed project management methodology, accompanied by the proper supporting tools. The tools can be characterized into three areas, as shown in Figure 10–4.

Once the organization recognizes that project management is a core competency, the organization can convert this competency into a sustainable competitive advantage, as shown in Figure 10–4. The ultimate purpose is for the sustainable competitive advantage to become the pathway for a strategic competency that becomes a primary effort during strategic planning activities. This requires strong executive support and a firm belief that project management does, in fact, impact the bottom line of the corporation.

#### IINTRODUCTION

Even with strategic planning for project management, special problems can always occur, problems that end up creating difficulties for both the project manager and the organization. Not all situations can be anticipated, of course, but some that might have been anticipated, are often simply not considered. Some problems exist purely because of misconceptions.

Perhaps the most common misconception arises when the company believes that the implementation of a singular methodology is a cure-all for all ailments. Project management is *not* a guarantee of success, but it can drastically improve your chances for success.

The remaining sections in this chapter contain special problems and misconceptions that have recently occurred even in the best-managed companies and also in those companies with world-class methodologies for project management. If the project achieves only 86 percent of the targeted specification, is the project a failure? If the project is canceled because we were researching in the wrong area, is this a success or a failure? If the customer's deliverable was not achieved but the customer was delighted with the working relationship, is the project a success or a failure? Companies today are redefining the meanings of success and failure.

Change management is another topic that must be considered, especially if strategic planning for project management requires people to change they way they had worked for the past several years. Change management is now a top priority for companies that wish to accelerate the project management learning curve. And finally, although this book is not intended to be a course on risk management, several risk management problems are now surfacing that affect the way we perform strategic planning for project management and impact on how we design a singular methodology. Proper design of a singular methodology for project management can simplify the way risk management planning is accomplished, and even encourage the project managers to increase their personal tolerance level for risk.

## THE MANY FACES OF SUCCESS

Historically, success has been defined as meeting the customer's expectations, regardless of whether "the customer" was internal or external. Furthermore, success has also meant getting the job done within the constraints of time, cost, and quality. Using this standard definition, success could be visualized as a singular point on a time, cost, quality/performance grid. But how many projects, especially those requiring innovation, can possibly reach this exact point?




FIGURE 11-1. Success: point or cube?

Very few project are ever completed without tradeoffs or scope changes on time, cost, and quality. Therefore, success might still occur without exactly hitting this singular point. In this regard, success might be better defined as a cube, such as seen in Figure 11–1. The singular point of time, cost, and quality would be a point within the cube.

Another factor to consider is that there may exist both primary and secondary definitions of success, as shown in Table 11–1. The primary definitions of success

are seen through the eyes of the customer. The secondary definitions of success are usually internal benefits. If achieving 86 percent of the specification is acceptable to the customer and follow-on work is received, then the original project might very well be considered as a success.

It is possible for a project management methodology to identify primary and secondary success factors. This could provide guidance to a project manager for the development of a risk management plan, as well as help the project manager decide which risks are worth taking and which are not acceptable.

## THE MANY FACES OF FAILURE\* \_

Previously we stated that success might be a cube rather than a point. If we stay within the cube but miss the point, is that a failure? Probably not! The true definition of failure is when the final results are not what were expected, even though the original expectations may or may not have been reasonable. Sometimes customers, and even internal executives, set performance targets that are totally unrealistic, they may hope to achieve 80 to 90 percent at best. For simplicity's sake, let us define failure as unmet expectations.

When unmeetable expectations are formed, failure is virtually assured, since we have defined failure as unmet expectations. This is called a *planning failure* and is the difference between what was planned to be accomplished and what was, in fact, achievable. The second component of failure is poor performance or

*actual failure*. This is the difference between what was achievable and what was actually accomplished.




FIGURE 11-2. Components of failure.




FIGURE 11–3. Components of failure.

*Perceived failure* is the net sum of *actual failure* and *planning failure*. Figures 11–2 and 11–3 illustrate the components of perceived failure. In Figure 11-2, *project management* has planned a level of accomplishment (C) lower than what is achievable given project circumstances and resources (D). This is a classic underplanning situation. Actual accomplishment (B), however, was even less than planned.

A slightly different case is illustrated in Figure 11–3. Here, management has planned to accomplish more than can be achieved. Planning failure is again assured even if no actual failure occurs. In both of these situations (overplanning and underplanning), the actual failure is the same, but the perceived failure can vary considerably.

Today, most project management practitioners focus on *planning failure*. If this aspect of the project can be compressed, or even eliminated, then the magnitude of the actual failure, should it occur, would be diminished. A good project management methodology helps to reduce planning failure. Today, we believe that planning failure, when it occurs, is due in large part to the project manager's inability to perform effective risk management. In the 1980s, we believed that the failure of a project was largely a quantitative failure due to:

- Ineffective planning
- Ineffective scheduling
- Ineffective estimating
- Ineffective cost control
- Project objectives being a "moving target"

During the 1990s, we changed our view of failure from being quantitatively oriented to qualitatively oriented. A failure in the 1990s was largely attributed to:

- Poor morale
- Poor motivation
- Poor human relations
- Poor productivity
- No employee commitment
- No functional commitment
- Delays in problem solving
- Too many unresolved policy issues
- Conflicting priorities between executives, line managers, and project managers

Although these quantitative and qualitative approaches still hold true to some degree, today we believe that the major component of planning failure is inappropriate or inadequate risk management, or having a project management methodology that does not provide any guidance for risk management.




FIGURE 11-4. Risk planning.

Sometimes, the risk management component of failure is not readily identified. For example, look at Figure 11–4. The actual performance delivered by the contractor was significantly less than the customer's expectations. Is the difference between these two arrows poor technical ability or a combination of technical inability and poor risk management? Today we believe that it is a combination.




FIGURE 11–5. Mitigation strategies available.

When a project reaches completion, the company performs a lessons learned review (or at least a well-managed company does). Sometimes lessons learned are inappropriately labeled and thus the true reason for the risk event remains unknown. Figure 11–5 illustrates the relationship between the marketing personnel and technical personnel when undertaking a project to develop a new product. If the project is completed with actual performance being less than customer expectations, is it because of poor risk management by the technical assessment and

forecasting personnel or poor marketing risk assessment? The interrelationship between marketing and technical risk management is not always clear.

Another point illustrated in Figure 11–5 is that opportunities for tradeoffs diminish as we get further downstream on the project. There are numerous opportunities for tradeoffs prior to establishing the final objectives for the project, but more limited chances during project execution. Thus if the project fails, it may very well be because of the timing when the risks were analyzed.

Care must be taken that the proper identification of failure is made and that the company knows to which functional areas the lessons learned should be applied.

### TRAINING AND EDUCATION .

Given the fact that most companies use the same basic tools as part of their methodology, what then makes one company better than another? The answer lies in the execution of the methodology. Training and education can accelerate not only the project management maturity process but also the ability to execute the methodology.




FIGURE 11-6. Project management learning curve.




FIGURE 11–7. Project management learning curve.

Actual learning takes place in three areas, as shown in Figure 11–6: on-thejob experience, education, and knowledge transfer. Ideal project management knowledge would be obtained by allowing each employee to be educated on the results of the company's lessons learned studies including risk management, benchmarking, and continuous improvement efforts. Unfortunately, this is rarely done and ideal learning is hardly ever reached. To make matters worse, actual learning is less than most people believe because of lost knowledge. This lost knowledge is shown in Figure 11–7 and will occur even in companies that maintain low employee turnover ratios.

# CHANGE MANAGEMENT




FIGURE 11–8. Methodology imputs.

It has often been said that the most difficult projects to manage are those that involve the management of change. Figure 11–8 shows the four basic inputs needed to develop a project management methodology. Each of these four inputs has a "human" side that may require that people change.

Successful development and implementation of a project management methodology requires:

- Identification of the most common reasons for change in project management and why these reasons occur.
- Identification of the ways to overcome the resistance to change.
- Application of the principles of change management to ensure that the desired project management environment will be created and sustained.




FIGURE 11–9. Resistance to change.

For simplicity's sake, resistance can be classified as departmental resistance and personal resistance to change. Organizational resistance occurs when a functional unit as a whole feels threatened by project management. This is shown in Figure 11–9. Examples include:

• Sales: The sales staff's greatest resistance to change arises from fear that project management will now take credit for corporate profits, thus reducing the year-end bonuses for the salesforce. Sales personnel fear that

project managers may become involved in the sales effort, thus diminishing the power of the salesforce.

- **Marketing:** Marketing people fear that project managers will end up working so closely with the customers that they may eventually be given some of the marketing and sales functions. This fear is not without merit because customers often want to communicate with the personnel managing the project rather than with marketing staff, who may well disappear after the closure of the sale.
- Finance (and accounting): These departments fear that project management will require the development of a project accounting system (such as earned value measurement), which, in turn, will increase the workload in accounting and finance. Accounting personnel are not happy with having to learn earned value measurement, and having to perform accounting both horizontally (i.e., in projects) and vertically (i.e., in line groups).
- **Procurement:** The fear among this group is that a project procurement system will be implemented in parallel with the corporate procurement system, and that the project managers will perform their own procurement, thus bypassing the procurement department.
- Human resources management: The H. R. department may fear that a project management career path ladder will be created, not to mention a need for project management training programs. Human resources personnel may find that their traditional training courses, with which they feel very comfortable, have to undergo major change to satisfy project management requirements. This will increase their workloads.
- **Manufacturing:** Little resistance is usually found here because, although the manufacturing segment of a company is not project-driven, staff there are usually familiar with numerous capital installation and maintenance projects, which will have required the use of project management.
- Engineering, R&D, and Information Technology: These departments are almost entirely project-driven with very little resistance to project management. Project management is viewed as a necessity.

Getting the support of and partnership with functional management in the involved departments can usually overcome the resistance that exists on an organi-

zational level. However, the resistance that may occur on an individual level is usually more complex and more difficult to overcome. Individual resistance levels may result from:

- Potential changes in work habits
- Potential changes in the social groups
- Embedded fears
- Potential changes in the wage and salary administration program

Tables 11–2 through 11–5 show how these different issues can lead to resistance, and list possible solutions. It is imperative that we understand the resistance to change. If individuals are happy with their current environment, there will always be resistance to change. But even if people are unhappy with their present environment, there will still exist resistance to change unless: (1) people believe that the change is possible, and (2) people believe that they will somehow benefit from the change. People are usually apprehensive over what they must give up rather than excited about what they will get in return. Not all people will be at the same readiness level for change even if the entire organization is going through the change. People will handle only so much change at one time and, if management eases up on its pressure for change, employees will revert back to their old ways.

Management is the architect for the change process. Management must develop the appropriate strategies such that the organization can align itself with change. This is best done by developing a shared understanding with the employees expected to make the change.

• Multiple-boss reporting

Performing the following can facilitate the change process:

- Management must explain to the employees the reasons for the change and solicit feedback.
- Management must explain to the employees what outcomes are desired and why.
- Management must champion the change process.
- Management must empower the appropriate individuals to institutionalize the changes.
- Management must be willing to invest in training necessary to support the changes.

#### PARTNERSHIPS .

A partnership is a group of two or more individuals or groups working together to achieve a common objective. Historically, partnerships were often between companies working together rather than between individuals. In project management, the critical partnership is the working relationship between the project and line managers.




FIGURE 11–10. Partnership strength.

In the early days of project management, the selection of the individual to serve as the project manager was most often dependent upon who possessed the greatest command of technology. The ultimate result, as shown in Figure 11–10, was a very poor working relationship between the project and line managers. Line managers viewed project managers as a threat, and their relationship developed into a competitive, superior-subordinate relationship. The most common form of organizational structure was a strong matrix where the project manager, perceived as having a command of technology, had a greater influence over the assigned employees than did their line manager.

As the magnitude and technical complexity of the projects grew, it became obvious that the project managers could not maintain a command of technology in all aspects of the project. Now, project managers were viewed as possessing an understanding of rather than command of technology. Project managers were now becoming more dependent upon line managers for technical support. The project man-

ager now finds himself or herself in the midst of a weak matrix where the employees are receiving the majority of their technical direction from the line managers.

As the partnership between the project and line managers begins to develop, management recognizes that partnerships work best on a peer-to-peer basis, rather than on a superior-to-subordinate basis. Now the project and line managers view each other as equals and share in the authority, responsibility, and accountability needed to assure project success.

Good project management methodologies emphasize the cooperative working relationship that must exist between the project and line managers. Conflict resolution channels may be clearly spelled out as part of the methodology, and which manager has the final decision in specific areas of knowledge may be specified.

#### THE IMPACT OF RISK CONTROL MEASURES

Most project management methodologies today have sections on risk management. The project management methodology may very well dictate the magnitude of the risk control measures to be undertaken. The risk control measures for risk assumption may be significantly more complex than risk control measures for avoidance.




FIGURE 11–11. Risk control measures.

Figure 11–11 shows the intensity of the controls versus the intensity of the risks. As the intensity of the risks increase, we tend to place more controls in the risk management process and the project management methodology. Care must

be taken that the cost of maintaining these control measures does not overly burden the project. Time and money are required for effective risk management. Excessive controls may require that the project manager spend more time performing risk management rather than actually managing the project.




FIGURE 11–12. Risk controls.

How to determine the proper amount of risk control measures is not easy. This can be seen from Figure 11–12, which illustrates the impact on the schedule

constraint. If not enough control measures are in place, or if there simply is no risk management plan, the result may be an elongated schedule due to ineffective risk control measures. If excessive risk control measures are in place, such as too many filters and gates, the schedule can likewise be elongated because the workers are spending too much time on contingency planning, risk reporting, documentation, and risk management meetings (i.e., there may be too many gates). This results in very slow progress being made. A proper balance is needed.

# DEPENDENCIES BETWEEN RISKS

If project managers had unlimited funding they could always identify a multitude of risk events. Some of the risk impacts may be insignificant, whereas others may expose the project to severe danger. With a large number of possible risk events, it is impossible to address each and every situation. It may be necessary to prioritize risks.




FIGURE 11–14. Ordering of tradeoffs.

Assume that the project manager categorizes the risks according to the project's time, cost, and performance constraints, as illustrated in Figure 11–13. According to the figure, the project manager should focus his/her efforts on reducing the scheduling risks first. The prioritization of risks could be established by the project manager, by the project sponsor, or even by the customer. The prioritization of risks can also be industry- or even country-specific, as shown in Figure 11–14. It is highly unlikely that any project management methodology would dictate the prioritization of risks. It is simply impossible to develop stan-

FIGURE 11–13. Prioritization of risks.

dardization in this area such that the application could be uniformly applied to each and every project.

The prioritization of risks for an individual project is a good starting point and could work well if it were not for the fact that most risks are interrelated. We know from tradeoff analysis that changes to a schedule can, and probably will, induce changes in cost and performance. Therefore, even though schedules have the highest priority in Figure 11–13, risk response to the schedule risk events may cause immediate evaluation of the technical performance risk events. Risks are interrelated.

The interdependencies between risks can also be seen from Table 11–6. The first column identifies certain actions that the project manager can opt for to take advantage of the opportunities in column 2. Each of these opportunities, in turn, can cause additional risks, as shown in column 3. In other words, risk mitigation strategies that are designed to take advantage of an opportunity could create another risk event that is more severe. As an example, working overtime could save you \$15,000 by compressing the schedule. But if the employees make more mistakes on overtime, retesting may be required, additional materials may need to be purchased, and a schedule slippage could well occur, thus causing a loss of \$100,000. Therefore, is it worth risking a loss of \$100,000 to save \$15,000?

To answer this question, we can use the concept of expected value, assuming we can determine the probabilities associated with mistakes being made and the cost of the mistakes. Without any knowledge of these probabilities, the actions taken to achieve the opportunities would be dependent upon the project manager's tolerance for risk.

Most project management professionals seem to agree that the most serious risks, and the ones about which we seem to know the least, are the technical risks.

The worst situation is to have multiple technical risks that interact in an unpredictable or unknown manner.




FIGURE 11–15. Interacting risks.

As an example, assume you are managing a new product development project. Marketing has provided you with two technical characteristics that would make the product highly desirable in the marketplace. The exact relationship between these two characteristics is unknown. However, your technical subject matter experts have prepared the curve shown in Figure 11–15. According to the curve, the two characteristics may end up moving in opposite directions. In other words, maximizing one characteristic may require degradation in the second characteristic.

Working with marketing, you prepare the specification limits according to characteristic B in Figure 11–15. Because these characteristics interact in often un-

known ways, the specification limit on characteristic B may force characteristic A into a region that would make the product less desirable to the ultimate consumer.

Although project management methodologies provide a framework for risk management and the development of a risk management plan, it is highly unlikely that any methodology would be sophisticated enough to account for the identification of technical dependency risks. The time and cost associated with the identification, quantification, and handling of technical risk dependencies could severely tax the project financially.

Another critical interdependency is the relationship between change management and risk management, both of which are part of the singular project management methodology. Each risk management strategy can results in changes that generate additional risks. Risks and changes go hand in hand, which is one of the reasons companies usually integrate risk management and change management together into a singular methodology. Table 11–7 shows the relationship between managed and unmanaged changes. If changes are unmanaged, then more time and money is needed to perform risk management. And what makes the situation even worse is that higher salaried employees and additional time is required to assess the additional risks resulting from unmanaged changes. Managed changes, on the other hand, allows for a lower cost risk management plan to be developed.

Project management methodologies, no matter how good, cannot accurately define the dependencies between risks. It is usually the responsibility of the project team to make these determinations.

# SELECTING THE APPROPRIATE RESPONSE MECHANISM

There exist four widely accepted risk response methods; assumption, reduction, transfer, and avoidance. Historically, most practitioners argue that the risk re-

sponse method selected is heavily biased toward the magnitude of the risk and the project manager's tolerance level for risk. While this may still be true, there are other factors that influence the risk response method selected, and many of these can be included as part of the project management methodology.




FIGURE 11–16. The risk-reward matrix.

The potential rewards of selecting the appropriate risk response can influence the selection process. Figure 11-6 shows the risk-reward matrix. What is important to recognize in Figure 11-16 is that the risk-reward matrix is actually threedimensional, with the third axis being the quality of resources required. Certain risk response actions, such as assumption or reduction, require that resources be consumed. The quality and availability of the resources required can influence the risk response selection process irrespective of the potential rewards. For example, if a company adopts a risk assumption approach on an R&D project, the rewards could be huge if patents are issued and licensing agreements follow. But this is predicated upon available, qualified resources. Without the appropriate available resources, the only response mechanisms remaining might be risk avoidance or risk transfer.




FIGURE 11–17. Which method to use?

A second factor influencing the risk response method selected is the procedural documentation requirements of the project management methodology. This appears in Figure 11-17. Project management methodologies that are based on policies and procedures are very rigid. Most good methodologies today are based upon guidelines that provide the project manager with significantly more flexibility in decision-making.

This flexibility (i.e., use of guidelines) can affect the risk response method selected. Although no empirical data exists as yet to support this, there appears a

tendency for project managers to accept higher levels of risk if the project manager is given more freedom in decision-making. On the other hand, the rigidity of policies and procedures generally allows for lower levels of risk acceptance and project managers seem to prefer avoidance. As risk management grows, more research will be expected in this area.

# CONCLUSIONS .

General strategic planning is never accomplished only once. It must be reexamined over and over again as requirements change and new information appears. The same holds true for strategic planning for project management. As more and more of these problem areas are identified internally from lessons learned files and externally in published articles, some of these often overlooked problems will be corrected.

# Case 1 \_\_\_\_\_ Packer Telecom

### Background

The rapid growth of the telecom industry made it apparent to Packer's executives that risk management must be performed on all development projects. If Packer were late in the introduction of a new product, then market share would be lost. Furthermore, Packer could lose valuable opportunities to "partner" with other companies if Packer were regarded as being behind the learning curve with regard to new product development.

Another problem facing Packer was the amount of money being committed to R&D. Typical companies spend 8 to 10 percent of earnings on R&D, whereas in the telecom industry, the number may be as high as 15 to 18 percent. Packer was spending 20 percent on R&D, and only a small percentage of the projects that started out in the conceptual phase ever reached the commercialization phase, where Packer could expect to recover its R&D costs. Management attributed the problem to a lack of effective risk management.

### The Meeting

*PM:* I have spent a great deal of time trying to benchmark best practices in risk management. I was amazed to find that most companies are in the same boat as us, with very little knowledge in risk management. From the limited results I have found from other companies, I have been able to develop a risk management template for us to use.

*Sponsor:* I've read over your report and looked at your templates. You have words and expressions in the templates that we don't use here at Packer. This concerns me greatly. Do we have to change the way we manage projects to use these templates?

Are we expected to make major changes to our existing project management methodology?

*PM:* I was hoping we could use these templates in their existing format. If the other companies are using these templates, then we should also. These templates also have the same probability distributions that other companies are using. I consider these facts equivalent to a validation of the templates.

*Sponsor:* Shouldn't the templates be tailored to our methodology for managing projects and our life cycle phases? These templates may have undergone validation, but not at Packer. The probability distributions are also based upon someone else's history, not our history. I cannot see anything in your report that talks about the justification of the probabilities.

The final problem I have is that the templates are based upon history. It is my understanding that risk management should be forward looking, with an attempt at predicting the possible future outcomes. I cannot see any of this in your templates.

*PM:* "I understand your concerns, but I don't believe they are a problem. I would prefer to use the next project as a "breakthrough" project using these templates. This will give us a good basis to validate the templates.

*Sponsor:* I will need to think about your request. I am not sure that we can use these templates without some type of risk management training for our employees.

- 1. Can templates be transferred from one company to another, or should tailoring be mandatory?
- 2. Can probability distributions be transferred from one company to another? If not, then how do we develop a probability distribution?
- 3. How do you validate a risk management template?
- 4. Should a risk management template be forward looking?
- 5. Can employees begin using a risk management template without some form of specialized training?

# Case 2 \_\_\_\_\_ Luxor Technologies

Between 1992 and 1996, Luxor Technologies had seen their business almost quadruple in the wireless communications area. Luxor's success was attributed largely to the strength of its technical community, which was regarded as second to none. The technical community was paid very well and given the freedom to innovate. Even though Luxor's revenue came from manufacturing, Luxor was regarded by Wall Street as being a technology-driven company.

The majority of Luxor's products were based upon low cost, high quality applications of the state-of-the-art technology, rather than advanced state-of-the-art technological breakthroughs. Applications engineering and process improvement were major strengths at Luxor. Luxor possessed patents in technology breakthrough, applications engineering, and even process improvement. Luxor refused to license their technology to other firms, even if the applicant was not a major competitor.

Patent protection and design secrecy were of paramount importance to Luxor. In this regard, Luxor became vertically integrated, manufacturing and assembling all components of their products internally. Only off-the-shelf components were purchased. Luxor believed that if they were to use outside vendors for sensitive component procurement, they would have to release critical and proprietary data to the vendors. Since these vendors most likely also serviced Luxor's competitors, Luxor maintained the approach of vertical integration to maintain secrecy.

Being the market leader technically afforded Luxor certain luxuries. Luxor saw no need for expertise in technical risk management. In cases where the technical community was only able to achieve 75–80 percent of the desired specification limit, the product was released as it stood, accompanied by an announcement that there would be an upgrade the following year to achieve the remaining 20–25 percent of the specification limit, together with other features. Enhancements and upgrades were made on a yearly basis.

By the fall of 1996, however, Luxor's fortunes were diminishing. The competition was catching up quickly, thanks to major technological breakthroughs. Marketing estimated that by 1998, Luxor would be a "follower" rather than a market leader. Luxor realized that something must be done, and quickly.

In January 1999, Luxor hired an expert in risk analysis and risk management to help Luxor assess the potential damage to the firm and to assist in development of a mitigation plan. The consultant reviewed project histories and lessons learned on all projects undertaken from 1992 through 1998. The consultant concluded that the major risk to Luxor would be the technical risk and prepared Exhibits I and II.

Exhibit I shows the likelihood of a technical risk event occurring. The consultant identified the six most common technical risk events that could occur at Luxor over the next several years, based upon the extrapolation of past and present data into the future. Exhibit II shows the impact that a technical risk event could have on each project. Because of the high probability of state-of-the-art advancements needed in the future (i.e., 95 percent from Exhibit I), the consultant identified the impact probabilities in Exhibit II for both with and without state-of-the-art advancement needed.

Exhibits I and II confirmed management's fear that Luxor was in trouble. A strategic decision had to be made concerning the technical risks identified in Exhibit I, specifically the first two risks. The competition had caught up to Luxor in applications engineering and was now surpassing Luxor in patents involving state-of-the-art

advancements. From 1992 to 1998, time was considered as a luxury for the technical community at Luxor. Now time was a serious constraint.

The strategic decision facing management was whether Luxor should struggle to remain a technical leader in wireless communications technology or simply console itself with a future as a "follower." Marketing was given the task of determining the potential impact of a change in strategy from a market leader to a market follower. The following list was prepared and presented to management by marketing:

- 1. The company's future growth rate will be limited.
- 2. Luxor will still remain strong in applications engineering but will need to outsource state-of-the-art development work.
- 3. Luxor will be required to provide outside vendors with proprietary information.
- 4. Luxor may no longer be vertically integrated (i.e., have backward integration).
- 5. Final product costs may be heavily influenced by the costs of subcontractors.
- 6. Luxor may not be able to remain a low cost supplier.
- 7. Layoffs will be inevitable, but perhaps not in the near term.
- 8. The marketing and selling of products may need to change. Can Luxor still market products as a low-cost, high quality, state-of-the-art manufacturer?
- 9. Price-cutting by Luxor's competitors could have a serious impact on Luxor's future ability to survive.

The list presented by marketing demonstrated that there was a serious threat to Luxor's growth and even survival. Engineering then prepared a list of alternative courses of action that would enable Luxor to maintain its technical leadership position:

- 1. Luxor could hire (away from the competition) more staff personnel with pure and applied R&D skills. This would be a costly effort.
- 2. Luxor could slowly retrain part of its existing labor force using existing, experienced R&D personnel to conduct the training.
- 3. Luxor could fund seminars and university courses on general R&D methods, as well as R&D methods for telecommunications projects. These programs were available locally.
- 4. Luxor could use tuition reimbursement funds to pay for distance learning courses (conducted over the Internet). These were full semester programs.
- 5. Luxor could outsource technical development.
- 6. Luxor could purchase or license technology from other firms, including competitors. This assumed that competitors would agree to this at a reasonable price.
- 7. Luxor could develop joint ventures/mergers with other companies which, in turn, would probably require Luxor to disclose much of its proprietary knowledge.

With marketing's and engineering's lists before them, Luxor's management had to decide which path would be best for the long term.

## Questions

1. Can the impact of one specific risk event, such as a technical risk event, create additional risks, which may or may not be technical risks? Can risk events be interrelated?

- 2. Does the list provided by marketing demonstrate the likelihood of a risk event or the impact of a risk event?
- 3. How does one assign probabilities to the marketing list?
- 4. The seven items in the list provided by engineering are all ways of mitigating certain risk events. If the company follows these suggestions, is it adopting a risk response mode of avoidance, assumption, reduction, or deflection?
- 5. Would you side with marketing or engineering? What should Luxor do at this point?

# Case 3 \_\_\_\_\_ Altex Corporation

#### Background

Following World War II, the United States entered into a Cold War with Russia. To win this Cold War, the United States had to develop sophisticated weapon systems with such destructive power that any aggressor knew that the retaliatory capability of the United States could and would inflict vast destruction.

Hundreds of millions of dollars were committed to ideas concerning technology that had not been developed as yet. Aerospace and defense contractors were growing without bounds, thanks to cost-plus-percentage-of-cost contract awards. Speed and technological capability were judged to be significantly more important than cost. To make matters worse, contracts were often awarded to the second or third most qualified bidder for the sole purpose of maintaining competition and maximizing the total number of defense contractors.

#### Contract Award

During this period Altex Corporation was elated when it learned that it had just been awarded the R&D phase of the Advanced Tactical Missile Program (ATMP). The terms of the contract specified that Altex had to submit to the Army, within 60 days after contract award, a formal project plan for the two-year ATMP effort. Contracts at that time did not require that a risk management plan be developed. A meeting was held with the project manager of R&D to assess the risks in the ATMP effort.

*PM:* I'm in the process of developing the project plan. Should I also develop a risk management plan as part of the project plan?

*Sponsor:* Absolutely not! Most new weapon systems requirements are established by military personnel who have no sense of reality about what it takes to develop a

weapon system based upon technology that doesn't even exist yet. We'll be lucky if we can deliver 60–70 percent of the specification imposed upon us.

*PM:* But that's not what we stated in our proposal. I wasn't brought on board until after we won the award, so I wasn't privileged to know the thought process that went into the proposal. The proposal even went so far as to imply that we might be able to exceed the specification limits, and now you're saying that we should be happy with 60–70 percent.

*Sponsor:* We say what we have to say to win the bid. Everyone does it. It is common practice. Whoever wins the R&D portion of the contract will also be first in line for the manufacturing effort and that's where the megabucks come from! If we can achieve 60–70 percent of specifications, it should placate the Army enough to give us a follow-on contract. If we told the Army the true cost of developing the technology to meet the specification limits, we would never get the contract. The program might even be canceled. The military people want this weapon system. They're not stupid! They know what is happening and they do not want to go to their superiors for more money until later on, downstream, after approval by DoD and project kickoff. The government wants the lowest cost and we want long-term, follow-on production contracts, which can generate huge profits.

PM: Aren't we simply telling lies in our proposal?

*Sponsor:* My engineers and scientists are highly optimistic and believe they can do the impossible. This is how technological breakthroughs are made. I prefer to call it "over-optimism of technical capability" rather than "telling lies." If my engineers and scientists have to develop a risk management plan, they may become pessimistic, and that's not good for us!

*PM:* The problem with letting your engineers and scientists be optimistic is that they become reactive rather than proactive thinkers. Without proactive thinkers, we end up with virtually no risk management or contingency plans. When problems surface that require significantly more in the way of resources than we budgeted for, we will be forced to accept crisis management as a way of life. Our costs will increase and that's not going to make the Army happy.

*Sponsor:* But the Army won't penalize us for failing to meet cost or for allowing the schedule to slip. If we fail to meet at least 60–70 percent of the specification limits, however, then we may well be in trouble. The Army knows there will be a follow-on contract request if we cannot meet specification limits. I consider 60–70 percent of the specifications to be the minimum acceptable limits for the Army. The Army wants the program kicked off right now.

Another important point is that long-term contracts and follow-on production contracts allow us to build up a good working relationship with the Army. This is critical. Once we get the initial contract, as we did, the Army will always work with us for follow-on efforts. Whoever gets the R&D effort will almost always get the lucrative production contract. Military officers are under pressure to work with us because their careers may be in jeopardy if they have to tell their superiors that millions of dollars were awarded to the wrong defense contractor. From a career standpoint, the military officers are better off allowing us to downgrade the requirements than admitting that a mistake was made.

*PM:* I'm just a little nervous managing a project that is so optimistic that major advances in the state of the art must occur to meet specifications. This is why I want to prepare a risk management plan.

*Sponsor:* You don't need a risk management plan when you know you can spend as much as you want and also let the schedule slip. If you prepare a risk management plan, you will end up exposing a multitude of risks, especially technical risks. The Army might not know about many of these risks, so why expose them and open up Pandora's box? Personally, I believe that the Army does already know many of these risks, but does not want them publicized to their superiors.

If you want to develop a risk management plan, then do it by yourself, and I really mean by yourself. Past experience has shown that our employees will be talking informally to Army personnel at least two to three times a week. I don't want anyone telling the customer that we have a risk management plan. The customer will obviously want to see it, and that's not good for us.

If you are so incensed that you feel obligated to tell the customer what you're doing, then wait about a year and a half. By that time, the Army will have made a considerable investment in both us and the project, and they'll be locked into us for follow-on work. Because of the strategic timing and additional costs, they will never want to qualify a second supplier so late in the game. Just keep the risk management plan to yourself for now.

If it looks like the Army might cancel the program, then we'll show them the risk management plan, and perhaps that will keep the program alive.

- 1. Why was a risk management plan considered unnecessary?
- 2. Should risk management planning be performed in the proposal stage or after contract award, assuming that it must be done?
- 3. Does the customer have the right to expect the contractor to perform risk analysis and develop a risk management plan if it is not called out as part of the contractual statement of work?
- 4. Would Altex have been more interested in developing a risk management plan if the project were funded entirely from within?
- 5. How effective will the risk management plan be if developed by the project manager in seclusion?
- 6. Should the customer be allowed to participate in or assist the contractor in developing a risk management plan?
- 7. How might the Army have responded if they were presented with a risk management plan early during the R&D activities?
- 8. How effective is a risk management plan if cost overruns and schedule slippages are always allowed?
- 9. How can severe optimism or severe pessimism influence the development of a risk management plan?
- 10. How does one develop a risk management plan predicated upon needed advances in the state of the art?
- 11. Can the sudden disclosure of a risk management plan be used as a stopgap measure to prevent termination of a potentially failing project?
- 12. Can risk management planning be justified on almost all programs and projects?

# Case 4 \_\_\_\_\_ Acme Corporation

### Background

Acme Corporation embarked upon an optimistic project to develop a new product for the marketplace. Acme's scientific community made a technical breakthrough and now the project appears to be in the development stage, more than being pure or applied research.

The product is considered to be high tech. If the product can be launched within the next four months, Acme expects to dominate the market for at least a year or so until the competition catches up. Marketing has stated that the product must sell for not more than \$150-\$160 per unit to be the cost-focused market leader.

Acme uses a project management methodology for all multifunctional projects. The methodology has six life cycle phases:

- Preliminary planning
- Detailed planning
- Execution/design selection
- Prototyping
- Testing/buyoff
- Production

At the end of each life cycle phase a gate/phase review meeting is held with the project sponsor and other appropriate stakeholders. Gate review meetings are formal meetings. The company has demonstrated success following this methodology for managing projects.

At the end of the second life cycle stage of this project, detailed planning, a meeting is held with just the project manager and the project sponsor. The purpose of the meeting is to review the detailed plan and identify any future problem areas that will require involvement by the project sponsor.

# The Meeting

*Sponsor:* I simply do not understand this document you sent me entitled "Risk Management Plan." All I see is a work breakdown structure with work packages at level 5 of the WBS accompanied by almost 100 risk events. Why am I looking at more than 100 risk events? Furthermore, they're not categorized in any manner. Doesn't our project management methodology provide any guidance on how to do this?

*PM:* All of these risk events can and will impact the design of the final product. We must be sure we select the right design at the lowest risk. Unfortunately, our project management methodology does not include any provisions or guidance on how to develop a risk management plan. Perhaps it should.

*Sponsor:* I see no reason for an in-depth analysis of 100 or so risk events. That's too many. Where are the probabilities and expected outcomes or damages?

*PM:* My team will not be assigning probabilities or damages until we get closer to prototype development. Some of these risk events may go away altogether.

*Sponsor:* Why spend all of this time and money on risk identification if the risks can go away next month? You've spent too much money doing this. If you spend the same amount of money on all of the risk management steps, then we'll be way over budget.

*PM:* We haven't looked at the other risk management steps yet, but I believe all of the remaining steps will require less than 10 percent of the budget we used for risk identification. We'll stay on budget.

- 1. Was the document given to the sponsor a risk management plan?
- 2. Did the project manager actually perform effective risk management?
- 3. Was the appropriate amount of time and money spent identifying the risk events?
- 4. Should one step be allowed to "dominate" the entire risk management process?
- 5. Are there any significant benefits to the amount of work already done for risk identification?
- 6. Should the 100 or so risk events identified have been categorized? If so, how?
- 7. Can probabilities of occurrence and expected outcomes (i.e., damage) be accurately assigned to 100 risk events?
- 8. Should a project management methodology provide guidance for the development of a risk management plan?
- 9. Given the life cycle phases in the case study, in which phase would it be appropriate to identify the risk management plan?
- 10. What are your feelings on the project manager's comments that he must wait until the prototyping phase to assign probabilities and outcomes?

# Case 5 \_\_\_\_\_ Quantum Telecom

In June of 1998, the executive committee of Quantum Telecom reluctantly approved two R&D projects that required technical breakthroughs. To make matters worse, the two products had to be developed by the summer of 1999 and introduced into the marketplace quickly. The life expectancy of both products was estimated to be less than one year because of the rate of change in technology. Yet, despite these risks, the two projects were fully funded. Two senior executives were assigned as the project sponsors, one for each project.

Quantum Telecom had a world-class project management methodology with five life cycle phases and five gate review meetings. The gate review meetings were go/nogo decision points based upon present performance and future risks. Each sponsor was authorized and empowered to make any and all decisions relative to projects, including termination.

Company politics always played an active role in decisions to terminate a project. Termination of a project often impacted the executive sponsor's advancement opportunities because the projects were promoted by the sponsors and funded through the sponsor's organization.

During the first two gate review meetings, virtually everyone recommended the termination of both projects. Technical breakthroughs seemed unlikely, and the schedule appeared unduely optimistic. But terminating the projects this early would certainly not reflect favorably upon the sponsors. Reluctantly, both sponsors agreed to continue the projects to the third gate in hopes of a "miracle."

During the third gate review, the projects were still in peril. Although the technical breakthrough opportunity now seemed plausible, the launch date would have to be slipped, thus giving Quantum Telecom a window of only six months to sell the products before obsolescence would occur.

By the fourth gate review, the technical breakthrough had not yet occurred but

did still seem plausible. Both project managers were still advocating the cancellation of the projects, and the situation was getting worse. Yet, in order to "save face" within the corporation, both sponsors allowed the projects to continue to completion. They asserted that, "If the new products could not be sold in sufficient quantity to recover the R&D costs, then the fault lies with marketing and sales, not with us." The sponsors were now off the hook, so to speak.

Both projects were completed six months late. The salesforce could not sell as much as one unit, and obsolescence occurred quickly. Marketing and sales were blamed for the failures, not the project sponsors.

- 1. How do we eliminate politics from gate review meetings?
- 2. How can we develop a methodology where termination of a project is not viewed as a failure?
- 3. Were the wrong people assigned as sponsors?
- 4. What options are available to a project manager when there exists a disagreement between the sponsor and the project manager?
- 5. Can your answer to the above question be outlined as part of the project management methodology?

# Case 6 \_\_\_\_\_ Lakes Automotive

Lakes Automotive is a Detroit-based tier one supplier to the auto industry. Between 1995 and 1999, Lakes Automotive installed a project management methodology based upon nine life cycle phases. All 60,000 employees world-wide accepted the methodology and used it. Management was pleased with the results. Also, Lakes Automotive's customer base was pleased with the methodology and provided Lakes Automotive with quality award recognition that everyone believed was attributed to how well the project management methodology was executed.

In February 2000, Lakes Automotive decided to offer additional products to their customers. Lakes Automotive bought out another tier one supplier, Pelex Automotive Products (PAP). PAP also had a good project management reputation and also provided quality products. Many of their products were similar to those provided by Lakes Automotive.

Since the employees from both companies would be working together closely, a singular project management methodology would be required that would be acceptable to both companies. PAP had a good methodology based upon five life cycle phases. Both methodologies had advantages and disadvantages, and both were well liked by their customers.

- 1. How do companies combine their methodologies?
- 2. How do you get employees to change work habits that have proven to be successful?
- 3. What influence should a customer have in redesigning a methodology that has been proven to be successful?
- 4. What if the customers want the existing methodologies left intact?
- 5. What if the customers are unhappy with the new combined methodology?

# Case 7 \_\_\_\_\_ Ferris HealthCare, Inc.

In July of 1999, senior management at Ferris recognized that its future growth could very well be determined by how quickly and how well it implemented project management. For the past several years, line managers had been functioning as project managers while still managing their line groups. The projects came out with the short end of the stick, most often late and over budget, because managers focused on line activities rather than project work. Everyone recognized that project management needed to be an established career path position and that some structured process had to be implemented for project management.

A consultant was brought into Ferris to provide initial project management training for 50 out of the 300 employees targeted for eventual project management training. Several of the employees thus trained were then placed on a committee with senior management to design a project management stage-gate model for Ferris.

After two months of meetings, the committee identified the need for three different stage-gate models: one for information systems, one for new products/services provided, and one for bringing on board new corporate clients. There were several similarities among the three models. However, personal interests dictated the need for three methodologies, all based upon rigid policies and procedures.

After a year of using three models, the company recognized it had a problem deciding how to assign the right project manager to the right project. Project managers had to be familiar with all three methodologies. The alternative, considered impractical, was to assign only those project managers familiar with that specific methodology.

After six months of meetings, the company consolidated the three methodologies into a single methodology, focusing more upon guidelines than on policies and procedures. The entire organization appeared to support the new singular methodology. A consultant was brought in to conduct the first three days of a four-day training program for employees not yet trained in project management. The fourth day was taught by internal personnel with a focus on how to use the new methodology. The success to failure ratio on projects increased dramatically.

- 1. Why was it so difficult to develop a singular methodology from the start?
- 2. Why were all three initial methodologies based upon policies and procedures?
- 3. Why do you believe the organization later was willing to accept a singular methodology?
- 4. Why was the singular methodology based upon guidelines rather than policies and procedures?
- 5. Did it make sense to have the fourth day of the training program devoted to the methodology and immediately attached to the end of the three-day program?
- 6. Why was the consultant not allowed to teach the methodology?

# Case 8 \_\_\_\_\_ Clark Faucet Company\*

#### Background

By 1999, Clark Faucet Company had grown into the third largest supplier of faucets for both commercial and home use. Competition was fierce. Consumers would evaluate faucets on artistic design and quality. Each faucet had to be available in at least 25 different colors. Commercial buyers seemed more interested in the cost than the average consumer, who viewed the faucet as an object of art, irrespective of price.

Clark Faucet Company did not spend a great deal of money advertising on the radio or on television. Some money was allocated for ads in professional journals. Most of Clark's advertising and marketing funds were allocated to the two semiannual home and garden trade shows and the annual builders trade show. One large builder could purchase more than 5,000 components for the furnishing of one newly constructed hotel or one apartment complex. Missing an opportunity to display the new products at these trade shows could easily result in a 6 to 12 month window of lost revenue.

### Culture

Clark Faucet had a noncooperative culture. Marketing and engineering would never talk to one another. Engineering wanted the freedom to design new products, whereas marketing wanted final approval to make sure that what was designed could be sold.

The conflict between marketing and engineering became so fierce that early attempts to implement project management failed. Nobody wanted to be the project

manager. Functional team members refused to attend team meetings and spent most of their time working on their own "pet" projects rather than the required work. Their line managers also showed little interest in supporting project management. Project management became so disliked that the procurement manager refused to

Project management became so disliked that the procurement manager refused to assign any of his employees to project teams. Instead, he mandated that all project work come through him. He eventually built up a large brick wall around his employees. He claimed that this would protect them from the continuous conflicts between engineering and marketing.

### The Executive Decision

The executive council mandated that another attempt to implement good project management practices must occur quickly. Project management would be needed not only for new product development but also for specialty products and enhancements. The vice presidents for marketing and engineering reluctantly agreed to try and patch up their differences, but did not appear confident that any changes would take place.

Strange as it may seem, nobody could identify the initial cause of the conflicts or how the trouble actually began. Senior management hired an external consultant to identify the problems, provide recommendations and alternatives, and act as a mediator. The consultant's process would have to begin with interviews.

### **Engineering Interviews**

The following comments were made during engineering interviews:

- "We are loaded down with work. If marketing would stay out of engineering, we could get our job done."
- "Marketing doesn't understand that there's more work for us to do other than just new product development."
- "Marketing personnel should spend their time at the country club and in bar rooms. This will allow us in engineering to finish our work uninterrupted!"
  "Marketing expects everyone in engineering to stop what they are doing in
- "Marketing expects everyone in engineering to stop what they are doing in order to put out marketing fires. I believe that most of the time the problem is that marketing doesn't know what they want up front. This leads to change after change. Why can't we get a good definition at the beginning of each project?"

### Marketing Interviews

- "Our livelihood rests on income generated from trade shows. Since new product development is 4–6 months in duration, we have to beat up on engineering to make sure that our marketing schedules are met. Why can't engineering understand the importance of these trade shows?"
- "Because of the time required to develop new products [4–6 months], we sometimes have to rush into projects without having a good definition of what is required. When a customer at a trade show gives us an idea for a new product, we rush to get the project underway for introduction at the next trade show. We then go back to the customer and ask for more clarification and/or

specifications. Sometimes we must work with the customer for months to get the information we need. I know that this is a problem for engineering, but it cannot be helped."

The consultant wrestled with the comments but was still somewhat perplexed. "Why doesn't engineering understand marketing's problems?" pondered the consultant. In a follow-up interview with an engineering manager, the following comment was made:

We are currently working on 375 different projects in engineering, and that includes those which marketing requested. Why can't marketing understand our problems?

- 1. What is the critical issue?
- 2. What can be done about it?
- 3. Can excellence in project management still be achieved and, if so, how? What steps would you recommend?
- 4. Given the current noncooperative culture, how long will it take to achieve a good cooperative project management culture, and even excellence?
- 5. What obstacles exist in getting marketing and engineering to agree to a singular methodology for project management?
- 6. What might happen if benchmarking studies indicate that either marketing or engineering are at fault?
- 7. Should a singular methodology for project management have a process for the prioritization of projects or should some committee external to the methodology accomplish this?

# Case 9 \_\_\_\_\_ Hyten Corporation\*

On June 5, 1998, a meeting was held at Hyten Corporation, between Bill Knapp, director of sales, and John Rich, director of engineering. The purpose of the meeting was to discuss the development of a new product for a special customer application. The requirements included a very difficult, tight-time schedule. The key to the success of the project would depend on timely completion of individual tasks by various departments.

*Bill Knapp:* The Business Development Department was established to provide coordination between departments, but they have not really helped. They just stick their nose in when things are going good and mess everything up. They have been out to see several customers, giving them information and delivery dates that we can't possibly meet.

*John Rich:* I have several engineers who have MBA degrees and are pushing hard for better positions within engineering or management. They keep talking that formal project management is what we should have at Hyten. The informal approach we use just doesn't work all the time. But I'm not sure that just any type of project management will work in our division.

*Knapp:* Well, I wonder who Business Development will tap to coordinate this project? It would be better to get the manager from inside the organization instead of hiring someone from outside.

## **Company Background**

Hyten Company was founded in 1982 as a manufacturer of automotive components. During the Gulf War, the company began manufacturing electronic components for the military. After the war, Hyten continued to prosper.

Hyten became one of the major component suppliers for the Space Program, but did not allow itself to become specialized. When the Space Program declined, Hyten developed other product lines, including energy management, building products, and machine tools, to complement their automotive components and electronics fields.


Hyten has been a leader in the development of new products and processes. Annual sales are in excess of \$600 million. The Automotive Components Division is one of Hyten's rapidly expanding business areas (see the organizational chart in Exhibit I).

## The Automotive Components Division

The management of both the Automotive Components Division and the Corporation itself is young and involved. Hyten has enjoyed a period of continuous growth over the past 15 years as a result of careful planning and having the right people in the right positions at the right time. This is emphasized by the fact that within five years of joining Hyten, every major manager and division head has been promoted to more responsibility within the corporation. The management staff of the Automotive Components Division has an average age of 40 and no one is over 50. Most of the middle managers have MBA degrees and a few have Ph.D.s. Currently, the Automotive Components Division has three manufacturing plants at various locations throughout the country. Central offices and most of the nonproduction functions are located at the main plant. There has been some effort by past presidents to give each separate plant some minimal level of purchasing, quality, manufacturing engineering and personnel functions.

## Informal Project Management at Hyten Corporation

The Automotive Components Division of Hyten Corporation has an informal system of project management. It revolves around each department handling their own func-

tional area of a given product development or project. Projects have been frequent enough that a sequence of operations has been developed to take a new product from concept to market. Each department knows its responsibilities and what it must contribute to a project.

A manager within the Business Development Department assumes informal project coordination responsibility and calls periodic meetings of the department heads involved. These meetings keep everyone advised of work status, changes to the project, and any problem areas. Budgeting of the project is based on the cost analysis developed after the initial design, while funding is allocated to each functional department based on the degree of its involvement. Funding for the initial design phase is controlled through business development. The customer has very little control over the funding, manpower, or work to be done. The customer, however, dictates when the new product design must be available for integration into the vehicle design, and when the product must be available in production quantities.

## The Business Development Department

The Business Development Department, separate from Marketing/Sales, functions as a steering group for deciding which new products or customer requests are to be pursued and which are to be dropped. Factors which they consider in making these decisions are: (1) the company's long- and short-term business plans, (2) current sales forecasts, (3) economic and industry indicators, (4) profit potential, (5) internal capabilities (both volume and technology), and (6) what the customer is willing to pay versus estimated cost.

The duties of Business Development also include the coordination of a project or new product from initial design through market availability. In this capacity, they have no formal authority over either functional managers or functional employees. They act strictly on an informal basis to keep the project moving, give status reports, and report on potential problems. They are also responsible for the selection of the plant that will be used to manufacture the product.

The functions of Business Development were formerly handled as a joint staff function where all the directors would periodically meet to formulate short-range plans and solve problems associated with new products. The department was formally organized three years ago by the then 38 year old president as a recognition of the need for project management within the Automotive Components Division.

Manpower for the Business Development Department was taken from both outside the company and from within the division. This was done to honor the Corporation's commitment to hire people from the outside only after it was determined that there were no qualified people internally (an area that for years has been a sore spot to the younger managers and engineers).

When the Business Development Department was organized, its level of authority and responsibility was limited. However, the Department's authority and responsibility have subsequently expanded, though at a slow rate. This was done so as not to alienate the functional managers who were concerned that project management would undermine their "empire."

## Introduction of Formal Project Management at Hyten Corporation

On July 10, 1998, Wilbur Donley was hired into the Business Development Department to direct new product development efforts. Prior to joining Hyten, he

worked as project manager with a company that supplied aircraft hardware to the government. He had worked both as an assistant project manager and as a project manager for five years prior to joining Hyten.

Shortly after his arrival, he convinced upper management to examine the idea of expanding the Business Development group and giving them responsibility for formal project management. An outside consulting firm was hired to give an in-depth seminar on project management to all management and supervisor employees in the Division.

Prior to the seminar, Donley talked to Frank Harrel, manager of quality and reliability, and George Hub, manager of manufacturing engineering, about their problems and what they thought of project management.

Frank Harrel is 37 years old, has an MBA degree, and has been with Hyten for five years. He was hired as an industrial engineer and three years ago was promoted to manager of quality and reliability. George Hub is 45 years old and has been with Hyten for 12 years as manager of manufacturing engineering.

*Wilbur Donley:* Well, Frank, what do you see as potential problems to the timely completion of projects within the Automotive Components Division?

*Frank Harrel:* The usual material movement problems we always have. We monitor all incoming materials in samples and production quantities, as well as in-process checking of production and finished goods on a sampling basis. We then move to 100 percent inspection if any discrepancies are found. Marketing and Manufacturing people don't realize how much time is required to inspect for either internal or customer deviations. Our current manpower requires that schedules be juggled to accommodate 100 percent inspection levels on "hot items." We seem to be getting more and more items at the last minute that must be done on overtime.

*Donley:* What are you suggesting? A coordination of effort with marketing, purchasing, production scheduling, and the manufacturing function to allow your department to perform their routine work and still be able to accommodate a limited amount of high-level work on "hot" jobs?

*Harrel:* Precisely, but we have no formal contact with these people. More open lines of communication would be of benefit to everyone.

*Donley:* We are going to introduce a more formal type of project management than has been used in the past so that all departments who are involved will actively participate in the planning cycle of the project. That way we they will remain aware of how they affect the function of other departments and prevent overlapping of work. We should be able to stay on schedule and get better cooperation.

*Harrel:* Good, I'll be looking forward to the departure from the usual method of handling a new project. Hopefully, it will work much better and result in fewer problems.

*Donley:* How do you feel, George, about improving the coordination of work among various departments through a formal project manager?

*George Hub:* Frankly, if it improves communication between departments, I'm all in favor of the change. Under our present system, I am asked to make estimates of cost and lead times to implement a new product. When the project begins, the Product

Design group starts making changes that require new cost figures and lead times. These changes result in cost overruns and in not meeting schedule dates. Typically, these changes continue right up to the production start date. Manufacturing appears to be the bad guy for not meeting the scheduled start date. We need someone to coordinate the work of various departments to prevent this continuous redoing of various jobs. We will at least have a chance at meeting the schedule, reducing cost, and improving the attitude of my people.

### Personnel Department's View of Project Management

After the seminar on project management, a discussion was held between Sue Lyons, director of personnel, and Jason Finney, assistant director of personnel. The discussion was about changing the organization structure from informal project management to formal project management.

*Sue Lyons:* Changing over would not be an easy road. There are several matters to be taken under consideration.

*Jason Finney:* I think we should stop going to outside sources for competent people to manage new projects that are established within Business Development. There are several competent people at Hyten who have MBA's in Systems/Project Management. With that background and their familiarity with company operations, it would be to the company's advantage if we selected personnel from within our organization.

*Lyons:* Problems will develop whether we choose someone form inside the company or from an outside source.

*Finney:* However, if the company continues to hire outsiders into Business Development to head new projects, competent people at Hyten are going to start filtering to places of new employment.

*Lyons:* You are right about the filtration. Whoever is chosen to be a project manager must have qualifications that will get the job done. He or she should not only know the technical aspect behind the project, but should also be able to work with people and understand their needs. Project managers have to show concern for team members and provide them with work challenge. Project managers must work in a dynamic environment. This often requires the implementation of change. Project managers must be able to live with change and provide necessary leadership to implement the change. It is the project manager's responsibility to develop an atmosphere to allow people to adapt to the changing work environment.

In our department alone, the changes to be made will be very crucial to the happiness of the employees and the success of projects. They must feel they are being given a square deal, especially in the evaluation procedure. Who will do the evaluation? Will the functional manager be solely responsible for the evaluation when, in fact, he or she might never see the functional employee for the duration of a project? A functional manager cannot possibly keep tabs on all the functional employees who are working on different projects.

*Finney:* Then the functional manager will have to ask the project managers for evaluation information.

Lyons: I can see how that could result in many unwanted situations. To begin with,

say the project manager and the functional manager don't see eye to eye on things. Granted, both should be at the same grade level and neither one has authority over the other, but let's say there is a situation where the two of them disagree as to either direction or quality of work. That puts the functional employee in an awkward position. Any employee will have the tendency of bending toward the individual who signs his or her promotion and evaluation form. This can influence the project manager into recommending an evaluation below par regardless of how the functional employee performs. There is also the situation where the employee is on the project for only a couple of weeks, and spends most of his or her time working alone, never getting a chance to know the project manager. The project manager will probably give the functional employee an average rating, even though the employee has done an excellent job. This results from very little contact. Then what do you do when the project manager allows personal feelings to influence his or her evaluation of a functional employee? A project manager who knows the functional employee personally might be tempted to give a strong or weak recommendation, regardless of performance.

*Finney:* You seem to be aware of many difficulties that project management might bring.

*Lyons:* Not really, but I've been doing a lot of homework since I attended that seminar on project management. It was a good seminar, and since there is not much written on the topic, I've been making a few phone calls to other colleagues for their opinions on project management.

*Finney:* What have you learned from these phone calls?

*Lyons:* That there are more personnel problems involved. What do you do in this situation? The project manager makes an excellent recommendation to the functional manager. The functional employee is aware of the appraisal and feels he or she should be given an above average pay increase to match the excellent job appraisal, but the functional manager fails to do so. One personnel manager from another company incorporating project management ran into problems when the project manager gave an employee of one grade level responsibilities of a higher grade level. The employee did an outstanding job taking on the responsibilities of a higher grade level and expected a large salary increase or a promotion.

Finney: Well, that's fair, isn't it?

*Lyons:* Yes, it seems fair enough, but that's not what happened. The functional manager gave an average evaluation and argued that the project manager had no business giving the functional employee added responsibility without first checking with him. So, then what you have is a disgruntled employee ready to seek employment elsewhere. Also, there are some functional managers who will only give above-average pay increases to those employees who stay in the functional department and make that manager look good.

*Lyons:* Right now I can see several changes that would need to take place. The first major change would have to be attitudes toward formal project management and hiring procedures. We do have project management here at Hyten but on an informal basis. If we could administer it formally, I feel we could do the company a great service. If we seek project managers from within, we could save on time and money. I could devote more time and effort on wage and salary grades and job descriptions. We

would need to revise our evaluation forms—presently they are not adequate. Maybe we should develop more than one evaluation form: one for the project manager to fill out and give to the functional manager, and a second form to be completed by the functional manager for submission to Personnel.

*Finney:* That might cause new problems. Should the project manager fill out his or her evaluation during or after project completion?

*Lyons:* It would have go be after project completion. That way an employee who felt unfairly evaluated would not feel tempted to screw up the project. If an employee felt the work wasn't justly evaluated, that employee might decide not to show up for a few days—these few days of absence could be most crucial for timely project completion.

*Finney:* How will you handle evaluation of employees who work on several projects at the same time? This could be a problem if employees are really enthusiastic about one project over another. They could do a terrific job on the project they are interested in and slack off on other projects. You could also have functional people working on departmental jobs but charging their time to the project overhead. Don't we have exempt and nonexempt people charging to projects?

*Lyons:* See what I mean? We can't just jump into project management and expect a bed of roses. There will have to be changes. We can't put the cart before the horse.

*Finney:* I realize that, Sue, but we do have several MBA people working here at Hyten who have been exposed to project management. I think that if we start putting our heads together and take a systematic approach to this matter, we will be able to pull this project together nicely.

*Lyons:* Well, Jason, I'm glad to see that you are for formal project management. We will have to approach top management on the topic. I would like you to help coordinate an equitable way of evaluating our people and to help develop the appropriate evaluation forms.

# Project Management as Seen by the Various Departments

The general manager arranged through the personnel department to interview various managers on a confidential basis. The purpose of the interview was to evaluate the overall acceptance of the concept of formal project management. The answers to the question, "How will project management affect your department?" were as follows:

Frank Harrel, quality and reliability manager

Project management is the actual coordination of the resources of functional departments to achieve the time, cost, and performance goals of the project. As a consequence, personnel interfacing is an important component toward the success of the project. In terms of quality control, it means less of the attitude of the structured workplace where quality is viewed as having the function of finding defects and, as a result, is looked upon as a hindrance to production. It means that the attitude toward quality control will change to one of interacting with other departments to minimize manufacturing problems. Project management reduces suboptimization among functional areas and induces cooperation. Both company and department goals can be achieved. It puts an end to the "can't see the forest for the trees" syndrome.

### Case 9

#### Harold Grimes, plant manager

I think that formal project management will give us more work than long-term benefits. History indicates that we hire more outside people for new positions than we promote from within. Who will be hired into these new project management jobs? We are experiencing a lot of backlash from people who are required to teach new people the ropes. In my opinion, we should assign inside MBA graduates with project management training to head up projects and not hire an outsider as a formal project manager. Our present system would work fine if inside people were made the new managers in the Business Development Department.

#### Herman Hall, director of MIS

I have no objections to the implementation of formal project management in our company. I do not believe, however, that it will be possible to provide the reports needed by this management structure for several years. This is due to the fact that most of my staff are deeply involved in current projects. We are currently working on the installation of minicomputers and on-line terminals throughout the plant. These projects have been delayed by the late arrival of new equipment, employee sabotage, and various start-up problems. As a result of these problems, one group admits to being six months behind schedule and the other group, although on schedule, is 18 months from their scheduled completion date. The rest of the staff currently assigned to maintenance projects consists of two systems analysts who are nearing retirement and two relatively inexperienced programmers. So, as you can readily see, unless we break up the current project teams and let those projects fall further behind schedule, it will be difficult at this time to put together another project team

The second problem is that even if I could put together a staff for the project, it might take up to two years to complete an adequate information system. Problems arise from the fact that it will take time to design a system that will draw data from all the functional areas. This design work will have to be done before the actual programming and testing could be accomplished. Finally, there would be a debugging period when we receive feedback from the user on any flaws in the system or enhancements that might be needed. We could not provide computer support to an "overnight" change to project management.

#### Bob Gustwell, scheduling manager

I am happy with the idea of formal project management, but I do see some problems implementing it. Some people around here like the way we do things now. It is a natural reaction for employees to fight against any changes in management style.

But don't worry about the scheduling department. My people will like the change to formal project management. I see this form of management as a way to minimize, of not eliminate, schedule changes. Better planning on the part of both department and project managers will be required, and the priorities will be set at corporate level. You can count on our support because I'm tired of being caught between production and sales.

### John Rich, director of engineering

It seems to me that project management will only mess things up. We now have a good flowing chain of command in our organization. This new matrix will only create problems. The engineering department, being very technical, just can't take direction from anyone outside the department. The project office will start to skimp on specifications just to save time and dollars. Our products are too technical to allow schedules and project costs to affect engineering results.

Bringing in someone from the outside to be the project manager will make things worse. I feel that formal project management should not be implemented at Hyten. Engineering has always directed the projects, and we should keep it that way. We shouldn't change a winning combination.

#### Fred Kuncl, plant engineering

I've thought about the trade-offs involved in implementing formal project management at Hyten and feel that plant engineering cannot live with them. Our departmental activities are centered around highly unpredictable circumstances, which sometimes involve rapidly changing priorities related to the production function. We in plant engineering must be able to respond quickly and appropriately to maintenance activities directly related to manufacturing activities. Plant engineering is also responsible for carrying out critical preventive maintenance and plant construction projects.

Project management would hinder our activities because project management responsibilities would burden our manpower with additional tasks. I am against project management because I feel that it is not in the best interest of Hyten. Project management would weaken our department's functional specialization because it would require cross-utilization of resources, manpower, and negotiation for the services critical to plant engineering.

#### Bill Knapp, director of marketing

I feel that the seminar on formal project management was a good one. Formal project management could benefit Hyten. Our organization needs to focus in more than one direction at all times. In order to be successful in today's market, we must concentrate on giving all our products sharp focus. Formal project management could be a good way of placing individual emphasis on each of the products of our company. Project management would be especially advantageous to us because of our highly diversified product lines. The organization needs to efficiently allocate resources to projects, products, and markets. We cannot afford to have expensive resources sitting idle. Cross-utilization and the consequent need for negotiation ensures that resources are used efficiently and in the organization's best overall interest.

We can't afford to continue to carry on informal project management in our business. We are so diversified that all of our products can't be treated alike. Each product has different needs. Besides, the nature of a team effort would strengthen our organization.

#### Stanley Grant, comptroller

In my opinion, formal project management can be profitably applied in our organization. Management should not, however, expect that project management would gain instant acceptance by the functional managers and functional employees, including the finance department personnel.

The implementation of formal project management in our organization would have an impact on our cost control system and internal control system, as well.

In the area of cost control, project cost control techniques have to be formalized and installed. This would require the accounting staff to: (1) beak comprehensive cost summaries into work packages, (2) prepare commitment reports for "technical decision makers," (3) approximate report data and (4) concentrate talent on major problems and opportunities. In project management, cost commitments on a project are made when various functional departments, such as engineering, manufacturing and marketing, make technical decisions to take some kind of action. Conventional accounting reports do not show the cost effects of these technical decisions until it is too late to reconsider. We would need to provide the project manager with cost commitment reports at each decision state to enable him or her to judge when costs are getting out of control. Only by receiving such timely cost commitment reports, could the project manager take needed corrective actions and be able to approximate the cost effect of each technical decision. Providing all these reports, however, would require additional personnel and expertise in our department. In addition, I feel that the implementation of formal project management would increase our responsibilities in finance department. We would need to conduct project audits, prepare periodic comparisons of actual versus projected costs and actual versus programmed manpower allocation, update projection reports and funding schedules, and sponsor cost improvement programs.

In the area of internal control, we will need to review and modify our existing internal control system to effectively meet our organization's goals related to project management. A careful and proper study and evaluation of existing internal control procedures should be conducted to determine the extent of the tests to which our internal auditing procedures are to be restricted. A thorough understanding of each project we undertake must be required at all times.

I'm all in favor of formal project management, provided management would allocate more resources to our department so we could maintain the personnel necessary to perform the added duties, responsibilities, and expertise required.

After the interviews, Sue Lyons talked to Wilbur Donley about the possibility of adopting formal project management. As she put it,

You realize that regardless of how much support there is for formal project management, the general manager will probably not allow us to implement it for fear it will affect the performance of the Automotive Components Division.

- 1. What are some of the major problems facing the management of Hyten in accepting formalized project management? (Include attitude problems/personality problems.)
- 2. Do any of the managers appear to have valid arguments for their beliefs as to why formal project management should not be considered?
- 3. Are there any good reasons why Hyten should go to formal project management?
- 4. Has Hyten taken a reasonable approach toward implementing formal project management?
- 5. Has Hyten done anything wrong?
- 6. Should formal project management give employees more room for personal growth?
- 7. Will formalized project management make it appear as though business development has taken power away from other groups?
- 8. Were the MBAs exposed to project management?
- 9. Were the organizational personnel focusing more on the problems (disadvantages) or advantages of project management?
- 10. What basic fears do employees have in considering organizational change to formal project management?
- 11. Must management be sold on project management prior to implementation?
- 12. Is it possible that some of the support groups cannot give immediate attention to such an organizational change?
- 13. Do functional managers risk a loss of employee loyalty with the new change?
- 14. What recommendations would you make to Hyten Corporation?
- 15. Is it easier or more difficult to implement a singular methodology for project management after the company has adopted formal project management rather than informal project management?
- 16. Is strategic planning for project management easier or more difficult to perform with formal project management in place?

# Case 10 \_\_\_\_\_ Como Tool and Die (A)\*

Como Tool and Die was a second-tier component supplier to the auto industry. Their largest customer was Ford Motor Company. Como had a reputation for delivering a quality product. During the 1980s and the early 1990s, Como's business grew because of their commitment to quality. Emphasis was on manufacturing operations, and few attempts were made to use project management. All work was controlled by line managers who, more often than not, were overburdened with work.

The culture at Como underwent a rude awakening in 1996. In the summer of 1996, Ford Motor Company established four product development objectives for both tier one and tier two suppliers:

- Lead time: 25–35 percent reduction
- Internal resources: 30–40 percent reduction
- Prototypes: 30–35 percent reduction (time and cost)
- Continuous process improvement and cost reductions

The objectives were aimed at consolidation of the supply base with larger commitments to tier one suppliers, who would now have greater responsibility in vehicle development, launch, process improvement, and cost reduction. Ford had established a time frame of 24 months for achievement of the objectives. The ultimate goal for Ford would be the creation of one global, decentralized vehicle development system that would benefit from the efficiency and technical capabilities of the original equipment manufacturers (OEMs) and the subsupplier infrastructure.

## Strategic Redirection: 1996

Como realized that it could no longer compete on quality alone. The marketplace had changed. The strategic plan for Como was now based upon maintaining an industry leadership position well into the twenty-first century. The four basic elements of the strategic plan included:

- First to market (faster development and tooling of the right products)
- Flexible processes (quickly adaptable to model changes)
- Flexible products (multiple niche products from shared platforms and a quick-to-change methodology)
- Lean manufacturing (low cost, high quality, speed, and global economies of scale)

The implementation of the strategy mandated superior project management performance, but changing a 60-year culture to support project management would not be an easy task.

The president of the company established a task force to identify the cultural issues of converting over to an informal project management system. The president believed that project management would eventually become the culture and, therefore, that the cultural issues must be addressed first. The following list of cultural issues was identified by the task force:

- Existing technical, functional departments currently do not adequately support the systemic nature of projects as departmental and individual objectives are not consistent with those of the project and the customer.
- Senior management must acknowledge the movement away from traditional, "over the fence," management and openly endorse the significance of project management, teamwork, and delegation of authority as the future.
- The company must establish a system of project sponsorship to support project managers by trusting them with the responsibility and then empowering them to be successful.
- The company must educate managers in project and risk management and the cultural changes of cross-functional project support; it is in the manager's self interest to support the project manager by providing necessary resources and negotiating for adequate time to complete the work.
- The company must enhance information systems to provide cost and schedule performance information for decision-making and problem resolution.
- Existing informal culture can be maintained while utilizing project management to monitor progress and review costs. Bureaucracy, red tape, and lost time must be eliminated through project management's enhanced communications, standard practices, and goal congruence.

The task force, as a whole, supported the idea of informal project management and believed that all of the cultural issues could be overcome. The task force identified four critical risks and the method of resolution:

- Trusting others and the system.
  - *Resolution:* Training in the process of project management and understanding of the benefits. Interpersonal training to learn to trust in each other and in keeping commitments will begin the cultural change.

- Transform 60 years of tradition in vertical reporting into horizontal project management.
  - *Resolution:* Senior management sponsor the implementation program, participate in training, and fully support efforts to implement project management across functional lines with encouragement and patience as new organizational relationships are forged.
- Capacity constraints and competition for resources.
  - *Resolution:* Work with managers to understand constraints and to develop alternative plans for success. Develop alternative external capacity to support projects.
- Inconsistency in application after introduction.
  - *Resolution:* Set the clear expectation that project management is the operational culture and the responsibility of each manager. Set the implementation of project management as a key measurable for management incentive plans. Establish a model project and recognize the efforts and successes as they occur.

The president realized that project management and strategic planning were related. The president wondered what would happen if the business base would grow as anticipated. Could project management excellence enhance the business base even further? To answer this question, the president prepared a list of competitive advantages that could be achieved through superior project management performance:

- Project management techniques and skills must be enhanced, especially for the larger, complex projects.
- Development of broader component and tooling supply bases would provide for additional capacity.
- Enhanced profitability would be possible through economies of scale to utilize project managers and skilled trades resources more efficiently through balanced workloads and level production.
- Greater purchasing leverage would be possible through larger purchasing volume and sourcing opportunities.
- Disciplined coordination, reporting of project status and proactive project management problem-solving must exist to meet timing schedules, budgets, and customer expectations.
- Effective project management of multitiered supply base will support sales growth beyond existing, capital intensive, internal tooling, and production capacities.

The wheels were set in motion. The president and his senior staff met with all of the employees of Como Tool and Die to discuss the implementation of project management. The president made it clear that he wanted a mature project management system in place within 36 months.

### Questions

- 1. Does Como have a choice in whether or not to accept project management as a culture?
- 2. How much influence should a customer be able to exert on how the contractors manage projects?

- 3. Was Como correct in attacking the cultural issues first?
- 4. Does the time frame of 36 months seem practical?
- 5. What chance of success do you give Como?
- 6. What dangers exist when your customers are more knowledgeable than you are concerning project management?
- 7. Is it possible for your customers' knowledge of project management to influence the way that your organization performs strategic planning for project management?
- 8. Should your customer, especially if a powerful customer, have an input in the way that your organization performs strategic planning for project management? If so, what type of input should the customer have and on what subject matter?

# Case 11 \_\_\_\_\_ Como Tool and Die (B)\*

By 1997, Como had achieved partial success in implementing project management. Lead times were reduced by 10 percent rather than the target of 25–35 percent. Internal resources were reduced by only 5 percent. The reduction in prototype time and cost was 15 percent rather than the expected 30–35 percent.

Como's automotive customers were not pleased with the slow progress and relatively immature performance of Como's project management system. Change was taking place, but not fast enough to placate the customers. Como was on target according to its 36 month schedule to achieve some degree of excellence in project management, but would its customers be willing to wait another two years for completion, or should Como try to accelerate the schedule?

### Ford Introduces "Chunk" Management

In the summer of 1997, Ford announced to its suppliers that it was establishing a "chunk" management system. All new vehicle metal structures would be divided into three or four major portions with each chosen supplier (i.e., chunk manager) responsible for all components within that portion of the vehicle. To reduce lead time at Ford and to gain supplier commitment, Ford announced that advanced placement of new work (i.e., chunk managers) would take place without competitive bidding. Target agreements on piece price, tooling cost, and lead time would be established and equitably negotiated later with value engineering work acknowledged.

Chunk managers would be selected based upon superior project management ca-

pability, including program management skills, coordination responsibility, design feasibility, prototypes, tooling, testing, process sampling, and start of production for components and subassemblies. Chunk managers would function as the second tier component suppliers and coordinate vehicle build for multiple, different vehicle projects at varied stages in the development-tool-launch process.

## Strategic Redirection: 1997

Ford Motor Company stated that the selection of the chunk managers would not take place for another year. Unfortunately, Como's plan to achieve excellence would not have been completed by then and its chances to be awarded a chunk management slot were slim.

The automotive division of Como was now at a critical junction. Como's management believed that the company could survive as a low-level supplier of parts, but its growth potential would be questionable. Chunk managers might find it costeffective to become vertically integrated and produce for themselves the same components that Como manufactured. This could have devastating results for Como. This alternative was unacceptable.

The second alternative required that Como make it clear to Ford Motor Company that Como wished to be considered for a chunk manager contract. If Como were to be selected, then Como's project management systems would have to:

- Provide greater coordination activities than previously anticipated
- Integrate concurrent engineering practices into the company's existing methodology for project management
- Decentralize the organization so as to enhance the working relationship with the customers
- Plan for better resource allocation so as to achieve a higher level of efficiency
- Force proactive planning and decision-making
- Drive out waste and lower cost while improving on-time delivery

There were also serious risks if Como were to become a chunk manager. The company would be under substantially more pressure to meet cost and delivery targets. Most of its resources would have to be committed to complex coordination activities rather than new product development. Therefore, value-added activities for its customers would be diminished. Finally, if Como failed to live up to its customers' expectations as a chunk manager, it might end up losing all automotive work.

The decision was made to inform Ford of Como's interest in chunk management. Now Como realized that its original three-year plan for excellence in project management would have to be completed in 18 months. The question on everyone's mind was: "How?"

## Questions

- 1. What was the driving force for excellence before the announcement of chunk management, and what is it now?
- 2. How can Como accelerate the learning process to achieve excellence in project management? What steps should management take based upon their learning so far?

- 3. What are their chances for success? Justify your answer.
- 4. Should Como compete to become a chunk manager?
- 5. Can the decision to become a chunk supplier change the way Como performs strategic planning for project management?
- 6. Can the decision to become a chunk supplier cause an immediate change in Como's singular methodology for project management?7. If a singular methodology for project management already exists, then how diffi-
- 7. If a singular methodology for project management already exists, then how difficult will it be to make major changes to the methodology and what type of resistance, if any, should management expect?

# Case 12\_\_\_\_\_ Macon, Inc.\*

Macon was a 50-year-old company in the business of developing test equipment for the tire industry. The company had a history of segregated departments with very focused functional line managers. The company had two major technical departments: mechanical engineering and electrical engineering. Both departments reported to a vice president for engineering, whose background was always mechanical engineering. For this reason, the company focused all projects from a mechanical engineering perspective. The significance of the test equipment's electrical control system was often minimized when, in reality, the electrical control systems were what made Macon's equipment outperform that of the competition.

Because of the strong autonomy of the departments, internal competition existed. Line managers were frequently competing with one another rather than focusing on the best interest of Macon. Each would hope the other would be the cause for project delays instead of working together to avoid project delays altogether. Once dates slipped, fingers were pointed and the problem would worsen over time.

One of Macon's customers had a service department that always blamed engineering for all of their problems. If the machine was not assembled correctly, it was engineering's fault for not documenting it clearly enough. If a component failed, it was engineering's fault for not designing it correctly. No matter what problem occurred in the field, customer service would always put the blame on engineering.

As might be expected, engineering would blame most problems on production claiming that production did not assemble the equipment correctly and did not maintain the proper level of quality. Engineering would design a product and then throw it

over the fence to production without ever going down to the manufacturing floor to help with its assembly. Errors or suggestions reported from production to engineering were being ignored. Engineers often perceived the assemblers as incapable of improving the design.

Production ultimately assembled the product and shipped it out to the customer. Oftentimes during assembly the production people would change the design as they saw fit without involving engineering. This would cause severe problems with documentation. Customer service would later inform engineering that the documentation was incorrect, once again causing conflict among all departments.

The president of Macon was a strong believer in project management. Unfortunately, his preaching fell upon deaf ears. The culture was just too strong. Projects were failing miserably. Some failures were attributed to the lack of sponsorship or commitment from line managers. One project failed as the result of a project leader who failed to control scope. Each day the project would fall further behind because work was being added with very little regard for the project's completion date. Project estimates were based upon a "gut feel" rather than upon sound quantitative data.

The delay in shipping dates was creating more and more frustration for the customers. The customers began assigning their own project managers as "watchdogs" to look out for their companies' best interests. The primary function of these "watchdog" project managers was to ensure that the equipment purchased would be delivered on time and complete. This involvement by the customers was becoming more prominent than ever before.

The president decided that action was needed to achieve some degree of excellence in project management. The question was what action to take, and when.

#### Questions

- 1. Where will the greatest resistance for excellence in project management come from?
- 2. What plan should be developed for achieving excellence in project management?
- 3. How long will it take to achieve some degree of excellence?
- 4. Explain the potential risks to Macon if the customer's experience with project management increases while Macon's knowledge remains stagnant.

# Case 13 \_\_\_\_\_ The Trophy Project\*

The ill-fated Trophy Project as in trouble right from the start. Reichart, who had been an assistant project manager, was involved with the project from its conception. When the Trophy Project was accepted by the company, Reichart was assigned as the project manager. The program schedules started to slip from day one, and expenditures were excessive. Reichart found that the functional managers were charging direct labor time to his project but working on their own "pet" projects. When Reichart complained of this, he was told not to meddle in the functional manager's allocation of resources and budgeted expenditures. After approximately six months, Reichart was requested to make a progress report directly to corporate and division staffs.

Reichart took this opportunity to bare his soul. The report substantiated that the project was forecasted to be one complete year behind schedule. Reichart's staff, as supplied by the line managers, was inadequate to stay at the required pace, let alone make up any time that had already been lost. The estimated cost at completion at this interval showed a cost overrun of at least 20 percent. This was Reichart's first opportunity to tell his story to people who were in a position to correct the situation. The result of Reichart's frank, candid evaluation of the Trophy Project was very predictable. Nonbelievers finally saw the light, and the line managers realized that they had a role to play in the completion of the project. Most of the problems were now out in the open and could be corrected by providing adequate staffing and resources. Corporate staff ordered immediate remedial action and staff support to provide Reichart a chance to bail out his program.

The results were not at all what Reichart had expected. He no longer reported to the project office; he now reported directly to the operations manager. Corporate staff's interest in the project became very intense, requiring a 7:00 A.M. meeting every Monday morning for complete review of the project status and plans for recovery. Reichart found himself spending more time preparing paperwork, reports, and projections for his Monday morning meetings than he did administering the Trophy Project. The main concern of corporate was to get the project back on schedule. Reichart spent many hours preparing the recovery plan and establishing manpower requirements to bring the program back onto the original schedule.

Group staff, in order to closely track the progress of the Trophy Project, assigned an assistant program manager. The assistant program manager determined that a sure cure for the Trophy Project would be to computerize the various problems and track the progress through a very complex computer program. Corporate provided Reichart with 12 additional staff members to work on the computer program. In the meantime, nothing changed. The functional managers still did not provide adequate staff for recovery, assuming that the additional manpower Reichart had received from corporate would accomplish that task.

After approximately \$50,000 was spent on the computer program to track the problems, it was found that the program objectives could not be handled by the computer. Reichart discussed this problem with a computer supplier and found that \$15,000 more was required for programming and additional storage capacity. It would take two months for installation of the additional storage capacity and the completion of the programming. At this point, the decision was made to abandon the computer program.

Reichart was now a year and a half into the program with no prototype units completed. The program was still nine months behind schedule with the overrun projected at 40 percent of budget. The customer had been receiving his reports on a timely basis and was well aware of the fact that the Trophy Project was behind schedule. Reichart had spent a great deal of time with the customer explaining the problems and the plan for recovery. Another problem that Reichart had to contend with was that the vendors who were supplying components for the project were also running behind schedule.

One Sunday morning, while Reichart was in his office putting together a report for the client, a corporate vice president came into his office. "Reichart," he said, "in any project I look at the top sheet of paper and the man whose name appears at the top of the sheet is the one I hold responsible. For this project your name appears at the top of the sheet. If you cannot bail this thing out, you are in serious trouble in this corporation." Reichart did not know which way to turn or what to say. He had no control over the functional managers who were creating the problems, but he was the person who was being held responsible.

After another three months the customer, becoming impatient, realized that the Trophy Project was in serious trouble and requested that the division general manager and his entire staff visit the customer's plant to give a progress and "get well" report within a week. The division general manager called Reichart into his office and said, "Reichart, go visit our customer. Take three or four functional line people with you and try to placate him with whatever you feel is necessary." Reichart and four functional line people visited the customer and gave a four-and-a-half-hour presentation defining the problems and the progress to that point. The customer was very polite and even commented that it was an excellent presentation, but the content was totally unacceptable. The program was still six to eight months late, and the customer de-

manded progress reports on a weekly basis. The customer made arrangements to assign a representative in Reichart's department to be "on-site" at the project on a daily basis and to interface with Reichart and his staff as required. After this turn of events, the program became very hectic.

The customer representative demanded constant updates and problem identification and then became involved in attempting to solve these problems. This involvement created many changes in the program and the product in order to eliminate some of the problems. Reichart had trouble with the customer and did not agree with the changes in the program. He expressed his disagreement vocally when, in many cases, the customer felt the changes were at no cost. This caused a deterioration of the relationship between client and producer.

One morning Reichart was called into the division general manager's office and introduced to Mr. "Red" Baron. Reichart was told to turn over the reins of the Trophy Project to Red immediately. "Reichart, you will be temporarily reassigned to some other division within the corporation. I suggest you start looking outside the company for another job." Reichart looked at Red and asked, "Who did this? Who shot me down?"

Red was program manager on the Trophy Project for approximately six months, after which, by mutual agreement, he was replaced by a third project manager. The customer reassigned his local program manager to another project. With the new team the Trophy Project was finally completed one year behind schedule and at a 40 percent cost overrun.

## Questions

- 1. Did the project appear to be planned correctly?
- 2. Did functional management seem to be committed to the project?
- 3. Did senior management appear supportive and committed?
- 4. Can a singular methodology for project management be designed to "force" cooperation to occur between groups?
- 5. Is it possible or even desirable for strategic planning for project management to include ways to improve cooperation and working relationships, or is this beyond the scope of strategic planning for project management?

# Case 14 \_\_\_\_\_ The Blue Spider Project\*

"This is impossible! Just totally impossible! Ten months ago I was sitting on top of the world. Upper-level management considered me one of the best, if not the best, engineer in the plant. Now look at me! I have bags under my eyes, I haven't slept soundly in the last six months, and here I am, cleaning out my desk. I'm sure glad they gave me back my old job in engineering. I guess I could have saved myself a lot of grief and aggravation had I not accepted the promotion to project manager."

#### History

Gary Anderson had accepted a position with Parks Corporation right out of college. With a Ph.D. in mechanical engineering, Gary was ready to solve the world's most traumatic problems. At first, Parks Corporation offered Gary little opportunity to do the pure research that he eagerly wanted to undertake. However, things soon changed. Parks grew into a major electronics and structural design corporation during the big boom of the late 1950s and early 1960s when Department of Defense (DoD) contracts were plentiful.

Parks Corporation grew from a handful of engineers to a major DoD contractor, employing some 6,500 people. During the recession of the late 1960s, money became scarce and major layoffs resulted in lowering the employment level to 2,200 employees. At that time, Parks decided to get out of the R&D business and compete as a lowcost production facility while maintaining an engineering organization solely to support production requirements.

After attempts at virtually every project management organizational structure,

Parks Corporation selected the matrix form. Each project had a program manager who reported to the director of program management. Each project also maintained an assistant project manager—normally a project engineer—who reported directly to the project manager and indirectly to the director of engineering. The program manager spent most of his time worrying about cost and time, whereas the assistant program manager worried more about technical performance.

With the poor job market for engineers, Gary and his colleagues began taking coursework toward MBA degrees in case the job market deteriorated further.

In 1975, with the upturn in DoD spending, Parks had to change its corporate strategy. Parks had spent the last seven years bidding on the production phase of large programs. Now, however, with the new evaluation criteria set forth for contract awards, those companies winning the R&D and qualification phases had a definite edge on being awarded the production contract. The production contract was where the big profits could be found. In keeping with this new strategy, Parks began to beef up its R&D engineering staff. By 1978, Parks had increased in size to 2,700 employees. The increase was mostly in engineering. Experienced R&D personnel were difficult to find for the salaries that Parks was offering. Parks was, however, able to lure some employees away from the competitors, but relied mostly upon the younger, in-experienced engineers fresh out of college.

With the adoption of this corporate strategy, Parks Corporation administered a new wage and salary program that included job upgrading. Gary was promoted to senior scientist, responsible for all R&D activities performed in the mechanical engineering department. Gary had distinguished himself as an outstanding production engineer during the past several years, and management felt that his contribution could be extended to R&D as well.

In January 1978, Parks Corporation decided to compete for Phase I of the Blue Spider Project, an R&D effort that, if successful, could lead into a \$500 million program spread out over 20 years. The Blue Spider Project was an attempt to improve the structural capabilities of the Spartan missile, a short-range tactical missile used by the Army. The Spartan missile was exhibiting fatigue failure after six years in the field. This was three years less than what the original design specifications called for. The Army wanted new materials that could result in a longer life for the Spartan missile.

Lord Industries was the prime contractor for the Army's Spartan Program. Parks Corporation would be a subcontractor to Lord if they could successfully bid and win the project. The criteria for subcontractor selection were based not only on low bid, but also on technical expertise as well as management performance on other projects. Park's management felt that they had a distinct advantage over most of the other competitors because they had successfully worked on other projects for Lord Industries.

#### The Blue Spider Project Kickoff

On November 3, 1977, Henry Gable, the director of engineering, called Gary Anderson into his office.

*Henry Gable:* Gary, I've just been notified through the grapevine that Lord will be issuing the RFP for the Blue Spider Project by the end of this month, with a 30-day response period. I've been waiting a long time for a project like this to come along so that I can experiment with some new ideas that I have. This project is going to be my baby all the way! I want you to head up the proposal team. I think it must be an en-

gineer. I'll make sure that you get a good proposal manager to help you. If we start working now, we can get close to two months of research in before proposal submittal. That will give us a one-month's edge on our competitors.

Gary was pleased to be involved in such an effort. He had absolutely no trouble in getting functional support for the R&D effort necessary to put together a technical proposal. All of the functional managers continually remarked to Gary, "This must be a biggy. The director of engineering has thrown all of his support behind you."

On December 2, the RFP was received. The only trouble area that Gary could see was that the technical specifications stated that all components must be able to operate normally and successfully through a temperature range of -65 °F to 145 °F. Current testing indicated the Parks Corporation's design would not function above 130 °F. An intensive R&D effort was conducted over the next three weeks. Everywhere Gary looked, it appeared that the entire organization was working on his technical proposal.

A week before the final proposal was to be submitted, Gary and Henry Gable met to develop a company position concerning the inability of the preliminary design material to be operated above 130 °F.

*Gary Anderson:* Henry, I don't think it is going to be possible to meet specification requirements unless we change our design material or incorporate new materials. Everything I've tried indicates we're in trouble.

*Gable:* We're in trouble only if the customer knows about it. Let the proposal state that we expect our design to be operative up to 155 °F. That'll please the customer.

Anderson: That seems unethical to me. Why don't we just tell them the truth?

*Gable:* The truth doesn't always win proposals. I picked you to head up this effort because I thought that you'd understand. I could have just as easily selected one of our many moral project managers. I'm considering you for program manager after we win the program. If you're going to pull this conscientious crap on me like the other project managers do, I'll find someone else. Look at it this way; later we can convince the customer to change the specifications. After all, we'll be so far downstream that he'll have no choice.

After two solid months of 16-hour days for Gary, the proposal was submitted. On February 10, 1978, Lord Industries announced that Parks Corporation would be awarded the Blue Spider Project. The contract called for a ten-month effort, negotiated at \$2.2 million at a firm-fixed price.À

#### Selecting the Project Manager

Following contract award, Henry Gable called Gary in for a conference.

*Gable:* Congratulations, Gary! You did a fine job. The Blue Spider Project has great potential for ongoing business over the next ten years, provided that we perform well during the R&D phase. Obviously you're the most qualified person in the plant to head up the project. How would you feel about a transfer to program management?

*Anderson:* I think it would be a real challenge. I could make maximum use of the MBA degree I earned last year. I've always wanted to be in program management.

*Gable:* Having several masters' degrees, or even doctorates for that matter, does not guarantee that you'll be a successful project manager. There are three requirements for effective program management: You must be able to communicate both in writing and orally; you must know how to motivate people; and you must be willing to give up your car pool. The last one is extremely important in that program managers must be totally committed and dedicated to the program, regardless of how much time is involved.

But this is not the reason why I asked you to come here. Going from project engineer to program management is a big step. There are only two places you can go from program management—up the organization or out the door. I know of very, very few engineers who failed in program management and were permitted to return.

*Anderson:* Why is that? If I'm considered to be the best engineer in the plant, why can't I return to engineering?

*Gable:* Program management is a world of its own. It has its own formal and informal organizational ties. Program managers are outsiders. You'll find out. You might not be able to keep the strong personal ties you now have with your fellow employees. You'll have to force even your best friends to comply with your standards. Program managers can go from program to program, but functional departments remain intact.

I'm telling you all this for a reason. We've worked well together the past several years. But if I sign the release so that you can work for Grey in program management, you'll be on your own, like hiring into a new company. I've already signed the release. You still have some time to think about it.

*Anderson:* One thing I don't understand. With all of the good program managers we have here, why am I given this opportunity?

*Gable:* Almost all of our program managers are over forty-five years old. This resulted from our massive layoffs several years ago when we were forced to lay off the younger, inexperienced program managers. You were selected because of your age and because all of our other program managers have worked only on production-type programs. We need someone at the reins who knows R&D. Your counterpart at Lord Industries will be an R&D type. You have to fight fire with fire.

I have an ulterior reason for wanting you to accept this position. Because of the division of authority between program management and project engineering, I need someone in program management whom I can communicate with concerning R&D work. The program managers we have now are interested only in time and cost. We need a manager who will bend over backwards to get performance also. I think you're that man. You know the commitment we made to Lord when we submitted that proposal. You have to try to achieve that. Remember, this program is my baby. You'll get all the support you need. I'm tied up on another project now. But when it's over, I'll be following your work like a hawk. We'll have to get together occasionally and discuss new techniques.

Take a day or two to think it over. If you want the position, make an appointment to see Elliot Grey, the director of program management. He'll give you the same speech I did. I'll assign Paul Evans to you as chief project engineer. He's a seasoned veteran and you should have no trouble working with him. He'll give you good advice. He's a good man.

#### The Work Begins

Gary accepted the new challenge. His first major hurdle occurred in staffing the project. The top priority given to him to bid the program did not follow through for staffing. The survival of Parks Corporation depended on the profits received from the production programs. In keeping with this philosophy Gary found that engineering managers (even his former boss) were reluctant to give up their key people to the Blue Spider Program. However, with a little support from Henry Gable, Gary formed an adequate staff for the program.

Right from the start Gary was worried that the test matrix called out in the technical volume of the proposal would not produce results that could satisfy specifications. Gary had 90 days after go-ahead during which to identify the raw materials that could satisfy specification requirements. Gary and Paul Evans held a meeting to map out their strategy for the first few months.

*Anderson:* Well, Paul, we're starting out with our backs against the wall on this one. Any recommendations?

*Paul Evans:* I also have my doubts about the validity of this test matrix. Fortunately, I've been through this before. Gable thinks this is his project and he'll sure as hell try to manipulate us. I have to report to him every morning at 7:30 A.M. with the raw data results of the previous day's testing. He wants to see it before you do. He also stated that he wants to meet with me alone.

Lord will be the big problem. If the test matrix proves to be a failure, we're going to have to change the scope of effort. Remember, this is an FFP contract. If we change the scope of work and do additional work in the earlier phases of the program, then we should prepare a trade-off analysis to see what we can delete downstream so as to not overrun the budget.

*Anderson:* I'm going to let the other project office personnel handle the administrating work. You and I are going to live in the research labs until we get some results. We'll let the other project office personnel run the weekly team meetings.

For the next three weeks Gary and Paul spent virtually 12 hours per day, 7 days a week, in the research and development lab. None of the results showed any promise. Gary kept trying to set up a meeting with Henry Gable but always found him unavailable.

During the fourth week, Gary, Paul, and the key functional department managers met to develop an alternate test matrix. The new test matrix looked good. Gary and his team worked frantically to develop a new workable schedule that would not have impact on the second milestone, which was to occur at the end of 180 days. The second milestone was the final acceptance of the raw materials and preparation of production runs of the raw materials to verify that there would be no scale-up differences between lab development and full-scale production.

Gary personally prepared all of the technical handouts for the interchange meeting. After all, he would be the one presenting all of the data. The technical interchange meeting was scheduled for two days. On the first day, Gary presented all of the data, including test results, and the new test matrix. The customer appeared displeased with the progress to date and decided to have its own in-house caucus that evening to go over the material that was presented.

The following morning the customer stated its position: "First of all, Gary, we're quite pleased to have a project manager who has such a command of technology. That's

good. But every time we've tried to contact you last month, you were unavailable or had to be paged in the research laboratories. You did an acceptable job presenting the technical data, but the administrative data was presented by your project office personnel. We, at Lord, do not think that you're maintaining the proper balance between your technical and administrative responsibilities. We prefer that you personally give the administrative data and your chief project engineer present the technical data.

"We did not receive any agenda. Our people like to know what will be discussed, and when. We also want a copy of all handouts to be presented at least three days in advance. We need time to scrutinize the data. You can't expect us to walk in here blind and make decisions after seeing the data for ten minutes.

"To be frank, we feel that the data to date is totally unacceptable. If the data does not improve, we will have no choice but to issue a work stoppage order and look for a new contractor. The new test matrix looks good, especially since this is a firm-fixedprice contract. Your company will bear the burden of all costs for the additional work. A trade-off with later work may be possible, but this will depend on the results presented at the second design review meeting, 90 days from now.

"We have decided to establish a customer office at Parks to follow your work more closely. Our people feel that monthly meetings are insufficient during R&D activities. We would like our customer representative to have daily verbal meetings with you or your staff. He will then keep us posted. Obviously, we had expected to review much more experimental data than you have given us.

"Many of our top-quality engineers would like to talk directly to your engineering community, without having to continually waste time by having to go through the project office. We must insist on this last point. Remember, your effort may be only \$2.2 million, but our total package is \$100 million. We have a lot more at stake than you people do. Our engineers do not like to get information that has been filtered by the project office. They want to help you.

"And last, don't forget that you people have a contractual requirement to prepare complete minutes for all interchange meetings. Send us the original for signature before going to publication."

Although Gary was unhappy with the first team meeting, especially with the requests made by Lord Industries, he felt that they had sufficient justification for their comments. Following the team meeting, Gary personally prepared the complete minutes. "This is absurd," thought Gary. "I've wasted almost one entire week doing nothing more than administrative paperwork. Why do we need such detailed minutes? Can't a rough summary suffice? Why is it that customers want everything documented? That's like an indication of fear. We've been completely cooperative with them. There has been no hostility between us. If we've gotten this much paperwork to do now, I hate to imagine what it will be like if we get into trouble."

#### A New Role

Gary completed and distributed the minutes to the customer as well as to all key team members.

For the next five weeks testing went according to plan, or at least Gary thought that it had. The results were still poor. Gary was so caught up in administrative paperwork that he hadn't found time to visit the research labs in over a month. On a Wednesday morning, Gary entered the lab to observe the morning testing. Upon arriving in the lab, Gary found Paul Evans, Henry Gable, and two technicians testing a new material, JXB-3.

*Gable:* Gary, your problems will soon be over. This new material, JXB-3, will permit you to satisfy specification requirements. Paul and I have been testing it for two weeks. We wanted to let you know, but were afraid that if the word leaked out to the customer that we were spending their money for testing materials that were not called out in the program plan, they would probably go crazy and might cancel the contract. Look at these results. They're super!

*Anderson:* Am I supposed to be the one to tell the customer now? This could cause a big wave.

*Gable:* There won't be any wave. Just tell them that we did it with our own IR&D funds. That'll please them because they'll think we're spending our own money to support their program.

Before presenting the information to Lord, Gary called a team meeting to present the new data to the project personnel. At the team meeting, one functional manager spoke out: "This is a hell of a way to run a program. I like to be kept informed about everything that's happening here at Parks. How can the project office expect to get support out of the functional departments if we're kept in the dark until the very last minute? My people have been working with the existing materials for the last two months and you're telling us that it was all for nothing. Now you're giving us a material that's so new that we have no information on it whatsoever. We're now going to have to play catch-up, and that's going to cost you plenty."

One week before the 180-day milestone meeting, Gary submitted the handout package to Lord Industries for preliminary review. An hour later the phone rang.

*Customer:* We've just read your handout. Where did this new material come from? How come we were not informed that this work was going on? You know, of course, that our customer, the Army, will be at this meeting. How can we explain this to them? We're postponing the review meeting until all of our people have analyzed the data and are prepared to make a decision.

The purpose of a review or interchange meeting is to exchange information when *both* parties have familiarity with the topic. Normally, we (Lord Industries) require almost weekly interchange meetings with our other customers because we don't trust them. We disregard this policy with Parks Corporation based on past working relationships. But with the new state of developments, you have forced us to revert to our previous position, since we now question Parks Corporation's integrity in communicating with us. At first we believed this was due to an inexperienced program manager. Now, we're not sure.

*Anderson:* I wonder if the real reason we have these interchange meetings isn't to show our people that Lord Industries doesn't trust us. You're creating a hell of a lot of work for us, you know.

Customer: You people put yourself in this position. Now you have to live with it.

Two weeks later Lord reluctantly agreed that the new material offered the greatest promise. Three weeks later the design review meeting was held. The Army was definitely not pleased with the prime contractor's recommendation to put a new, untested material into a multimillion-dollar effort.

## The Communications Breakdown

During the week following the design review meeting Gary planned to make the first verification mix in order to establish final specifications for selection of the raw materials. Unfortunately, the manufacturing plans were a week behind schedule, primarily because of Gary, since he had decided to reduce costs by accepting the responsibility for developing the bill of materials himself.

A meeting was called by Gary to consider rescheduling of the mix.

*Anderson:* As you know we're about a week to ten days behind schedule. We'll have to reschedule the verification mix for late next week.

*Production Manager:* Our resources are committed until a month from now. You can't expect to simply call a meeting and have everything reshuffled for the Blue Spider Program. We should have been notified earlier. Engineering has the responsibility for preparing the bill of materials. Why aren't they ready?

*Engineering Integration:* We were never asked to prepare the bill of materials. But I'm sure that we could get it out if we work our people overtime for the next two days.

Anderson: When can we remake the mix?

*Production Manager:* We have to redo at least 500 sheets of paper every time we reschedule mixes. Not only that, we have to reschedule people on all three shifts. If we are to reschedule your mix, it will have to be performed on overtime. That's going to increase your costs. If that's agreeable with you, we'll try it. But this will be the first and last time that production will bail you out. There are procedures that have to be followed.

*Testing Engineer:* I've been coming to these meetings since we kicked off this program. I think I speak for the entire engineering division when I say that the role that the director of engineering is playing in this program is suppressing individuality among our highly competent personnel. In new projects, especially those involving R&D, our people are not apt to stick their necks out. Now our people are becoming ostriches. If they're impeded from contributing, even in their own slight way, then you'll probably lose them before the project gets completed. Right now I feel that I'm wasting my time here. All I need are minutes of the team meetings and I'll be happy. Then I won't have to come to these pretend meetings anymore.

The purpose of the verification mix was to make a full-scale production run of the material to verify that there would be no material property changes in scale-up from the small mixes made in the R&D laboratories. After testing, it became obvious that the wrong lots of raw materials were used in the production verification mix.

A meeting was called by Lord Industries for an explanation of why the mistake had occurred and what the alternatives were.

## Lord: Why did the problem occur?

*Anderson:* Well, we had a problem with the bill of materials. The result was that the mix had to be made on overtime. And when you work people on overtime, you have to be willing to accept mistakes as being a way of life. The energy cycles of our people are slow during the overtime hours.

Lord: The ultimate responsibility has to be with you, the program manager. We, at

Lord, think that you're spending too much time doing and not enough time managing. As the prime contractor, we have a hell of a lot more at stake than you do. From now on we want documented weekly technical interchange meetings and closer interaction by our quality control section with yours.

*Anderson:* These additional team meetings are going to tie up our key people. I can't spare people to prepare handouts for weekly meetings with your people.

*Lord:* Team meetings are a management responsibility. If Parks does not want the Blue Spider Program, I'm sure we can find another subcontractor. All you (Gary) have to do is give up taking the material vendors to lunch and you'll have plenty of time for handout preparation.

Gary left the meeting feeling as though he had just gotten raked over the coals. For the next two months, Gary worked sixteen hours a day, almost every day. Gary did not want to burden his staff with the responsibility of the handouts, so he began preparing them himself. He could have hired additional staff, but with such a tight budget, and having to remake verification mix, cost overruns appeared inevitable.

As the end of the seventh month approached, Gary was feeling pressure from within Parks Corporation. The decision-making process appeared to be slowing down and Gary found it more and more difficult to motivate his people. In fact, the grapevine was referring to the Blue Spider Project as a loser, and some of his key people acted as though they were on a sinking ship.

By the time the eighth month rolled around, the budget had nearly been expended. Gary was tired of doing everything himself. "Perhaps I should have stayed an engineer," thought Gary. Elliot Grey and Gary Anderson had a meeting to see what could be salvaged. Grey agreed to get Gary additional corporate funding to complete the project. "But performance must be met, since there is a lot riding on the Blue Spider Project," asserted Grey. He called a team meeting to identify the program status.

*Anderson:* It's time to map out our strategy for the remainder of the program. Can engineering and production adhere to the schedule that I have laid out before you?

*Team Member: Engineering:* This is the first time that I've seen this schedule. You can't expect me to make a decision in the next ten minutes and commit the resources of my department. We're getting a little unhappy being kept in the dark until the last minute. What happened to effective planning?

*Anderson:* We still have effective planning. We must adhere to the original schedule, or at least try to adhere to it. This revised schedule will do that.

*Team Member: Engineering:* Look, Gary! When a project gets in trouble it is usually the functional departments that come to the rescue. But if we're kept in the dark, then how can you expect us to come to your rescue? My boss wants to know, well in advance, every decision that you're contemplating with regard to our departmental resources. Right now, we . . .

*Anderson:* Granted, we may have had a communications problem. But now we're in trouble and have to unite forces. What is your impression as to whether your department can meet the new schedule?

Team Member: Engineering: When the Blue Spider Program first got in trouble, my

boss exercised his authority to make all departmental decisions regarding the program himself. I'm just a puppet. I have to check with him on everything.

*Team Member: Production:* I'm in the same boat, Gary. You know we're not happy having to reschedule our facilities and people. We went through this once before. I also have to check with my boss before giving you an answer about the new schedule.

The following week the verification mix was made. Testing proceeded according to the revised schedule, and it looked as though the total schedule milestones could be met, provided that specifications could be adhered to.

Because of the revised schedule, some of the testing had to be performed on holidays. Gary wasn't pleased with asking people to work on Sundays and holidays, but he had no choice, since the test matrix called for testing to be accomplished at specific times after end-of-mix.

A team meeting was called on Wednesday to resolve the problem of who would work on the holiday, which would occur on Friday, as well as staffing Saturday and Sunday. During the team meeting Gary became quite disappointed. Phil Rodgers, who had been Gary's test engineer since the project started, was assigned to a new project that the grapevine called Gable's new adventure. His replacement was a relatively new man, only eight months with the company. For an hour and a half, the team members argued about the little problems and continually avoided the major question, stating that they would first have to coordinate commitments with their bosses. It was obvious to Gary that his team members were afraid to make major decisions and therefore "ate up" a lot of time on trivial problems.

On the following day, Thursday, Gary went to see the department manager responsible for testing, in hopes that he could use Phil Rodgers this weekend.

*Department Manager:* I have specific instructions from the boss (director of engineering) to use Phil Rodgers on the new project. You'll have to see the boss if you want him back

*Anderson:* But we have testing that must be accomplished this weekend. Where's the new man you assigned yesterday?

*Department Manager:* Nobody told me you had testing scheduled for this weekend. Half of my department is already on an extended weekend vacation, including Phil Rodgers and the new man. How come I'm always the last to know when we have a problem?

*Anderson:* The customer is flying down his best people to observe this weekend's tests. It's too late to change anything. You and I can do the testing.

*Department Manager:* Not on your life. I'm staying as far away as possible from the Blue Spider Project. I'll get you someone, but it won't be me. That's for sure!

The weekend's testing went according to schedule. The raw data was made available to the customer under the stipulation that the final company position would be announced at the end of the next month, after the functional departments had a chance to analyze it.

Final testing was completed during the second week of the ninth month. The initial results looked excellent. The materials were within contract specifications, and although they were new, both Gary and Lord's management felt that there would be little difficulty in convincing the Army that this was the way to go. Henry Gable visited Gary and congratulated him on a job well done.

All that now remained was the making of four additional full-scale verification mixes in order to determine how much deviation there would be in material properties between full-sized production-run mixes. Gary tried to get the customer to concur (as part of the original trade-off analysis) that two of the four production runs could be deleted. Lord's management refused, insisting that contractual requirements must be met at the expense of the contractor.

The following week, Elliot Grey called Gary in for an emergency meeting concerning expenditures to date.

*Elliot Grey:* Gary, I just received a copy of the financial planning report for last quarter in which you stated that both the cost and performance of the Blue Spider Project were 75 percent complete. I don't think you realize what you've done. The target profit on the program was \$200,000. Your memo authorized the vice president and general manager to book 75 percent of that, or \$150,000, for corporate profit spending for stockholders. I was planning on using all \$200,000 together with the additional \$300,000 I personally requested from corporate headquarters to bail you out. Now I have to go back to the vice president and general manager and tell them that we've made a mistake and that we'll need an additional \$150,000.

*Anderson:* Perhaps I should go with you and explain my error. Obviously, I take all responsibility.

*Grey:* No, Gary. It's our error, not yours. I really don't think you want to be around the general manager when he sees red at the bottom of the page. It takes an act of God to get money back once corporate books it as profit. Perhaps you should reconsider project engineering as a career instead of program management. Your performance hasn't exactly been sparkling, you know.

Gary returned to his office quite disappointed. No matter how hard he worked, the bureaucratic red tape of project management seemed always to do him in. But late that afternoon, Gary's disposition improved. Lord Industries called to say that, after consultation with the Army, Parks Corporation would be awarded a sole-source contract for qualification and production of Spartan missile components using the new longer-life raw materials. Both Lord and the Army felt that the sole-source contract was justified, provided that continued testing showed the same results, since Parks Corporation had all of the technical experience with the new materials.

Gary received a letter of congratulations from corporate headquarters, but no additional pay increase. The grapevine said that a substantial bonus was given to the director of engineering.

During the tenth month, results were coming back from the accelerated aging tests performed on the new materials. The results indicated that although the new materials would meet specifications, the age life would probably be less than five years. These numbers came as a shock to Gary. Gary and Paul Evans had a conference to determine the best strategy to follow.

*Anderson:* Well, I guess we're now in the fire instead of the frying pan. Obviously, we can't tell Lord Industries about these tests. We ran them on our own. Could the results be wrong?

*Anderson:* I'm not going to tell anyone about this, especially Henry Gable. You and I will handle this. It will be my throat if word of this leaks out. Let's wait until we have the production contract in hand.

well with actual aging. We must form a company position on this as soon as possible.

*Evans:* That's dangerous. This has to be a company position, not a project office position. We had better let them know upstairs.

Anderson: I can't do that. I'll take all responsibility. Are you with me on this?

*Evans:* I'll go along. I'm sure I can find employment elsewhere when we open Pandora's box. You had better tell the department managers to be quiet also.

Two weeks later, as the program was winding down into the testing for the final verification mix and final report development, Gary received an urgent phone call asking him to report immediately to Henry Gable's office.

*Gable:* When this project is over, you're through. You'll never hack it as a program manager, or possibly a good project engineer. We can't run projects around here without honesty and open communications. How the hell do you expect top management to support you when you start censoring bad news to the top? I don't like surprises. I like to get the bad news from the program manager and project engineers, not secondhand from the customer. And of course, we cannot forget the cost overrun. Why didn't you take some precautionary measures?

*Anderson:* How could I when you were asking our people to do work such as accelerated aging tests that would be charged to my project and was not part of program plan? I don't think I'm totally to blame for what's happened.

*Gable:* Gary, I don't think it's necessary to argue the point any further. I'm willing to give you back your old job, in engineering. I hope you didn't lose too many friends while working in program management. Finish up final testing and the program report. Then I'll reassign you.

Gary returned to his office and put his feet up on the desk. "Well," thought Gary, "perhaps I'm better off in engineering. At least I can see my wife and kids once in a while." As Gary began writing the final report, the phone rang:

*Functional Manager:* Hello, Gary. I just thought I'd call to find out what charge number you want us to use for experimenting with this new procedure to determine accelerated age life.

Anderson: Don't call me! Call Gable. After all, the Blue Spider Project is his baby.

# Case 15 \_\_\_\_\_ Corwin Corporation\*


By June 1983, Corwin Corporation had grown into a \$150 million per year corporation with an international reputation for manufacturing low-cost, high-quality rubber components. Corwin maintained more than a dozen different product lines, all of which were sold as off-the-shelf items in department stores, hardware stores, and automotive parts distributors. The name "Corwin" was now synonymous with "quality." This provided management with the luxury of having products that maintained extremely long life cycles.

Organizationally, Corwin had maintained the same structure for more than 15 years (see Exhibit I). The top management of Corwin Corporation was highly conservative and believed in using a marketing approach to find new markets for existing product lines rather than exploring for new products. Under this philosophy, Corwin maintained a small R&D group whose mission was simply to evaluate state-of-the-art technology and its application to existing product lines.

Corwin's reputation was so good that they continually received inquiries about the manufacturing of specialty products. Unfortunately, the conservative nature of Corwin's management created a "do not rock the boat" atmosphere opposed to taking any type of risks. A management policy was established to evaluate all specialty-product requests. The policy required answering yes to the following questions:

- Will the specialty product provide the same profit margin (20 percent) as existing product lines?
- What is the total projected profitability to the company in terms of follow-on contracts?

- Can the specialty product be developed into a product line?
- Can the specialty product be produced with minimum disruption to existing product lines and manufacturing operations?

These stringent requirements forced Corwin to no-bid more than 90 percent of all specialty-product inquiries.

Corwin Corporation was a marketing-driven organization, although manufacturing often had different ideas. Almost all decisions were made by marketing with the exception of product pricing and estimating, which was a joint undertaking between manufacturing and marketing. Engineering was considered as merely a support group to marketing and manufacturing.

For specialty products, the project managers would always come out of marketing even during the R&D phase of development. The company's approach was that if the specialty product should mature into a full product line, then there should be a product line manager assigned right at the onset.

#### The Peters Company Project

In 1980, Corwin accepted a specialty-product assignment from Peters Company because of the potential for follow-on work. In 1981 and 1982, and again in 1983, profitable follow-on contracts were received, and a good working relationship developed, despite Peters' reputation for being a difficult customer to work with.

On December 7, 1982, Gene Frimel, the vice president of marketing at Corwin, received a rather unusual phone call from Dr. Frank Delia, the marketing vice president at Peters Company.

*Frank Delia:* Gene, I have a rather strange problem on my hands. Our R&D group has \$250,000 committed for research toward development of a new rubber product material, and we simply do not have the available personnel or talent to undertake the project. We have to go outside. We'd like your company to do the work. Our testing and R&D facilities are already overburdened.

*Gene Frimel:* Well, as you know, Frank, we are not a research group even though we've done this once before for you. And furthermore, I would never be able to sell our management on such an undertaking. Let some other company do the R&D work and then we'll take over on the production end.

*Delia:* Let me explain our position on this. We've been burned several times in the past. Projects like this generate several patents, and the R&D company almost always requires that our contracts give them royalties or first refusal for manufacturing rights.

*Frimel:* I understand your problem, but it's not within our capabilities. This project, if undertaken, could disrupt parts of our organization. We're already operating lean in engineering.

*Delia:* Look, Gene! The bottom line is this: We have complete confidence in your manufacturing ability to such a point that we're willing to commit to a five-year production contract if the product can be developed. That makes it extremely profitable for you.

Frimel: You've just gotten me interested. What additional details can you give me?

*Delia:* All I can give you is a rough set of performance specifications that we'd like to meet. Obviously, some trade-offs are possible.

Frimel: When can you get the specification sheet to me?

Delia: You'll have it tomorrow morning. I'll ship it overnight express.

*Frimel:* Good! I'll have my people look at it, but we won't be able to get you an answer until after the first of the year. As you know, our plant is closed down for the last two weeks in December, and most of our people have already left for extended vacations.

*Delia:* That's not acceptable! My management wants a signed, sealed, and delivered contract by the end of this month. If this is not done, corporate will reduce our budget for 1983 by \$250,000, thinking that we've bitten off more than we can chew. Actually, I need your answer within 48 hours so that I'll have some time to find another source.

*Frimel:* You know, Frank, today is December 7, Pearl Harbor Day. Why do I feel as though the sky is about to fall in?

*Delia:* Don't worry, Gene! I'm not going to drop any bombs on you. Just remember, all that we have available is \$250,000, and the contract must be a firm-fixed-price effort. We anticipate a six-month project with \$125,000 paid on contract signing and the balance at project termination.

*Frimel:* I still have that ominous feeling, but I'll talk to my people. You'll hear from us with a go or no-go decision within 48 hours. I'm scheduled to go on a cruise in the Caribbean, and my wife and I are leaving this evening. One of my people will get back to you on this matter.

Gene Frimel had a problem. All bid and no-bid decisions were made by a fourman committee composed of the president and the three vice presidents. The president and the vice president for manufacturing were on vacation. Frimel met with Dr. Royce, the vice president of engineering, and explained the situation.

*Royce:* You know, Gene, I totally support projects like this because it would help our technical people grow intellectually. Unfortunately, my vote never appears to carry any weight.

*Frimel:* The profitability potential as well as the development of good customer relations makes this attractive, but I'm not sure we want to accept such a risk. A failure could easily destroy our good working relationship with Peters Company.

*Royce:* I'd have to look at the specification sheets before assessing the risks, but I would like to give it a shot.

Frimel: I'll try to reach our president by phone.

By late afternoon, Frimel was fortunate enough to be able to contact the president and received a reluctant authorization to proceed. The problem now was how to prepare a proposal within the next two or three days and be prepared to make an oral presentation to Peters Company.

*Frimel:* The Boss gave his blessing, Royce, and the ball is in your hands. I'm leaving for vacation, and you'll have total responsibility for the proposal and presentation. Delia wants the presentation this weekend. You should have his specification sheets tomorrow morning.

*Royce:* Our R&D director, Dr. Reddy, left for vacation this morning. I wish he were here to help me price out the work and select the project manager. I assume that, in this case, the project manager will come out of engineering rather than marketing.

*Frimel:* Yes, I agree. Marketing should not have any role in this effort. It's your baby all the way. And as for the pricing effort, you know our bid will be for \$250,000. Just work backwards to justify the numbers. I'll assign one of our contracting people to assist you in the pricing. I hope I can find someone who has experience in this type of effort. I'll call Delia and tell him we'll bid it with an unsolicited proposal.

Royce selected Dan West, one of the R&D scientists, to act as the project leader. Royce had severe reservations about doing this without the R&D director, Dr. Reddy, being actively involved. With Reddy on vacation, Royce had to make an immediate decision.

On the following morning, the specification sheets arrived and Royce, West, and Dick Potts, a contracts man, began preparing the proposal. West prepared the direct labor man-hours, and Royce provided the costing data and pricing rates. Potts, being completely unfamiliar with this type of effort, simply acted as an observer and provided legal advice when necessary. Potts allowed Royce to make all decisions even though the contracts man was considered the official representative of the president.

Finally completed two days later, the proposal was actually a ten-page letter that simply contained the cost summaries (see Exhibit II) and the engineering intent. West estimated that 30 tests would be required. The test matrix described the test conditions only for the first five tests. The remaining 25 test conditions would be determined at a later date, jointly by Peters and Corwin personnel.

On Sunday morning, a meeting was held at Peters Company, and the proposal was accepted. Delia gave Royce a letter of intent authorizing Corwin Corporation to begin working on the project immediately. The final contract would not be available for signing until late January, and the letter of intent simply stated that Peters Company would assume all costs until such time that the contract was signed or the effort terminated.

West was truly excited about being selected as the project manager and being able to interface with the customer, a luxury that was usually given only to the marketing personnel. Although Corwin Corporation was closed for two weeks over Christmas, West still went into the office to prepare the project schedules and to identify the support he would need in the other areas, thinking that if he presented this information to management on the first day back to work, they would be convinced that he had everything under control.

#### **The Work Begins**

On the first working day in January 1983, a meeting was held with the three vice presidents and Dr. Reddy to discuss the support needed for the project. (West was not in attendance at this meeting, although all participants had a copy of his memo.)

*Reddy:* I think we're heading for trouble in accepting this project. I've worked with Peters Company previously on R&D efforts, and they're tough to get along with. West is a good man, but I would never have assigned him as the project leader. His expertise is in managing internal rather than external projects. But, no matter what happens, I'll support West the best I can.

*Royce:* You're too pessimistic. You have good people in your group and I'm sure you'll be able to give him the support he needs. I'll try to look in on the project every so often. West will still be reporting to you for this project. Try not to burden him too much with other work. This project is important to the company.

West spent the first few days after vacation soliciting the support that he needed from the other line groups. Many of the other groups were upset that they had not been informed earlier and were unsure as to what support they could provide. West met with Reddy to discuss the final schedules. *Reddy:* Your schedules look pretty good, Dan. I think you have a good grasp on the problem. You won't need very much help from me. I have a lot of work to do on other activities, so I'm just going to be in the background on this project. Just drop me a note every once in a while telling me what's going on. I don't need anything formal. Just a paragraph or two will suffice.

By the end of the third week, all of the raw materials had been purchased, and initial formulations and testing were ready to begin. In addition, the contract was ready for signature. The contract contained a clause specifying that Peters Company had the right to send an in-house representative into Corwin Corporation for the duration of the project. Peters Company informed Corwin that Patrick Ray would be the in-house representative, reporting to Delia, and would assume his responsibilities on or about February 15.

By the time Pat Ray appeared at Corwin Corporation, West had completed the first three tests. The results were not what was expected, but gave promise that Corwin was heading in the right direction. Pat Ray's interpretation of the tests was completely opposite to that of West. Ray thought that Corwin was "way off base," and that redirection was needed.

*Pat Ray:* Look, Dan! We have only six months to do this effort and we shouldn't waste our time on marginally acceptable data. These are the next five tests I'd like to see performed.

*Dan West:* Let me look over your request and review it with my people. That will take a couple of days, and, in the meanwhile, I'm going to run the other two tests as planned.

Ray's arrogant attitude bothered West. However, West decided that the project was too important to "knock heads" with Ray and simply decided to cater to Ray the best he could. This was not exactly the working relationship that West expected to have with the in-house representative.

West reviewed the test data and the new test matrix with engineering personnel, who felt that the test data was inconclusive as yet and preferred to withhold their opinion until the results of the fourth and fifth tests were made available. Although this displeased Ray, he agreed to wait a few more days if it meant getting Corwin Corporation on the right track.

The fourth and fifth tests appeared to be marginally acceptable just as the first three had been. Corwin's engineering people analyzed the data and made their recommendations.

*West:* Pat, my people feel that we're going in the right direction and that our path has greater promise than your test matrix.

*Ray:* As long as we're paying the bills, we're going to have a say in what tests are conducted. Your proposal stated that we would work together in developing the other test conditions. Let's go with my test matrix. I've already reported back to my boss that the first five tests were failures and that we're changing the direction of the project.

*West:* I've already purchased \$30,000 worth of raw materials. Your matrix uses other materials and will require additional expenditures of \$12,000.

*Ray:* That's your problem. Perhaps you shouldn't have purchased all of the raw materials until we agreed on the complete test matrix.

During the month of February, West conducted 15 tests, all under Ray's direction. The tests were scattered over such a wide range that no valid conclusions could be drawn. Ray continued sending reports back to Delia confirming that Corwin was not producing beneficial results and there was no indication that the situation would reverse itself. Delia ordered Ray to take any steps necessary to ensure a successful completion of the project.

Ray and West met again as they had done for each of the past 45 days to discuss the status and direction of the project.

*Ray:* Dan, my boss is putting tremendous pressure on me for results, and thus far I've given him nothing. I'm up for promotion in a couple of months and I can't let this project stand in my way. It's time to completely redirect the project.

*West:* Your redirection of the activities is playing havoc with my scheduling. I have people in other departments who just cannot commit to this continual rescheduling. They blame me for not communicating with them when, in fact, I'm embarrassed to.

*Ray:* Everybody has their problems. We'll get this problem solved. I spent this morning working with some of your lab people in designing the next 15 tests. Here are the test conditions.

*West:* I certainly would have liked to be involved with this. After all, I thought I was the project manager. Shouldn't I have been at the meeting?

*Ray:* Look, Dan! I really like you, but I'm not sure that you can handle this project. We need some good results immediately, or my neck will be stuck out for the next four months. I don't want that. Just have your lab personnel start on these tests, and we'll get along fine. Also, I'm planning on spending a great deal of time in your lab area. I want to observe the testing personally and talk to your lab personnel.

*West:* We've already conducted 20 tests, and you're scheduling another 15 tests. I priced out only 30 tests in the proposal. We're heading for a cost overrun condition.

*Ray:* Our contract is a firm-fixed-price effort. Therefore, the cost overrun is your problem.

West met with Dr. Reddy to discuss the new direction of the project and potential cost overruns. West brought along a memo projecting the costs through the end of the third month of the project (see Exhibit III).

*Reddy:* I'm already overburdened on other projects and won't be able to help you out. Royce picked you to be the project manager because he felt that you could do the job. Now, don't let him down. Send me a brief memo next month explaining the situation, and I'll see what I can do. Perhaps the situation will correct itself.

During the month of March, the third month of the project, West received almost daily phone calls from the people in the lab stating that Pat Ray was interfering with their job. In fact, one phone call stated that Ray had changed the test conditions from what was agreed on in the latest test matrix. When West confronted Ray on his med-

dling, Ray asserted that Corwin personnel were very unprofessional in their attitude and that he thought this was being carried down to the testing as well. Furthermore, Ray demanded that one of the functional employees be removed immediately from the project because of incompetence. West stated that he would talk to the employee's department manager. Ray, however, felt that this would be useless and said, "Remove him or else!" The functional employee was removed from the project.

By the end of the third month, most Corwin employees were becoming disenchanted with the project and were looking for other assignments. West attributed this to Ray's harassment of the employees. To aggravate the situation even further, Ray met with Royce and Reddy, and demanded that West be removed and a new project manager be assigned.

Royce refused to remove West as project manager, and ordered Reddy to take charge and help West get the project back on track.

*Reddy:* You've kept me in the dark concerning this project, West. If you want me to help you, as Royce requested, I'll need all the information tomorrow, especially the cost data. I'll expect you in my office tomorrow morning at 8:00 A.M. I'll bail you out of this mess.

West prepared the projected cost data for the remainder of the work and presented the results to Dr. Reddy (see Exhibit IV). Both West and Reddy agreed that the project was now out of control, and severe measures would be required to correct the situation, in addition to more than \$250,000 in corporate funding.

*Reddy:* Dan, I've called a meeting for 10:00 A.M. with several of our R&D people to completely construct a new test matrix. This is what we should have done right from the start.

*West:* Shouldn't we invite Ray to attend this meeting? I'm sure he'd want to be involved in designing the new test matrix.

*Reddy:* I'm running this show now, not Ray!! Tell Ray that I'm instituting new policies and procedures for in-house representatives. He's no longer authorized to visit the labs at his own discretion. He must be accompanied by either you or me. If he

doesn't like these rules, he can get out. I'm not going to allow that guy to disrupt our organization. We're spending our money now, not his.

West met with Ray and informed him of the new test matrix as well as the new policies and procedures for in-house representatives. Ray was furious over the new turn of events and stated that he was returning to Peters Company for a meeting with Delia.

On the following Monday, Frimel received a letter from Delia stating that Peters Company was officially canceling the contract. The reasons given by Delia were as follows:

- 1. Corwin had produced absolutely no data that looked promising.
- 2. Corwin continually changed the direction of the project and did not appear to have a systematic plan of attack.
- 3. Corwin did not provide a project manager capable of handling such a project.
- 4. Corwin did not provide sufficient support for the in-house representative.
- 5. Corwin's top management did not appear to be sincerely interested in the project and did not provide sufficient executive-level support.

Royce and Frimel met to decide on a course of action in order to sustain good working relations with Peters Company. Frimel wrote a strong letter refuting all of the accusations in the Peters letter, but to no avail. Even the fact that Corwin was willing to spend \$250,000 of their own funds had no bearing on Delia's decision. The damage was done. Frimel was now thoroughly convinced that a contract should not be accepted on "Pearl Harbor Day."

### Questions

- 1. What were the major mistakes made by Corwin?
- 2. Should Corwin have accepted the assignment?
- 3. Should companies risk bidding on projects based upon rough draft specifications?
- 4. Should the shortness of the proposal preparation time have required more active top management involvement before the proposal went out-of-house?
- 5. Are there any risks in not having the vice president for manufacturing available during the go or no-go bidding decision?

- 6. Explain the attitude of Dick Potts during the proposal activities.
- 7. None of the executives expressed concern when Dr. Reddy said, "I would never have assigned him (West) as project leader." How do you account for the executives' lack of concern?
- 8. How important is it to inform line managers of proposal activities even if the line managers are not required to provide proposal support?
- 9. Explain Dr. Reddy's attitude after go-ahead.
- 10. How should West have handled the situation where Pat Ray's opinion of the test data was contrary to that of Corwin's engineering personnel?
- 11. How should West have reacted to the remarks made by Ray that he informed Delia that the first five tests were failures?
- 12. Is immediate procurement of all materials a mistake?
- 13. Should Pat Ray have been given the freedom to visit laboratory personnel at any time?
- 14. Should an in-house representative have the right to remove a functional employee from the project?
- 15. Financially, how should the extra tests have been handled?
- 16. Explain Dr. Reddy's attitude when told to assume control of the project.
- 17. Delia's letter, stating the five reasons for canceling the project, was refuted by Frimel, but with no success. Could Frimel's early involvement as a project sponsor have prevented this?
- 18. In retrospect, would it have been better to assign a marketing person as project manager?
- 19. Your company has a singular methodology for project management. You are offered a special project from a powerful customer that does not fit into your methodology. Should a project be refused simply because it is not a good fit with your methodology?
- 20. Should a customer be informed that only projects that fit your methodology would be accepted?

# Case 16 MIS Project Management at First National Bank\*

During the last five years, First National Bank (FNB) has been one of the fastestgrowing banks in the Midwest. The holding company of the bank has been actively involved in purchasing small banks thoughout the state of Ohio. This expansion and the resulting increase of operations had been attended by considerable growth in numbers of employees and in the complexity of the organizational structure. In five years the staff of the bank has increased by 35 percent, and total assets have grown by 70 percent. FNB management is eagerly looking forward to a change in the Ohio banking laws that will allow statewide branch banking.

### Information Services Division (ISD) History

Data processing at FNB has grown at a much faster pace than the rest of the bank. The systems and programming staff grew from 12 in 1970 to over 75 during the first part of 1977. Because of several future projects, the staff is expected to increase by 50 percent during the next two years.

Prior to 1972, the Information Services Department reported to the executive vice president of the Consumer Banking and Operations Division. As a result, the first banking applications to be computerized were in the demand deposit, savings, and consumer credit banking areas. The computer was seen as a tool to speed up the processing of consumer transactions. Little effort was expended to meet the informational requirements of the rest of the bank. This caused a high-level conflict, since each major operating organization of the bank did not have equal access to systems




Exhibit I. Information Services Division organizational chart


and programming resources. The management of FNB became increasingly aware of the benefits that could accrue from a realignment of the bank's organization into one that would be better attuned to the total information requirements of the corporation.

In 1982 the Information Services Division (ISD) was created. ISD was removed from the Consumer Banking and Operations Division to become a separate division reporting directly to the president. An organizational chart depicting the Information Services Division is shown in Exhibit I.

### **Priorities Committee**

During 1982 the Priorities Committee was formed. It consists of the chief executive officer of each of the major operating organizations whose activities are directly affected by the need for new or revised information systems. The Priorities Committee was established to ensure that the resources of systems and programming personnel and computer hardware would be used only on those information systems that can best be cost justified. Divisions represented on the committee are included in Exhibit II.

The Priorities Committee meets monthly to reaffirm previously set priorities and rank new projects introduced since the last meeting. Bank policy states that the only way to obtain funds for an information development project is to submit a request to the Priorities Committee and have it approved and ranked in overall priority order for the bank. Placing potential projects in ranked sequence is done by the senior executives. The primary document used for Priorities Committee review is called the project proposal.





## The Project Proposal Life Cycle

When a user department determines a need for the development or enhancement of an information system, it is required to prepare a draft containing a statement of the problem from its functional perspective. The problem statement is sent[jy[bnto the president of ISD, who authorizes Systems Research (see Exhibit I) to prepare an impact statement. This impact statement will include a general overview from ISD's perspective of:

- Project feasibility
- Project complexity
- Conformity with long-range ISD plans
- Estimated ISD resource commitment
- Review of similar requests
- Unique characteristics/problems
- Broad estimate of total costs

The problem and impact statements are then presented to the members of the Priorities Committee for their review. The proposals are preliminary in nature, but they permit the broad concept (with a very approximate cost attached to it) to be reviewed by the executive group to see if there is serious interest in pursuing the idea. If the interest level of the committee is low, then the idea is rejected. However, if the Priorities Committee members feel the concept has merit, they authorize the Systems Research Group of ISD to prepare a full-scale project proposal that contains:

- A detailed statement of the problem
- Identification of alternative solutions
- Impact of request on:

- User division
- ISD
- Other operating divisions
- Estimated costs of solutions
- Schedule of approximate task duration
- Cost-benefit analysis of solutions
- Long-range implications
- Recommended course of action

After the project proposal is prepared by systems research, the user sponsor must review the proposal and appear at the next Priorities Committee meeting to speak in favor of the approval and priority level of the proposed work. The project proposal is evaluated by the committee and either dropped, tabled for further review, or assigned a priority relative to ongoing projects and available resources.

The final output of a Priorities Committee meeting is an updated list of project proposals in priority order with an accompanying milestone schedule that indicates the approximate time span required to implement each of the proposed projects.

The net result of this process is that the priority-setting for systems development is done by a cross section of executive management; it does not revert by default to data processing management. Priority-setting, if done by data processing, can lead to misunderstanding and dissatisfaction by sponsors of the projects that did not get ranked high enough to be funded in the near future. The project proposal cycle at FNB is diagrammed in Exhibit III. Once a project has risen to the top of the ranked priority list, it is assigned to the appropriate systems group for systems definition, system design and development, and system implementation.

The time spent by systems research in producing impact statements and project proposals is considered to be overhead by ISD. No systems research time is directly charged to the development of information systems.

#### Project Life Cycle

As noted before, the systems and programming staff of ISD has increased in size rapidly and is expected to expand by another 50 percent over the next two years. As a rule, most new employees have previous data processing experience and training in various systems methodologies. ISD management recently implemented a project management system dedicated to providing a uniform step-by-step methodology for the development of management information systems. All project work is covered by tasks that make up the information project development life cycle at FNB. The sub-phases used by ISD in the project life cycle are:

- 1. Systems definition
  - a. Project plan
  - b. User requirements
  - c. Systems definition
  - d. Advisability study
- 2. Systems design and development
  - a. Preliminary systems design
  - b. Subsystems design
  - c. Program design
  - d. Programming and testing

- 3. System implementation
  - a. System implementation
  - b. System test
  - c. Production control turnover
  - d. User training
  - e. System acceptance

#### **Project Estimating**

The project management system contains a list of all normal tasks and subtasks (over 400) to be performed during the life cycle of a development project. The project manager must examine all the tasks to determine if they apply to a given project. The manager must insert additional tasks if required and delete tasks that do not apply. The project manager next estimates the amount of time (in hours) to complete each task of each subphase of the project life cycle.


The estimating process of the project management system uses a "moving window" concept. ISD management feels that detailed cost estimating and time schedules are only meaningful for the next subphase of a project, where the visibility of the tasks to be performed is quite clear. Beyond that subphase, a more summary method of estimating is relied on. As the project progresses, new segments of the project gain visibility. Detailed estimates are made for the next major portion of the project, and summary estimates are done beyond that until the end of the project.

Estimates are performed at five intervals during the project life cycle. When the project is first initiated, the funding is based on the original estimates, which are derived from the list of normal tasks and subtasks. At this time, the subphases through the advisability study are estimated in detail, and summary estimates are prepared for the rest of the tasks in the project. Once the project has progressed through the advisability study, the preliminary systems design is estimated in detail, and the balance of the project is estimated in a more summary fashion. Estimates are conducted in this manner until the systems implementation plan is completed and the scope of the remaining subphases of the project is known. This multiple estimating process is used because it is almost impossible at the beginning of many projects to be certain of what the magnitude of effort will be later on in the project life cycle.

#### **Funding of Projects**

The project plan is the official document for securing funding from the sponsor in the user organization. The project plan must be completed and approved by the project manager before activity can begin on the user requirements subphase (1b). An initial stage in developing a project plan includes the drawing of a network that identifies each of the tasks to be done in the appropriate sequence for their execution. The project plan must include a milestone schedule, a cost estimate, and a budget request. It is submitted to the appropriate general manager of systems and programming for review so that an understanding can be reached of how the estimates were prepared and why the costs and schedules are as shown. At this time the general manager can get an idea of the quantity of systems and programming resources required by the project. The general manager next sets up a meeting with the project manager and





the user sponsor to review the project plan and obtain funding from the user organization.

The initial project funding is based on an estimate that includes a number of assumptions concerning the scope of the project. Once certain key milestones in the project have been achieved, the visibility on the balance of the project becomes much clearer, and reestimates are performed. The reestimates may result in refunding if there has been a significant change in the project. The normal milestone refunding points are as follows:

- 1. After the advisability study (1d)
- 2. After the preliminary systems design (2a)
- 3. After the program design (2c)
- 4. After system implementation (3a)

The refunding process is similar to the initial funding with the exception that progress information is presented on the status of the work and reasons are given to explain deviations from project expenditure projections. A revised project plan is prepared for each milestone refunding meeting.

During the systems design and development stage, design freezes are issued by the project manager to users announcing that no additional changes will be accepted to the project beyond that point. The presence of these design freezes is outlined at the beginning of the project. Following the design freeze, no additional changes will be accepted unless the project is reestimated at a new level and approved by the user sponsor.

#### System Quality Reviews

The key element in ensuring user involvement in the new system is the conducting of quality reviews. In the normal system cycles at FNB, there are ten quality reviews, seven of which are participated in jointly by users and data processing personnel, and three of which are technical reviews by data processing (DP) personnel only. An important side benefit of this review process is that users of a new system are forced to become involved in and are permitted to make a contribution to the systems design.

Each of the quality review points coincides with the end of a subphase in the project life cycle. The review must be held at the completion of one subphase to obtain authorization to begin work on the tasks of the next subphase of the project.

All tasks and subtasks assigned to members of the project team should end in some "deliverable" for the project documentation. The first step in conducting a quality review is to assemble the documentation produced during the subphase for distribution to the Quality Review Board. The Quality Review Board consists of between two and eight people who are appointed by the project manager with the approval of the project sponsor and the general manager of systems and programming. The minutes of the quality review meeting are written either to express "concurrence" with the subsystem quality or to recommend changes to the system that must be completed before the next subphase can be started. By this process the system is fine-tuned to the requirements of the members of the review group at the end of each subphase in the system. The members of the Quality Review Board charge their time to the project budget.

Quality review points and review board makeup are as follows:

To summarize, the quality review evaluates the quality of project subphase results, including design adequacy and proof of accomplishment in meeting project objectives. The review board authorizes work to progress based on their detailed knowledge that all required tasks and subtasks of each subphase have been successfully completed and documented.

#### Project Team Staffing

Once a project has risen to the top of the priority list, the appropriate manager of systems development appoints a project manager from his or her staff of analysts. The project manager has a short time to review the project proposal created by systems research before developing a project plan. The project plan must be approved by the general manager of systems and programming and the user sponsor before the project can be funded and work started on the user requirements subphase.

The project manager is "free" to spend as much time as required in reviewing the project proposal and creating the project plan; however, this time is "charged" to the project at a rate of \$26 per hour. The project manager must negotiate with a "supervisor," the manager of systems development, to obtain the required systems analysts for the project, starting with the user requirements subphase. The project manager must obtain programming resources from the manager of systems support. Schedule delays caused by a lack of systems or programming resources are to be communicated to the general manager by the project manager. All ISD personnel working on a project charge their time at a rate of \$26 per hour. All computer time is billed at a rate of \$64 per hour.

There are no user personnel on the project team; all team members are from ISD.

#### Corporate Database

John Hart had for several years seen the need to use the computer to support the corporate marketing effort of the bank. Despite the fact that the majority of the bank's profits were from corporate customers, most information systems effort was directed at speeding up transactions handling for small unprofitable accounts.

Mr. Hart had extensive experience in the Corporate Banking Division of the bank. He realized the need to consolidate information about corporate customers from many areas of the bank into one corporate database. From this information corporate banking services could be developed not only to better serve the corporate customers, but also to contribute heavily to the profit structure of the bank through repricing of services.

The absence of a corporate database meant that no one individual knew what total banking services a corporate customer was using, because corporate services were provided by many banking departments. It was also impossible to determine how profitable a corporate customer was to the bank. Contact officers did not have regularly scheduled calls. They serviced corporate customers almost on a hit-or-miss basis. Unfortunately, many customers were "sold" on a service because they walked in the door and requested it. Mr. Hart felt that there was a vast market of untapped corporate customers in Ohio who would purchase services from the bank if they were contacted and "sold" in a professional manner. A corporate database could be used to develop corporate profiles to help contact officers sell likely services to corporations.

Mr. Hart knew that data about corporate customers was being processed in many departments of the bank, but mainly in the following divisions:

- Corporate Banking
- Corporate Trust
- Consumer banking

He also realized that much of the information was processed in manual systems, some was processed by time-sharing at various vendors, and other information was computerized in many internal information systems.

The upper management of FNB must have agreed with Mr. Hart because in December of 1986 the Corporate Marketing Division was formed with John Hart as its executive vice president. Mr. Hart was due to retire within the year but was honored to be selected for the new position. He agreed to stay with the bank until "his" new system was "off the ground." He immediately composed a problem statement and sent it to the ISD. Systems Research compiled a preliminary impact statement. At the next Priorities Committee meeting, a project proposal was authorized to be done by Systems Research.

The project proposal was completed by Systems Research in record time. Most information was obtained from Mr. Hart. He had been thinking about the systems requirements for years and possessed vast experience in almost all areas of the bank. Other user divisions and departments were often "too busy" when approached for information. A common reply to a request for information was, "That project is John's baby; he knows what we need."

The project proposal as prepared by Systems Research recommended the following:

- Interfaces should be designed to extract information from existing computerized systems for the corporate database (CDB).
- Time-sharing systems should be brought in-house to be interfaced with the CDB.
- Information should be collected from manual systems to be integrated into the CDB on a temporary basis.
- Manual systems should be consolidated and computerized, potentially causing a reorganization of some departments.
- Information analysis and flow for all departments and divisions having contact with corporate customers should be coordinated by the Corporate Marketing Division.
- All corporate database analysis should be done by the Corporate Marketing Division staff, using either a user-controlled report writer or interactive inquiry.

The project proposal was presented at the next Priorities Committee meeting

where it was approved and rated as the highest priority MIS development project in the bank. Mr. Hart became the user sponsor for the CDB project.

The project proposal was sent to the manager of corporate development, who appointed Jim Gunn as project manager from the staff of analysts in corporate development. Jim Gunn was the most experienced project manager available. His prior experience consisted of successful projects in the Financial Division of the bank.

Jim reviewed the project proposal and started to work on his project plan. He was aware that the corporate analyst group was presently understaffed but was assured by his manager, the manager of corporate development, that resources would be available for the user requirements subphase. He had many questions concerning the scope of the project and the interrelationship between the Corporate Marketing Division and the other users of corporate marketing data. But each meeting with Mr. Hart ended with the same comment: "This is a waste of time. I've already been over this with Systems Research. Let's get moving." Jim also was receiving pressure from the general manager to "hurry up" with the project plan. Jim therefore quickly prepared his project plan, which included a general milestone schedule for subphase completion, a general cost estimate, and a request for funding. The project plan was reviewed by the general manager and signed by Mr. Hart.

Jim Gunn anticipated the need to have four analysts assigned to the project and went to his manager to see who was available. He was told that two junior analysts were available now and another analyst should be free next week. No senior analysts were available. Jim notified the general manager that the CDB schedule would probably be delayed because of a lack of resources, but received no response.

Jim assigned tasks to the members of the team and explained the assignments and the schedule. Since the project was understaffed, Jim assigned a heavy load of tasks to himself.

During the next two weeks the majority of the meetings set up to document user requirements were canceled by the user departments. Jim notified Mr. Hart of the problem and was assured that steps would be taken to correct the problem. Future meetings with the users in the Consumer Banking and Corporate Banking Divisions became very hostile. Jim soon discovered that many individuals in these divisions did not see the need for the corporate database. They resented spending their time in meetings documenting the CDB requirements. They were afraid that the CDB project would lead to a shift of many of their responsibilities and functions to the Corporate Marketing Division.

Mr. Hart was also unhappy. The CDB team was spending more time than was budgeted in documenting user requirements. If this trend continued, a revised budget would have to be submitted to the Priorities Committee for approval. He was also growing tired of ordering individuals in the user departments to keep appointments with the CDB team. Mr. Hart could not understand the resistance to his project.

Jim Gunn kept trying to obtain analysts for his project but was told by his manager that none were available. Jim explained that the quality of work done by the junior analysts was not "up to par" because of lack of experience. Jim complained that he could not adequately supervise the work quality because he was forced to complete many of the analysis tasks himself. He also noted that the quality review of the user requirements subphase was scheduled for next month, making it extremely critical that experienced analysts be assigned to the project. No new personnel were assigned to the project. Jim thought about contacting the general manager again to explain his need for more experienced analysts, but did not. He was due for a semiyearly evaluation from his manager in two weeks. Even though he knew the quality of the work was below standards, Jim was determined to get the project done on schedule with the resources available to him. He drove both himself and the team very hard during the next few weeks. The quality review of the user requirement subphase was held on schedule. Over 90 percent of the assigned tasks had to be redone before the Quality Review Board would sign-off on the review. Jim Gunn was removed as project manager.

Three senior analysts and a new project manager were assigned to the CDB project. The project received additional funding from the Priorities Committee. The user requirements subphase was completely redone despite vigorous protests from the Consumer Banking and Corporate Banking divisions.

Within the next three months the following events happened:

- The new project manager resigned to accept a position with another firm.
- John Hart took early retirement.
- The CDB project was tabled.

#### Synopsis

All projects at First National Bank (FNB) have project managers assigned and are handled through the Information Services Division (ISD). The organizational structure is not a matrix, although some people think that it is. The case describes one particular project, the development of a corporate database, and the resulting failure. The problem at hand is to investigate why the project failed.

#### Questions

- 1. What are the strengths of FNB?
- 2. What are the major weaknesses?
- 3. What is the major problem mentioned above? Defend your answer.
- 4. How many people did the project manager have to report to?
- 5. Did the PM remain within vertical structure of the organization?
- 6. Is there anything wrong if a PM is a previous co-worker of some team members before the team is formed?
- 7. Who made up the project team?
- 8. Was there any resistance to the project by company management?
- 9. Was there an unnecessary duplication of work?
- 10. Was there an increased resistance to change?
- 11. Was the communication process slow or fast?
- 12. Was there an increased amount of paperwork?
- 13. What are reasonable recommendations?
- 14. Does the company have any type of project management methodology?
- 15. Could the existence of a methodology have alleviated any of the above problems?
- 16. Did the bank perform strategic planning for project management or did it simply rush into the project?
- 17. Why do organizations rush into project management without first performing strategic planning for project management or, at least, some form of benchmarking against other organizations?
